The View from the Chesapeake, 1770-1776

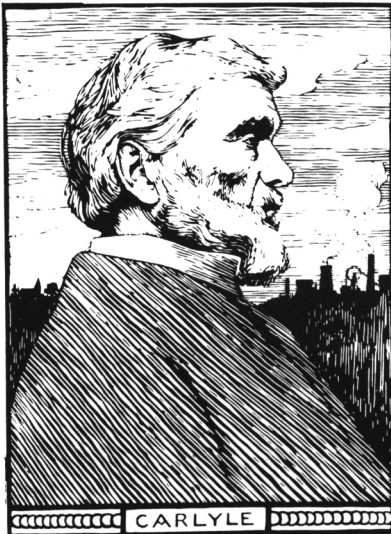

The Making of Elizabethan Foreign Policy, 1558-1603

R. B. Wernham

An elegant synthesis by the foremost authority on the subject. Wernham lucidly describes how Queen Elizabeth's responses to the questions and problems posed by her relations with neighboring and far more powerful countries grew into a coherent foreign policy. Beginning with an assessment of the influence councillors and other advisors had on the policy, Wernham then examines the quarrels with Spain of 1568-1572 and 1585 onward. He looks at the frustrations caused by the weakness of Elizabeth's French and Dutch allies, the vagaries of her own commanders, and the problem of poor communications. He discusses how the burdens imposed by the Spanish war provoked a more critical attitude in Parliament. Finally, he shows how the Spanish war and privateering accelerated the redeployment of English trade and maritime activity away from Europe.
