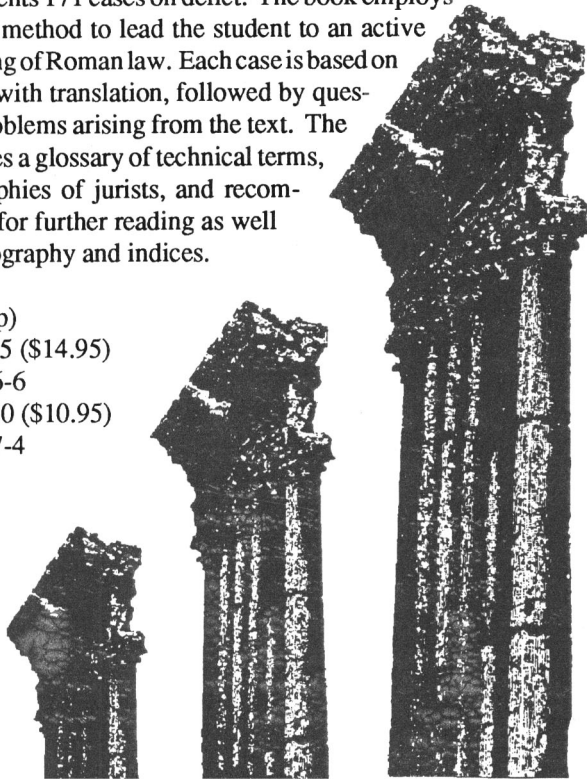


A Casebook on The Roman Law of Delict

This casebook is the first of its type in English on Roman law and presents 171 cases on delict. The book employs the Socratic method to lead the student to an active understanding of Roman law. Each case is based on a Latin text with translation, followed by questions and problems arising from the text. The book includes a glossary of technical terms, brief biographies of jurists, and recommendations for further reading as well as full bibliography and indices.

In 1983, Larry Flynt's *Hustler* magazine published a parody of a Campari advertisement that depicted the Reverend Jerry Falwell as a drunkard engaging in sex with his mother in an outhouse. "On one side," wrote Andrew Klavan in *Village Voice*, "the sanctimonious embodiment of everything that is most awful about religion. On the other, a mad pornographer whose indigestible sleazitude would strain the tolerance of the ACLU. This had to make a terrific book."

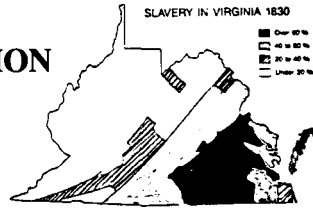

The editors welcome unsolicited manuscripts, books for review, and suggestions concerning *Law and History Review*. Manuscripts should be submitted to Bruce H. Mann, University of Pennsylvania Law School, 3400 Chestnut Street, Philadelphia, Pennsylvania 19104. The text should be typed, double-spaced, on 8½" x 11" paper with ample margins on all sides. Type on one side of the paper only. Footnotes should be typed double-spaced and separate from the text, and should conform to either the style found in the *Chicago Manual of Style* (13th ed.) or to *A Uniform System of Citation* (14th ed.); the *Chicago Manual* is preferred. Authors of accepted manuscripts should contact the editorial office regarding computer compatibility. Because of the commitment we ask of our outside referees, *Law and History Review* cannot consider for publication manuscripts that have been submitted to other journals. A submission to the *Review* carries with it the implicit promise that the author will not submit the manuscript elsewhere while it is under consideration by *Law and History Review*.
