A LOPEZ-ESCOBAR THEOREM FOR CONTINUOUS DOMAINS

Abstract. We prove an effective version of the Lopez-Escobar theorem for continuous domains. Let $Mod(\tau)$ be the set of countable structures with universe ω in vocabulary τ topologized by the Scott topology. We show that an invariant set $K \subseteq Mod(\tau)$ is Π^0_α in the Borel hierarchy of this topology if and only if it is definable by a Π^n_α -formula, a positive Π^0_α formula in the infinitary logic $L_{\omega_1\omega}$. As a corollary of this result we obtain a new pullback theorem for positive computable embeddings: Let K be positively computably embeddable in K' by Φ , then for every Π^n_α formula ξ in the vocabulary of K' there is a Π^n_α formula ξ^* in the vocabulary of K such that for all $A \in K$, $A \models \xi^*$ if and only if $\Phi(A) \models \xi$. We use this to obtain new results on the possibility of positive computable embeddings into the class of linear orderings.

§1. Introduction. A common theme in the study of countable mathematical structures is that isomorphism invariant properties have syntactic characterizations. Examples of this phenomenon are the existence of Scott sentences for countable structures [30], the Lopez-Escobar theorem, which says that every invariant Borel subset in the space of countable structures is definable in the infinitary logic $L_{\omega_1\omega}$ [24], or that a relation on a structure that is Σ^0_{α} in every copy is definable by a computable Σ^0_{α} $L_{\omega_1\omega}$ -formula [2, 10].

Definability in the logic $L_{\omega_1\omega}$ is closely related to Turing reducibility. The base case of [2, 10] tells us that a relation is definable by a computable Σ_1^0 formula and a computable Π_1^0 formula if and only if it is computable in every copy. Similarly, evaluating whether a computable infinitary Σ_{α}^0 formula holds of a structure \mathcal{A} is c.e. in the α th Turing jump of \mathcal{A} , and hence deciding membership of computable structures in Σ_{α}^0 sets is Σ_{α}^0 . Another fact that makes this connection is that the space of countable τ -structures with universe ω , $Mod(\tau)$, can be viewed as a closed subspace of Cantor space \mathcal{C} . It is well known that continuous functions $\mathcal{C} \to \mathcal{C}$ are X-computable operators relative to some $X \in 2^{\omega}$, and thus Turing computable operators correspond to the effectively continuous functions.

Being a powerful tool to study algorithmic properties, Turing reducibility is not well suited to deal with partial objects, such as c.e. sets, partial functions, and partial structures. Enumeration reducibility was introduced by Friedberg and Rogers [15] as a generalization of relative computability intended to deal with partial objects. Namely, $X \subseteq \omega$ is enumeration reducible to $Y \subseteq \omega$, $X \leq_e Y$, if every enumeration of Y computes an enumeration of X. Given the explained above relationship between definability and Turing computability, one wonders whether a similar relationship

can be established between definability and enumeration reducibility. To establish such a correspondence, throughout the paper we will treat structures as partial objects given by their positive diagrams. For a structure \mathcal{A} in a relational vocabulary τ its positive diagram is the set $\bigoplus_{R_i \in \tau} R_i^{\mathcal{A}}$.

Algorithmic properties of structures given by their positive diagrams have been studied for a long time, as this kind of presentation has deep connections to results in algebra and theoretical computer science. The formal general definition of positive (or c.e.) structures was given by Mal'cev [25]. From an algebraic point of view, many finitely presented algebras are naturally positive but lack a computable presentation [5, 26, 28]. An extensive overview of results on positive (c.e.) structures from the twentieth century can be found in [31]. Later c.e. structures were studied by Harizanov and co-authors [8, 9, 14]. In a recent survey [21] Khoussainov summarizes more results on c.e. structures and suggests new questions, relating the study of c.e. structures to the theory of equivalence relations. Further recent results about c.e. structures could be found, e.g., in [17, 18].

The approach that applies enumeration reducibility to study computational properties of structures goes back to Soskov [34, 35] who adapted notions studied in computable structure theory to enumeration reducibility. Assuming that a structure is given by its positive diagram, one may ask questions similar to the ones in classic computable structure theory but with respect to enumeration reducibility. For example, Richter introduced the notion of the Turing degree spectrum of a structure, the set of Turing degrees of its isomorphic copies [29]. The first and one of the fundamental results in this area of Knight is a dichotomy [22]. If a structure is automorphically non-trivial, its degree spectrum is upwards closed. Otherwise, it is a singleton. This dichotomy disappears in the analogue of this notion for enumeration reducibility—enumeration degree spectra. The enumeration degree spectrum of a structure is the set of degrees of enumerations of its positive diagram [34]. Soskov's work on this notion exposed deep theory and contributed to the study of Turing degree spectra (see [36] for a survey). In [12] r.i.p.e. relations, relations that are enumerable from the positive diagrams of all isomorphic copies of a given structure, were studied. The main results show that a relation is r.i.p.e. if and only if it is definable by a positive computable Σ_1^0 infinitary formula, and that positive enumerable functors—a reducibility between structures introduced in [13]—have a syntactic equivalent in a version of interpretability using Σ_1^p formulas.

In this article, we establish another relationship between definability by positive infinitary formulas and enumeration reducibility. Our main result is an effective version of the Lopez-Escobar theorem that establishes a connection between the Borel hierarchy on the Scott topology on the space of countable structures and a hierarchy of positive $L_{\omega_1\omega}$ -formulas. Let $(Mod(\tau), \preceq)$ be the set of countable structures in the relational language τ with universe ω , where \preceq is the substructure ordering on $Mod(\tau)$. This ordering gives rise to a topology, the Scott topology with basic open sets the superstructures of τ -finite structures. It is not a Polish space but an ω -continuous domain and allows the definition of a Borel hierarchy. Selivanov [33] showed that the Borel sets in this topology equal the Borel sets under the usual Polish topology on $Mod(\tau)$ and, thus, one gets Lopez-Escobar's theorem for the Scott topology for free. However, the Borel hierarchies on this spaces differ and we will prove a stronger version of this theorem, matching the Borel complexity

with the complexity of defining formulas. We show that a set is Π_{α}^{0} in the effective Borel hierarchy on the Scott topology if and only if it is definable by a computable Π_{α}^{p} formula (Theorem 3.12). The p in Π_{α}^{p} stands for positive; the Π_{α}^{p} formulas are a subset of the classical Π_{α}^{0} formulas in the logic $L_{\omega_{1}\omega}$ with the use of negations restricted. Vanden Boom [4] showed the analogue of our theorem in the classical setting. The bold-face version is a corollary of Vaught's proof of the Lopez-Escobar theorem [37]. We will prove our version of the Lopez-Escobar theorem using a notion of forcing which can be seen as an amalgamation of the forcing used in Vanden Boom's proof and a forcing used by Soskov [34].

As Turing computable operators are to Polish spaces, enumeration operators are to the Scott topology. Enumeration operators can be viewed as functions mapping subsets of ω to subsets of ω and thus as functions from 2^{ω} to 2^{ω} . While we have only defined the Scott topology on $Mod(\tau)$, there is a similar topology on 2^{ω} where the basic open sets are the supersets of finite sets. Enumeration operators correspond to effective Scott continuous functions from 2^{ω} to 2^{ω} . As in the classical case, we can view the Scott topology on $Mod(\tau)$ as a subspace of the Scott topology on 2^{ω} . We use this fact to obtain a new pullback theorem for computable embeddings. A computable embedding between two classes \mathcal{K} and \mathcal{K}' is an enumeration operator Φ such that for $\mathcal{A} \in \mathcal{K}$, $\Phi(\mathcal{A}) \in \mathcal{K}'$, and $\mathcal{A} \cong \mathcal{B}$ if and only if $\Phi(\mathcal{A}) \cong \Phi(\mathcal{B})$ [7]. Our pullback theorem says that for ξ a Π^p_α formula in the vocabulary of \mathcal{K}' , there is ξ^* , a Π^p_α formula in the vocabulary of \mathcal{K} such that for all $\mathcal{A} \in \mathcal{K}$, $\mathcal{A} \models \xi^*$ if and only if $\Phi(\mathcal{A}) \models \xi$ (Theorem 4.5).

Computable embeddings and their classical analogue, Turing computable embeddings [23], have been heavily studied in computable structure theory over the last decade. One question that has seen interest is to find a dividing line between these two types of reducibilities [3, 7, 11, 19, 20]: What properties must classes of structures \mathcal{K} and \mathcal{K}' have so that there is a Turing computable embedding from \mathcal{K} to \mathcal{K}' but no computable embedding? Our pullback theorem is a useful tool for investigations of this kind. To demonstrate this we study classes \mathcal{K} and their sister classes $\tilde{\mathcal{K}}$ where $\tilde{\mathcal{A}}$ is obtained from \mathcal{A} by introducing an infinite equivalence relation E on ω where all equivalence classes are infinite such that $\tilde{\mathcal{A}}/E \cong \mathcal{A}$. We continue work of Ganchev, Kalimullin, and Vatev [16] and study when we can have a computable embedding from $\tilde{\mathcal{K}}$ into \mathcal{K} . We show that for \mathcal{L} the class of linear orderings, any two structures in $\tilde{\mathcal{L}}$ satisfy the same Σ_2^p sentences. Thus, if $\mathcal{K} \subseteq \mathcal{L}$, and the orderings in \mathcal{K} are distinguishable by Σ_2^p sentences, we cannot have a computable embedding $\tilde{\mathcal{K}} \to \mathcal{K}$. Using this we show that there is no embedding from $\{\tilde{\omega}, \tilde{\omega}^*\}$ to $\{\omega, \omega^*\}$, answering a question of Kalimullin (Theorem 5.6).

§2. Preliminaries.

2.1. Scott topology. Let (P, \leq) be a partial order. A set $D \subseteq P$ is directed if $D \neq \emptyset$ and for all $a, b \in D$, there is $d \in D$ with $a \leq d$ and $b \leq d$. A partial order P is a directed complete partial order (dcpo) if every directed $D \subseteq P$ has a supremum sup D in P. A set U is Scott open if U is an upper set, i.e., $x \in U$ and $x \leq y \implies y \in U$, and for every directed set D with sup $D \in U$ we have that $D \cap U \neq \emptyset$. The Scott open sets of P form a topology on P, the Scott topology.

Notice that the Scott topology on any partial ordered set that contains a chain of size larger than 2 is not Hausdorff. To see this just note that for all $x, y \in P$ if $x \le y$ then every Scott open set containing x contains y. So, in particular, it is not Polish.

As an example of such a space consider the Scott topology on 2^{ω} equipped with the dcpo given by $f \subseteq g$ if $f(i) = 1 \implies g(i) = 1$. It has a natural countable basis given by the basic open sets

$$2^{\omega}$$
, \emptyset , and $O_n = \{ f \in 2^{\omega} \mid f(n) = 1 \}$ for all $n \in \omega$.

The Scott topology on 2^{ω} is what is commonly referred to as an ω -continuous domain. In fact it is an ω -algebraic domain and thus a quasi-Polish space [6]. The spaces we consider in this paper will be closed subspaces of the Scott topology on 2^{ω} .

Let τ be a countable relational vocabulary containing = and \neq . Denote by $Mod(\tau)$ the set of countable τ -structures with universe ω . Similarly, if ξ is a τ -formula, denote by $Mod(\xi)$ the set of models of ξ . There is a natural dcpo on $Mod(\tau)$ given by

$$\mathcal{A} \prec \mathcal{B} : \iff \forall R \in \tau(R^{\mathcal{A}} \subseteq R^{\mathcal{B}}).$$

For the sake of readability we will refer to the Scott topology on $(Mod(\tau), \preceq)$ simply as the Scott topology on $Mod(\tau)$. It might seem odd to the reader that we include both = and \neq in the vocabulary. The reason for this is that we want to identify the Scott open subsets of $Mod(\tau)$ with subsets that are definable by existential formulas without negation. If \neq is not in the vocabulary, then this is generally not possible for the emptyset. With \neq in the vocabulary we can always define the emptyset by the formula $\exists x \ x \neq x$ regardless of other properties of τ .

In order to use tools from computability theory, it is convenient to represent $A \in Mod(\tau)$ by their atomic diagram—the infinite binary string

$$D_{\mathcal{A}}(n) = \begin{cases} 1, & \text{if } \mathcal{A} \models \xi_n^{at}[x_i \to i], \\ 0, & \text{otherwise,} \end{cases}$$

where ξ_n^{at} is the n^{th} formula in an effective enumeration of all atomic τ -formulas with free variables a subset of $\{x_0, \dots, x_n\}$. Notice that this representation gives a homeomorphism between $(Mod(\tau), \preceq)$ and the closed subset of $(2^{\omega}, \subseteq)$ given by

$$\bigcap_{n \in \{\lceil x_i = x_j \rceil : i \neq j \in \omega\}} 2^{\omega} \setminus O_n \cap \bigcap_{n \in \{\lceil x_i \neq x_i \rceil : i \in \omega\}} 2^{\omega} \setminus O_n.$$

Notice that the Scott topology on $Mod(\tau)$ is homeomorphic to the subspace topology on this space. By the same idea we can view natural classes of structures such as linear orderings as closed subspaces of 2^{ω} .

2.2. The Borel hierarchy for non-metrizable spaces. The Borel sets of a Polish space bear a natural structure in terms of the Borel hierarchy. This is witnessed by the fact that the Σ_2^0 sets are precisely the F_{σ} subsets and the Π_2^0 sets coincide with the G_{δ} subsets of the space. In non-Hausdorff spaces we cannot find this correspondence

¹When talking about computable structures, there is often no algorithmic difference between atomic and quantifier-free formulas. This often leads to identifying atomic and quantifier-free diagrams, the two terms being then used interchangeably. Here we really do mean atomic formulas, in particular, no negations are allowed.

in general. It is common for non-Hausdorff spaces to have open sets that are not F_{σ} (i.e., countable unions of closed sets) and closed sets that are not G_{δ} (i.e., countable intersections of open sets). One example of this phenomenon is the Sierpiński space, which has $\{\bot, \top\}$ as underlying set and the singleton $\{\top\}$ open but not closed. This implies that the classical definition of the Borel hierarchy, which defines level Σ_2^0 as the F_{σ} -sets and Π_{2}^{0} as the G_{δ} -sets, is not appropriate in the general setting.

DEFINITION 2.1 [33]. Let (X, τ) be a topological space. For each countable ordinal $\alpha \geq 1$ we define $\Sigma_{\alpha}^{0}(X,\tau)$ inductively as follows.

- (1) $\Sigma_1^0(X, \tau) = \tau$.
- (2) For $\alpha > 1$, $\Sigma_{\alpha}^{0}(X, \tau)$ is the set of all subsets A of X which can be expressed in the form

$$A=\bigcup_{i\in\omega}B_i\setminus B_i',$$

where for each *i*, B_i and B'_i are in $\Sigma^0_{\beta_i}(X, \tau)$ for some $\beta_i < \alpha$.

We define $\Pi^0_{\alpha}(X,\tau) = \{X \setminus A \mid A \in \Sigma^0_{\alpha}(X,\tau)\}$ and $\Delta^0_{\alpha}(X,\tau) = \Sigma^0_{\alpha}(X,\tau) \cap \Pi^0_{\alpha}(X,\tau)$. Finally, we define $\mathbf{B}(X,\tau) = \bigcup_{\alpha < \omega_1} \Sigma^0_{\alpha}(X,\tau)$ to be the *Borel* subsets of (X,τ) .

The definition above is equivalent to the classical definition of the Borel hierarchy on metrizable spaces, but differs in general. Selivanov has investigated this hierarchy in a series of papers [32, 33], with an emphasis on applications to ω -continuous domains. He shows (Proposition 5.3 in [32]) that the classical Borel hierarchy on Cantor space differs from the new Borel hierarchy on the Scott space at finite levels and coincides at infinite levels.

2.3. A hierarchy of positive infinitary formulas. In the classical setting the Lopez-Escobar theorem establishes a correspondence between subsets of $Mod(\tau)$ defined by sentences in the infinitary logic $L_{\omega_1\omega}$ and the Borel sets. Our theorem relates the Borel sets in the Scott topology with subsets defined by positive infinitary sentences defined below. See [1] for an in-depth treatment of infinitary logic that goes in hand with the developments in this section.

Definition 2.2. Fix a countable vocabulary τ . For every $\alpha < \omega_1$ define the sets of Σ_{α}^{p} and Π_{α}^{p} τ -formulas inductively as follows.

- Let $\alpha = 0$. Then:

 - the Σ_0^p formulas are the finite conjunctions of atomic τ -formulas. the Π_0^p formulas are the finite disjunctions of *negations* of atomic τ formulas.
- Let $\alpha = 1$. Then:
 - $-\varphi(\bar{u})$ is a Σ_1^p formula if it has the form

$$\varphi(\bar{u}) = \mathbb{W}_{i \in I} \exists \bar{x}_i \psi_i(\bar{u}, \bar{x}_i),$$

where for each $i \in I$, $\psi_i(\bar{u}, \bar{x}_i)$ is a Σ_0^p formula, I is countable.

 $- \varphi(\bar{u})$ is a Π^p_1 formula if it has the form

$$\varphi(\bar{u}) = \mathbb{M}_{i \in I} \forall \overline{x}_i \psi_i(\bar{u}, \bar{x}_i),$$

where for each $i \in I$, $\psi_i(\bar{u}, \bar{x}_i)$ is a Π_0^p formula, I is countable.

- Let $\alpha > 2$. Then:
 - $-\varphi(\bar{u})$ is Σ_{α}^{p} formula if it has the form

$$\varphi(\bar{u}) = \mathbb{W}_{i \in I} \exists \bar{x}_i (\xi_i(\bar{u}, \bar{x}_i) \land \psi_i(\bar{u}, \bar{x}_i)),$$

where for each $i \in I$, $\xi_i(\bar{u}, \bar{x}_i)$ is a $\Sigma_{\beta_i}^p$ formula and $\psi_i(\bar{u}, \bar{x}_i)$ is a $\Pi_{\beta_i}^p$ formula, for some $\beta_i < \alpha$ and I countable.

 $-\varphi(\bar{u})$ is Π^p_α formula if it has the form

$$\varphi(\bar{u}) = \mathbb{M}_{i \in I} \forall \bar{x}_i (\xi_i(\bar{u}, \bar{x}_i) \lor \psi_i(\bar{u}, \bar{x}_i)),$$

where for each $i \in I$, $\xi_i(\bar{u}, \bar{x}_i)$ is a $\Sigma^p_{\beta_i}$ formula and $\psi_i(\bar{u}, \bar{x}_i)$ is a $\Pi^p_{\beta_i}$ formula, for some $\beta_i < \alpha$ and I countable.

The set of positive infinitary formulas, $L^p_{\omega_1\omega}$, is the smallest subset of $L_{\omega_1\omega}$ closed under logical equivalence containing all Π^p_α formulas for $\alpha<\omega_1$.

It is not hard to see that every $L_{\omega_1\omega}$ formula is logically equivalent to an $L^p_{\omega_1\omega}$ formula and that these two sets are thus equivalent. However, as should be evident from the definition, the hierarchies differ at finite levels.

We say that a formula is in *normal form* if it is Σ_{α}^{p} or Π_{α}^{p} for some $\alpha < \omega_{1}$. An easy transfinite induction shows that every $L_{\omega_1\omega}$ formula is equivalent to a formula in a normal form.

Consider a Σ_1^p formula $\xi = \mathbb{V}_{i \in I} \exists \bar{x}_i \psi_i(\bar{x}_i)$ in a computable vocabulary τ . We can fix an injective computable enumeration of the conjunctions of atomic τ -formulas and assume without loss of generality that $i = \lceil \psi_i \rceil$ is the index of ψ_i in this enumeration. Let $X \subseteq \omega$ such that I is X-c.e., then we say that ξ is an X-computable Σ_1^p formula, or short, $\xi \in \Sigma_1^{p,X}$. We will denote the set of Σ_1^p formulas such that I is c.e., as the Σ_1^{pc} formulas, where c stands for computable.

We could intuitively generalize the above definition to arbitrary X-computable α and X-computable Π_{α}^{p} formulas by demanding that all the index sets I are X-c.e. However, doing this formally requires some care. Let us give the formal definition for computable Σ_{α}^{p} and Π_{α}^{p} . It should be obvious that this definition relativizes.

DEFINITION 2.3. For $a \in \mathcal{O}$, we define the index sets S_a^{Σ} and S_a^{Π} as follows:

- Let $|a|_{\mathcal{O}} = 0$ and $S_1^{\Sigma} = \{ \lceil \varphi \rceil \mid \varphi \text{ a finitary conjunction of atomic } \tau\text{-formulas} \}.$
- Let $|a|_{\mathcal{O}} > 0$. Then:

 - $-S_{\overline{a}}^{\Sigma} = \{ \langle \Sigma, a, \overline{x}, e \rangle \mid \overline{x} \text{ is a tuple of variables, } e \in \omega \}, \\ -S_{\overline{a}}^{\Pi} = \{ \langle \Pi, a, \overline{x}, e \rangle \mid \overline{x} \text{ is a tuple of variables, } e \in \omega \}.$

We define the positive infinitary formula $\varphi_i(\overline{u})$ with index i as follows.

- Let $|a|_{\mathcal{O}} = 0$. If $i \in S_1^{\Sigma}$, then $\varphi_i(\overline{u})$ is the τ -formula with Gödel number i.
- Let $|a|_{\mathcal{O}} = 1$. Then:
 - If $i \in S_a^{\Sigma}$, then $i = \langle \Sigma, a, \overline{u}, e \rangle$, for some tuple \overline{u} and index e, and $\varphi_i(\overline{u})$ is the disjunction of formulas $(\exists \overline{x})\xi_j(\overline{u},\overline{x})$, where $j \in W_e \cap S_1^{\Sigma}$.
 - If $i \in S_a^{\Pi}$, then $i = \langle \Pi, a, \overline{u}, e \rangle$, for some tuple \overline{u} and index e, and $\varphi_i(\overline{u})$ is the conjunction of formulas $(\forall \overline{x}) \neg \xi_j(\overline{u}, \overline{x})$, where $j \in W_e \cap S_1^{\Sigma}$.
- Let $|a|_{\mathcal{O}} \geq 2$. Then:
 - If $i \in S_a^{\Sigma}$, then $i = \langle \Sigma, a, \overline{u}, e \rangle$, for some tuple \overline{u} and index e, and $\varphi_i(\overline{u})$ is the disjunction of formulas $(\exists \overline{x})[\xi_{\ell}(\overline{u},\overline{x}) \land \psi_r(\overline{u},\overline{x})]$, where $\langle \ell,r \rangle \in W_e$

- and $\ell \in S_b^{\Sigma}$ and $r \in S_b^{\Pi}$, for some $b <_{\mathcal{O}} a$ with $|b|_{\mathcal{O}} > 0$. Moreover, the third components of the indices ℓ and r are the tuple $(\overline{u}, \overline{x})$.
- If $i \in S_a^\Pi$, then $i = \langle \Pi, a, \overline{u}, e \rangle$, for some tuple \overline{u} and index e, and $\varphi_i(\overline{u})$ is the conjunction of formulas $(\forall \overline{x})[\xi_\ell(\overline{u}, \overline{x}) \lor \psi_r(\overline{u}, \overline{x})]$, where $\langle \ell, r \rangle \in W_e$ and $\ell \in S_b^\Sigma$ and $r \in S_b^\Pi$, for some $b <_{\mathcal{O}} a$ with $|b|_{\mathcal{O}} > 0$. Moreover, the third components of the indices ℓ and r are the tuple $(\overline{u}, \overline{x})$.

If $i \in S_a^{\Sigma}(S_a^{\Pi})$ with $|a| = \alpha$, then $\varphi_i \in \Sigma_{\alpha}^{pc}(\Pi_{\alpha}^{pc})$. A formula ξ is a computable positive infinitary formula if $\xi \in L_{c\omega}^p = \bigcup_{\alpha < \omega_1^{CK}} \Sigma_{\alpha}^{pc} \cup \Pi_{\alpha}^{pc}$.

Definition 2.3 can be relativized to arbitrary $X \subseteq \omega$ by replacing occurrences of \mathcal{O} and W_e with \mathcal{O}^X and W_e^X . This allows us to obtain $\Sigma_{\alpha}^{p,X}$ and $\Pi_{\alpha}^{p,X}$ formulas. As every $L_{\omega_1\omega}^p$ formula φ is Π_{α}^p for some countable ordinal α , φ is $\Pi_{\alpha}^{p,X}$ for X the computable join of the index sets in the definition of φ and a set Y with $\alpha < \omega_1^Y$. Hence, a formula is Π_{α}^p if and only if it is $\Pi_{\alpha}^{p,X}$ for some $X \subseteq \omega$.

DEFINITION 2.4. We define $neg(\varphi)$ following the definition of φ .

- Let $\alpha = 0$.
 - If φ is Σ_0^p , i.e., φ is a conjunction over some finite set I of the atomic formulas φ_i^{at} , where $i \in I$, then $neg(\varphi)$ is the finite disjunction over the same finite set I of $\neg \varphi_i^{at}$, where $i \in I$.
 - If φ is Π_0^p , i.e., φ is a disjunction over some finite set I of $\neg \varphi_i^{at}$, where $i \in I$, then $neg(\varphi)$ is the conjunction over the same finite set I of φ_i^{at} , where $i \in I$.
- Let $\alpha = 1$.
 - If φ is Σ_1^p , i.e., φ is an infinitary disjunction over a set of formulas of the form $\exists \bar{x} \psi$, then $neg(\varphi)$ is an infinitary conjunction over the same set of the formulas $\forall \bar{x} neg(\psi)$.
 - If φ is Π_1^p , i.e., φ is an infinitary conjunction over a set of formulas of the form $\forall \bar{x}\psi$, then $neg(\varphi)$ is an infinitary disjunction over the same set of the formulas $\exists \bar{x}neg(\psi)$.
- Let $\alpha \geq 2$.
 - If φ is Σ_{α}^{p} formula, i.e., φ is an infinitary disjunction over a set of formulas of the form $\exists \bar{x}(\xi \land \psi)$, then $neg(\varphi)$ is an infinitary conjunction over the same set of the formulas $\forall \bar{x}(neg(\xi) \lor neg(\psi))$.
 - If φ is Π_{α}^{p} formula, i.e., φ is an infinitary conjunction over a set of formulas of the form $\forall \bar{x}(\xi \lor \psi)$, then $neg(\varphi)$ is an infinitary disjunction over the same set of the formulas $\exists \bar{x}(neg(\xi) \land neg(\psi))$.

If ξ is not in normal form and thus not in Σ_{α}^{p} or Π_{α}^{p} for any $\alpha < \omega_{1}$, then we can find a formula in normal form ψ such that $\psi \equiv \xi$ and let $neg(\xi) = neg(\psi)$.

The above definition makes the proof of the following proposition self-evident.

PROPOSITION 2.5. For any $L^p_{\omega_1\omega}$ formula φ , $neg(neg(\varphi)) \equiv \varphi$. Furthermore, if $\varphi \in \Pi^{pc}_{\alpha}$, then $neg(\varphi) \in \Sigma^{pc}_{\alpha}$ and $neg(neg(\varphi)) = \varphi$.

Following [27, Chapter V.4], consider $L^p_{\omega_1\omega}$ formulas in the language of arithmetic with one extra unary relation symbol D, to represent the diagram of the structure, which we treat as a second-order variable. This means that we allow atomic formulas

of the form D(x). We will refer to these formulas as \mathbb{N} - $L^p_{\omega_1\omega}$ formulas. We can now talk about \mathbb{N} - $L_{\omega_1\omega}^{p'}$ definable subsets of 2^{ω} (or $Mod(\tau)$) in the standard model of arithmetic. A set of natural numbers A is \mathbb{N} - $L^p_{\omega_1\omega}$ -definable if there is an \mathbb{N} - $L^p_{\omega_1\omega}$ formula ξ such that $(\mathbb{N}, A) \models \xi$ where \mathbb{N} is the standard model of arithmetic. By identifying elements of 2^{ω} and $Mod(\tau)$ as characteristic functions of sets we get the notion of definability for these elements. Furthermore, it is not hard to see that within this model every \mathbb{N} - $L^p_{\omega_1\omega}$ formula is equivalent to an \mathbb{N} - $L^p_{\omega_1\omega}$ formula without quantifiers, and that this quantifier elimination can be done without increasing the complexity of the formula. To see this, simply note that we can replace formulas of the form $\exists x \xi(x)$ by $\forall x \in \omega \xi(\mathbf{n})$ and formulas of the form $\forall x \xi(x)$ by $\forall x \in \omega \xi(\mathbf{n})$ where \mathbf{n} is the formal term for n in \mathbb{N} . Notice that the atomic subformulas of a quantifier-free \mathbb{N} - $L^p_{\omega_1\omega}$ formula are either $D(\mathbf{n})$, \top , or \bot . We will refer to Σ^p_α formulas of this form as \mathbb{N} - Σ_{α}^{p} formulas and to Π_{α}^{p} formulas as \mathbb{N} - Π_{α}^{p} formulas.

Proposition 2.6. For all non-zero $\alpha < \omega_1$,

$$\begin{array}{l} (1) \ \boldsymbol{\Sigma}_{\alpha}^{0}(2^{\omega}) = Mod\left(\mathbb{N}\text{-}\boldsymbol{\Sigma}_{\alpha}^{p}\right) = \left\{\left\{X \in 2^{\omega} : (\mathbb{N},X) \models \xi\right\} : \xi \in \mathbb{N}\text{-}\boldsymbol{\Sigma}_{\alpha}^{p}\right\}, \\ (2) \ \boldsymbol{\Pi}_{\alpha}^{0}(2^{\omega}) = Mod\left(\mathbb{N}\text{-}\boldsymbol{\Pi}_{\alpha}^{p}\right) = \left\{\left\{X \in 2^{\omega} : (\mathbb{N},X) \models \xi\right\} : \xi \in \mathbb{N}\text{-}\boldsymbol{\Pi}_{\alpha}^{p}\right\}. \end{array}$$

PROOF. The proof is by induction on α . By our comments in the above paragraph we may assume that \mathbb{N} - $L^p_{\omega_1\omega}$ formulas are quantifier-free and all atomic subformulas are of the form \top , \bot , or $D(\mathbf{n})$ for some $n \in \omega$. If $\xi \in \mathbb{N}$ - Σ_0^p contains the subformula \perp , then $Mod(\xi) = \emptyset$ and if $\xi = \top$, then $Mod(\xi) = 2^{\omega}$. Otherwise, the corresponding open set X_{ξ} is $\bigcap_{n \in \omega: D(\mathbf{n}) \in sf(\xi)} O_n$, where by $sf(\xi)$ we denote the subformulas of ξ .

If $\xi \in \mathbb{N}$ - Σ_1^p , i.e., $\xi = \mathbb{W}_{i \in I} \psi_i$ with $\psi_i \in \mathbb{N}$ - Σ_0^p , then $Mod(\xi) = X_{\xi} = \bigcup_{i \in I} X_{\psi_i} \in \mathbb{N}$ Σ^0_1 . If $\xi \in \mathbb{N}$ - Π^p_1 , then $\xi = neg(\psi)$ and $Mod(\xi) = Mod(neg(\psi)) = 2^{\omega} \setminus X_{\psi} \in \Pi^0_1$. On the other hand, if $B \in \Sigma^0_1$, i.e., $B = \bigcup_{i \in I} \bigcap_{n \leq N_i} O_n$, then let $\xi_B = \bigcup_{i \in I} \bigcap_{n \leq N_i} O_n$, then $\xi \in \Sigma^0_1$ is the sum of $\xi \in \Sigma^0_1$. $\forall i \in I \land M_n \leq N_i D(\mathbf{n}).$ If $B \in \mathbf{\Pi}_1^0$, then $2^\omega \setminus B \in \mathbf{\Sigma}_1^0$, $neg(\xi_{2^\omega \setminus B}) \in \mathbb{N} - \mathbf{\Pi}_1^p$ and $B = \mathbf{\Pi}_1^p \in \mathbf{\Pi}_1^p$ $Mod(neg(\xi_{2^{\omega}\setminus B})).$

Assume that for all $\beta < \alpha$ and all $\mathbb{N}-\Sigma^p_{\beta}$ formulas ξ , there is a Σ^0_{β} set X_{ξ} such that $Mod(\xi) = X_{\xi}$. Let $\xi \in \mathbb{N}-\Sigma^p_{\alpha}$, i.e., $\xi = \mathbb{W}_{i \in I}(\psi_i \wedge neg(\theta_i))$ for $\psi_i, \theta_i \in \mathbb{N}-\Sigma^p_{\beta_i}$ with $eta_i < lpha$. Then $Mod(\xi) = \bigcup_{i \in I} X_{\psi_i} \setminus X_{\theta_i} = X_{\xi} \in \mathbf{\Sigma}^0_{lpha}$. If $\xi \in \mathbb{N}$ - Π^p_{lpha} , then $\xi = neg(\psi)$

for $\psi \in \Sigma_{\alpha}^{p}$ and $Mod(\xi) = Mod(neg(\psi)) = 2^{\omega} \setminus X_{\psi} \in \Pi_{\alpha}^{0}$. Suppose that for all $\beta < \alpha$ and all Σ_{β}^{0} sets B, there is an \mathbb{N} - Σ_{β}^{p} formula ξ_{B} such that $Mod(\xi_B) = B$. Assume that $B \in \Sigma^0_{\alpha}$, i.e., $B = \bigcup_{i \in I} B_i \setminus B'_i$ with $B_i, B'_i \in \Sigma^0_{\beta_i}$ for $\beta_i < \alpha$. Then $\xi_B = \mathbb{W}_{i \in I}(\xi_{B_i} \land neg(\xi_{B_i'})) \in \mathbb{N}-\Sigma_{\alpha}^p$ and $Mod(\xi_B) = B$. At last, let $B \in \Pi^0_{\alpha}$, then $2^{\omega} \setminus B \in \Sigma^0_{\alpha}$, $neg(\xi_{2^{\omega} \setminus B}) \in \mathbb{N}$ - Π^p_{α} and $Mod(neg(\xi_{2^{\omega} \setminus B})) = B$.

2.4. The effective Borel hierarchy. As we have discussed after Definition 2.3, every positive infinitary formula is computable relative to some oracle X. Proposition 2.6 associates to every Borel set a positive infinitary formula ξ in the language of arithmetic with an additional unary relation symbol. This motivates the following definition of the effectively Borel hierarchy on 2^{ω} and through this on $Mod(\tau)$ for a given computable vocabulary τ .

Definition 2.7. Let $X \subseteq 2^{\omega}$ and $Y \subseteq \omega$.

ullet $X\in \Sigma^0_lpha(Y)$ if there is a $\Sigma^{p,Y}_lpha$ \mathbb{N} - $L^p_{\omega_1\omega}$ -formula arphi such that $X=\{D:(\mathbb{N},D)\models \mathbb{N}\}$ φ }. A $\Sigma_{\alpha}^{p,Y}$ index for φ is a Y-computable index for X.

• $X \in \Pi^0_{\alpha}(Y)$ if there is a $\Pi^{p,Y}_{\alpha} \mathbb{N}$ - $L^p_{\omega_1\omega}$ -formula φ such that $X = \{D : (\mathbb{N}, D) \models$ φ }. A $\Pi_{\alpha}^{p,Y}$ index for φ is a Y-computable index for X.

Furthermore, X is effectively Σ_{α}^{0} , or $X \in \Sigma_{\alpha}^{0}$, if $X \in \Sigma_{\alpha}^{0}(\emptyset)$. Likewise, X is effectively Π^0_{α} , or $X \in \Pi^0_{\alpha}$, if $X \in \Pi^0_{\alpha}(\emptyset)$.

§3. The Lopez-Escobar theorem for positive infinitary formulas. The main goal of this section is to give a forcing proof of the Lopez-Escobar theorem and its related corollaries. The definition of our forcing relation is similar to the forcing relation in [34], but our presentation of the forcing and the forcing poset are closer to [27].

Our forcing poset is the space of presentations of a fixed structure A. We produce a generic element $\mathcal{G} \cong \mathcal{A}$ that decides membership of the Borel sets on \mathcal{A} . We represent the Borel sets by their \mathbb{N} - $L^p_{\omega_1\omega}$ formulas using the correspondence established in Proposition 2.6. Formally our forcing poset \mathcal{P} is the set of finite permutations of the natural numbers. We will build a generic enumeration g and let our generic proposition $\mathcal{G} = g^{-1}(\mathcal{A})$. Let us start by defining our forcing relation.

DEFINITION 3.1 (Forcing relation). Fix a countable structure A in a countable vocabulary and let \mathcal{P} be the set of all finite permutations of A, which by our assumption is ω . For a forcing condition $p \in \mathcal{P}$ define the forcing relation $\Vdash_{\mathcal{A}}$ inductively for all \mathbb{N} - $L^p_{\omega_1\omega}$ -formulas φ in normal form as follows.

 $(\mathbb{N}-\Sigma_0^p) \text{ If } \varphi = D(n_0) \wedge \cdots \wedge D(n_k) \text{, then } p \Vdash_{\mathcal{A}} \varphi \text{ if } p \Vdash_{\mathcal{A}} D(n_i) \text{ for all } i \leq k.$ $(\mathbb{N}-\Sigma_1^p) \text{ If } \varphi = \mathbb{W}_{i \in I} \xi_i, \text{ where } \xi_i \text{ are } \mathbb{N}-\Sigma_0^p \text{ formulas, then } p \Vdash_{\mathcal{A}} \varphi \text{ if for some }$

 $i \in I, p \Vdash_{\mathcal{A}} \xi_{i}.$ $(\mathbb{N}-\Sigma_{>1}^{p}) \text{ If } \varphi = \mathbb{W}_{i \in I}(\xi_{i} \wedge \theta_{i}), \text{ where for each } i \in I, \xi_{i} \in \mathbb{N}-\Sigma_{\beta_{i}}^{p} \text{ and } \theta_{i} \in \mathbb{N}-\Pi_{\beta_{i}}^{p}$ for some $\beta_i > 0$, then $p \Vdash_{\mathcal{A}} \varphi$ if $p \Vdash_{\mathcal{A}} \xi_i$ and $p \Vdash_{\mathcal{A}} \theta_i$ for some $i \in I$.

 $(\mathbb{N} - \Pi_{\alpha}^{p})$ If φ is an $\mathbb{N} - \Pi_{\alpha}^{p}$ formula, for any $\alpha \geq 0$, then $p \Vdash_{\mathcal{A}} \varphi$ if for all $q \supseteq p$, $a \not\Vdash_{\Lambda} neg(\varphi).$

There is a subtle point to the definition of (atom2). If ξ_n^{at} contains a variable symbol x_i with $i \ge |p|$, then we regard $\xi_n^{at}[x_i \mapsto p_i]$ as false in \mathcal{A} and thus $p \not\Vdash_{\mathcal{A}} D(n)$ in this case.

LEMMA 3.2 (Extension). For any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ and forcing condition p, if $p \Vdash_{\mathcal{A}} \varphi$ and $p \subseteq q$, then $q \Vdash_{\mathcal{A}} \varphi$.

PROOF. Straightforward induction on φ .

Lemma 3.3 (Consistency). For any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ and any forcing condition p, it is not the case that $p \Vdash_A \varphi$ and $p \Vdash_A neg(\varphi)$.

PROOF. Towards a contradiction, assume that for some \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ and some forcing condition p, $p \Vdash_{\mathcal{A}} \varphi$ and $p \Vdash_{\mathcal{A}} neg(\varphi)$. Without loss of generality, suppose that φ is an \mathbb{N} - Σ_{α}^{p} formula, for some α . Then, clearly, $neg(\varphi)$ is an \mathbb{N} - Π_{α}^{p} formula. It follows that, since $p \Vdash_{\mathcal{A}} neg(\varphi)$, for all $q \supseteq p$, $q \not\Vdash_{\mathcal{A}} neg(neg(\varphi))$ and hence $p \not\Vdash_{\mathcal{A}} \varphi$ because $neg(neg(\varphi)) \equiv \varphi$.

Lemma 3.4 (Density). For any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ and forcing condition p, there is a forcing condition $q \supseteq p$ such that $q \Vdash_{\mathcal{A}} \varphi$ or $q \Vdash_{\mathcal{A}} neg(\varphi)$.

PROOF. Assume that there is an \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ and forcing condition p such that for all $q \supseteq p$, $q \not\Vdash_{\mathcal{A}} \varphi$ and $q \not\Vdash_{\mathcal{A}} neg(\varphi)$. Without loss of generality, suppose that φ is an \mathbb{N} - Σ^p_α formula. Hence, $neg(\varphi)$ is an \mathbb{N} - Π^p_α formula. Since $p \not\Vdash_{\mathcal{A}} neg(\varphi)$, it follows that for some $q \supseteq p$, $q \Vdash_{\mathcal{A}} neg(neg(\varphi))$. But since $neg(neg(\varphi)) \equiv \varphi$, we conclude that $q \Vdash_{\mathcal{A}} \varphi$.

DEFINITION 3.5. A bijection g is called a *generic* enumeration of \mathcal{A} if for any \mathbb{N} - $L^p_{c\omega}$ formula φ , there is $p \subset g$ such that $p \Vdash_{\mathcal{A}} \varphi$ or $p \Vdash_{\mathcal{A}} neg(\varphi)$.

Lemma 3.6. Every $p \in \mathcal{P}$ can be extended to a generic enumeration g.

PROOF. As the set of \mathbb{N} - $L^p_{c\omega}$ formulas in normal form is countable, we can fix an enumeration $(\xi_n)_{n\in\omega}$ of these formulas and let $F_n=\{q\in\mathcal{P}:q\Vdash_{\mathcal{A}}\xi_n\vee q\Vdash_{\mathcal{A}}\neg(\xi_n)\}$. By Lemma 3.4 every F_n is dense in \mathcal{P} . Define a sequence $p=p_0\subseteq p_1\subseteq\cdots$ such that $p_{2n}\in F_n$ and p_{2n+1} contains the least natural number not in p_{2n} . As all the F_n are dense, this sequence is well-defined and $g=\lim_{n\to\omega}p_n$ is generic.

THEOREM 3.7 (Forcing equals truth). Let g be a generic enumeration of A and let $G = g^{-1}(A)$ and D_G be the atomic diagram of G. Then for any \mathbb{N} - L^p_{co} formula φ ,

$$(\mathbb{N}, D_{\mathcal{G}}) \models \varphi \text{ iff } (\exists p \subset g)[p \Vdash_{\mathcal{A}} \varphi].$$

PROOF. We prove this by transfinite induction on the \mathbb{N} - $L^p_{c\omega}$ formula φ . Let φ be atomic. Then $\varphi = \top$, $\varphi = \bot$ or $\varphi = D(\mathbf{n})$ for some n. The first two cases follow trivially from the definition. For the third case, suppose that for some $p \subset g$, $p \Vdash_{\mathcal{A}} D(\mathbf{n})$. Then $p^{-1}(\mathcal{A}) \models \xi_n^{at}[x_i \mapsto i]$ and, thus, $g^{-1}(\mathcal{A}) \models \xi_n^{at}[x_i \mapsto i]$, or, in other words, $(\mathbb{N}, D_{\mathcal{G}}) \models D(\mathbf{n})$. For the converse, let $(\mathbb{N}, D_{\mathcal{G}}) \models D(\mathbf{n})$. By our convention that ξ_n^{at} does not contain variable symbols x_i for i > n we have that for $p = g \upharpoonright n$, $p^{-1}(\mathcal{A}) \models \xi_n^{at}[x_i \mapsto i]$ and hence $p \Vdash_{\mathcal{A}} D(n)$. The equivalence for \mathbb{N} - Σ_0^{pc} and \mathbb{N} - Σ_1^{pc} formulas follows easily.

Let φ be equivalent to an \mathbb{N} - Σ_{α}^{pc} formula, for $\alpha \geq 2$. Then $\varphi \equiv \mathbb{W}_{i \in W_e}(\xi_i \wedge \psi_i)$, where for any $i \in W_e$, ξ_i is \mathbb{N} - $\Sigma_{\beta_i}^{pc}$ and ψ_i is \mathbb{N} - $\Pi_{\beta_i}^{pc}$ for some $\beta_i < \alpha$. Suppose that for some $p \subset g$, $p \Vdash_{\mathcal{A}} \varphi$, i.e., for some $i \in W_e$, $p \Vdash_{\mathcal{A}} \xi_i$ and $p \Vdash_{\mathcal{A}} \psi_i$. By the induction hypothesis, $(\mathbb{N}, D_{\mathcal{G}}) \models \xi_i$ and $(\mathbb{N}, D_{\mathcal{G}}) \models \psi_i$ and hence $(\mathbb{N}, D_{\mathcal{G}}) \models \varphi$. For the converse, let $(\mathbb{N}, D_{\mathcal{G}}) \models \varphi$. Then $(\mathbb{N}, D_{\mathcal{G}}) \models \xi_i$ and $(\mathbb{N}, D_{\mathcal{G}}) \models \psi_i$ for some $i \in W_e$. By the induction hypothesis, there is some $p_0 \subset g$ such that $p_0 \Vdash_{\mathcal{A}} \xi_i$ and some $p_1 \subset g$ such that $p_1 \Vdash_{\mathcal{A}} \psi_i$. Let $p = \max\{p_0, p_1\}$. Clearly, $p \subset g$. By monotonicity of forcing, $p \Vdash_{\mathcal{A}} \xi_i$ and $p \Vdash_{\mathcal{A}} \psi_i$. It follows that $p \Vdash_{\mathcal{A}} \varphi$.

Now let us consider the case when φ is equivalent to an \mathbb{N} - Π_{α}^{pc} formula, for any $\alpha \geq 0$. First, let $p \Vdash_{\mathcal{A}} \varphi$ for some $p \subset g$. Towards a contradiction, assume that $(\mathbb{N}, D_{\mathcal{G}}) \not\models \varphi$. But then $(\mathbb{N}, D_{\mathcal{G}}) \models neg(\varphi)$, where $neg(\varphi)$ is \mathbb{N} - Σ_{α}^{pc} . It follows that for some $q \subset g$, $q \Vdash_{\mathcal{A}} neg(\varphi)$. Let $r = \max\{p, q\}$. By monotonicity, it follows that $r \Vdash_{\mathcal{A}} \varphi$ and $r \Vdash_{\mathcal{A}} neg(\varphi)$. A contradiction.

Second, let $(\mathbb{N}, D_{\mathcal{G}}) \models \varphi$. Assume that for all $p \subset g$, $p \not\models_{\mathcal{A}} \varphi$. But then, since g is generic, there is some $q \subset g$ such that $q \Vdash_{\mathcal{A}} neg(\varphi)$. Since $neg(\varphi)$ is \mathbb{N} - Σ_{α}^{pc} , it follows that $(\mathbb{N}, D_{\mathcal{G}}) \models neg(\varphi)$. We reach a contradiction.

3.1. Definability of forcing. For any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ , we will define an $L^p_{\omega_1\omega}$ formula $Force_{\varphi}(\bar{u})$ such that

$$p \Vdash_{\mathcal{A}} \varphi \text{ iff } \mathcal{A} \models Force_{\varphi}(\bar{p}).$$

DEFINITION 3.8. For any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ in normal form and every tuple $\bar{u} \in \omega^{<\omega}$, define the formula $Force_{\varphi}(\bar{u})$ inductively as follows.

(atom1)
$$Force_{\top}(\bar{u}) = \exists x \ x = x \text{ and } Force_{\bot}(\bar{u}) = \exists x \exists y (x \neq y \land x = y).$$
 (atom2) If $\varphi = D(n)$, then $Force_{\varphi}(\bar{u}) = \bigwedge_{i \neq j} \underset{\& i,j < n}{\&} u_i \neq u_j \underset{\& \xi_n^{at}}{^a} [x_i \mapsto u_i].$ ($\mathbb{N}\text{-}\Sigma_0^p$) If $\varphi = \underset{i \in I}{\&} \xi_i$ with ξ_i atomic, then $Force_{\varphi}(\bar{u}) = \underset{i \in I}{\&} Force_{\xi_i}(\bar{u}).$ ($\mathbb{N}\text{-}\Sigma_1^p$) If $\varphi = \underset{i \in I}{\&} \xi_i$ where $\xi_i \in \mathbb{N}\text{-}\Sigma_0^p$, then $Force_{\varphi}(\bar{u}) = \underset{i \in I}{\&} Force_{\xi_i}(\bar{u}).$ ($\mathbb{N}\text{-}\Sigma_{>1}^p$) If $\varphi = \underset{i \in I}{\&} (\xi_i \land \theta_i)$ where $\xi_i \in \mathbb{N}\text{-}\Sigma_{\beta_i}^p$ and $\theta_i \in \mathbb{N}\text{-}\Pi_{\beta_i}^p$, $\beta_i > 0$, then

$$Force_{\varphi}(\bar{u}) = \mathbb{W}_{i \in I}(Force_{\xi_i}(\bar{u}) \wedge Force_{\theta_i}(\bar{u})).$$

$$(\mathbb{N}-\Pi_{\alpha}^{p}) \ Force_{\varphi}(\overline{u}) = \mathbb{M}_{k \in \omega} \forall x_{1} \cdots \forall x_{k} (neg(Force_{neg(\varphi)}(\overline{u}, \overline{x}))).$$

Notice that the definition of $Force_{\varphi}(\bar{u})$ only depends on the formula φ and the size of the tuple \bar{u} . It depends neither on the tuple \bar{u} itself nor on the structure A.

Lemma 3.9. For all $\alpha \geq 1$, for each \mathbb{N} - Σ_{α}^{pc} formula φ , Force φ is a Σ_{α}^{pc} τ -formula.

PROOF. This is proven by transfinite induction on α .

- Let φ be an \mathbb{N} - Σ_0^p formula. Since \neq is included in τ , the formula $Force_{\varphi}$ is a finite conjunction of finite Σ_1^p formulas and hence it is a Σ_1^p formula.
- Let φ be an \mathbb{N} - Σ_1^p formula. Then $\varphi = \mathbb{W}_{i \in I} \xi_i$, where all $\dot{\xi}_i \in \mathbb{N}$ - Σ_0^p . We know that $Force_{\xi_i}(\overline{u})$ is Σ_0^p for any tuple \overline{u} . Then

$$Force_{\varphi}(\bar{u}) = \mathbb{W}_{i \in I} Force_{\xi_i}(\overline{u})$$

is a Σ_1^p τ -formula.

• Let φ be an \mathbb{N} - Σ_{α}^{p} formula, $\alpha \geq 2$. Then $\varphi = \mathbb{W}_{i \in I}(\xi_{i} \wedge \theta_{i})$, where $\xi_{i} \in \mathbb{N}$ - Σ_{β}^{p} and $\theta_{i} \in \mathbb{N}$ - Π_{β}^{p} , for some $\beta < \alpha$. Without loss of generality, we may suppose that $\beta \geq 1$. By the induction hypothesis, we know that $Force_{\xi_{i}}(\overline{u})$ is Σ_{β}^{p} and $Force_{\theta_{i}}(\overline{u})$ is Π_{β}^{p} .

$$Force_{\varphi}(\bar{u}) = \mathbb{V}_{i \in I}(Force_{\xi_i}(\overline{u}) \wedge Force_{\theta_i}(\overline{u}))$$

is a computable infinitary Σ_{α}^{p} τ -formula.

• Let φ be an \mathbb{N} - Π^p_{α} formula, for any $\alpha \geq 0$. Then clearly, $neg(\varphi)$ is an \mathbb{N} - Σ^p_{α} formula. It follows that $Force_{neg(\varphi)}(\overline{u})$ is a Σ^p_{α} τ -formula for any tuple \overline{u} . Then $neg(Force_{neg(\xi_i)}(\overline{u}))$ is Π^p_{α} and hence

$$Force_{\varphi}(\bar{u}) = \mathbb{M}_{k \in \omega} \forall x_1 \cdots \forall x_k \ neg(Force_{neg(\varphi)}(\overline{u}, \overline{x}))$$

is Π^p_α formula if $\alpha \ge 1$ and Π^p_1 if $\alpha = 0$.

We still have to establish that if φ is computable \mathbb{N} - Σ_{α}^{p} , then $Force_{\varphi}(\bar{u})$ is computable Σ_{α}^{p} . Just notice that given an index set for an \mathbb{N} - Σ_{α}^{pc} formula φ our inductive definition of $Force_{\varphi}(\bar{u})$ describes an algorithm that produces an index set for a Σ_{α}^{pc} formula equivalent to $Force_{\varphi}(\bar{u})$.

Lemma 3.10 (Definability of forcing). For any forcing condition p and any \mathbb{N} - $L^p_{\omega_1\omega}$ formula φ , $p \Vdash_{\mathcal{A}} \varphi$ iff $\mathcal{A} \models Force_{\varphi}(\bar{p})$.

PROOF. Induction on φ .

For classes of structures C, D, and K, we say that C = D within K if $C \cap K = D \cap K$. We essentially repeat the proof in [27] to obtain an effective version of Lopez-Escobar's theorem.

THEOREM 3.11. Let $K \subseteq Mod(\tau)$ be isomorphism invariant. Suppose that for $\alpha \geq 1$, i is an index for a Π^0_α set B_i in the effective Borel hierarchy such that $B_i \cap K$ is isomorphism invariant. Then we can effectively find an index for a Π^{pc}_α τ -sentence φ such that $B_i = Mod(\varphi)$ within K.

PROOF. Consider a Π^0_α set B_i in the effective Borel hierarchy. We can effectively find an index j of an \mathbb{N} - Π^{pc}_α formula ξ such that $B_i = \operatorname{Mod}(\xi)$. By Lemmas 3.9 and 3.10 we can effectively find an index for the Π^{pc}_α τ -sentence $\varphi = Force_\xi(\langle \rangle)$ where $\langle \rangle$ denotes the empty forcing condition. We will show that $B_i = \operatorname{Mod}(\varphi)$ within K.

First, let $A \in B_i \cap K$. We must show that $A \models \varphi$. Towards a contradiction, assume $A \not\models \varphi$. Then, by Lemma 3.10, $\langle \rangle \not\models_A \xi$. Since ξ is \mathbb{N} - Π^p_α , by Definition 3.1, there is a forcing condition q such that $q \models_A neg(\xi)$. Extend q to a generic enumeration g of A and consider $\mathcal{G} = g^{-1}(A)$. But then by Theorem 3.7, $(\mathbb{N}, D_{\mathcal{G}}) \models neg(\xi)$. As $Mod(neg(\xi)) = 2^\omega \setminus B_i$, $\mathcal{G} \in 2^\omega \setminus B_i$. But $B_i \ni A$ was invariant and thus, as $A \cong \mathcal{G}$, $\mathcal{G} \in B_i$, a contradiction.

Second, let $A \in \operatorname{Mod}(\varphi) \cap \mathcal{K}$. Then $A \models \varphi$ and hence $\langle \rangle \Vdash_{\mathcal{A}} \xi$. Consider any generic copy \mathcal{G} of A. By Theorem 3.7, $(\mathbb{N}, D_{\mathcal{G}}) \models \xi$ and hence $\mathcal{G} \in \operatorname{Mod}(\xi) \cap \mathcal{K}$. Since $\operatorname{Mod}(\xi) \cap \mathcal{K}$ is closed under isomorphism, $A \in \operatorname{Mod}(\xi) \cap \mathcal{K} = B_i \cap \mathcal{K}$.

Notice that Theorem 3.11 also works for Σ_{α}^{pc} sets as neg is a computable function that takes an index for a Σ_{α}^{pc} set and outputs an index for a Π_{α}^{pc} set equivalent to the negation of the original formula. Proving the theorem for Σ_{α}^{pc} sets directly seems to be difficult using our forcing as for \mathbb{N} - Σ_{α}^{pc} formulas ξ , $\emptyset \not\Vdash_{\mathcal{A}} \xi$.

Theorem 3.12. Fix a computable ordinal $\alpha \geq 1$. An isomorphism invariant $B \subseteq Mod(\tau)$ is Π^0_{α} if and only if there is a Π^{pc}_{α} τ -sentence φ such that $B = Mod(\varphi)$.

PROOF. The left to right direction is just Theorem 3.11 with $K = Mod(\tau)$. The right to left direction is established by an easy transfinite induction.

The following corollary follows directly from the relativization of Theorem 3.12 after one notices that every Π^0_{α} is $\Pi^0_{\alpha}(X)$ for some $X \subseteq \omega$.

COROLLARY 3.13. Let $B \subseteq Mod(\mathcal{L})$ be isomorphism invariant and let $\alpha \geq 1$. The set B is Π^0_{α} if and only if there is a Π^p_{α} sentence φ such that $B = Mod(\varphi)$.

By the argument given after Theorem 3.11 the analogs of Theorem 3.12 and Corollary 3.13 for Σ_{α}^{0} sets are also true.

§4. A pullback theorem for computable embeddings. An enumeration operator Γ is a c.e. set of pairs $\langle n, m \rangle$ where we treat n as an index for F_n , the nth set in a fixed computable enumeration of the finite subsets of ω . For $X \subseteq \omega$ we write $\Gamma(X)$ for the set $\{m : \langle n, m \rangle \in \Gamma \text{ and } F_n \subseteq X\}$, and for an element $f \in 2^{\omega}$, we let $X_f \subseteq \omega$ be such that $\chi_{X_f} = f$. Then an enumeration operator Γ defines a function $2^{\omega} \to 2^{\omega}$ given by $f \mapsto \chi_{\Gamma(X_f)}$. In fact, it is easy to see that enumeration operators are Scott continuous (i.e., continuous functions in the Scott topology on 2^{ω}). Identifying countable models in relational vocabularies by their atomic diagrams, we may view

enumeration operators as Scott continuous functions from $Mod(\tau_0)$ to $Mod(\tau_1)$ for τ_0, τ_1 relational vocabularies, and, thus, as functions between classes of structures. Let \mathcal{K}_0 be a class of τ_0 -structures, and let \mathcal{K}_1 be a class of τ_1 -structures.

DEFINITION 4.1. An enumeration operator Γ is a *positive computable embedding* of \mathcal{K}_0 into \mathcal{K}_1 , denoted by Γ : $\mathcal{K}_0 \leq_{pc} \mathcal{K}_1$, if Γ satisfies the following:

- (1) For any $A \in \mathcal{K}_0$, $\Gamma(D(A))$ is the atomic diagram of a structure from \mathcal{K}_1 . This structure is denoted by $\Gamma(A)$.
- (2) For any $A, B \in \mathcal{K}_0$, we have $A \cong B$ if and only if $\Gamma(A) \cong \Gamma(B)$.

Positive computable embeddings have the useful property of *monotonicity*: If $\Gamma \colon \mathcal{K}_0 \leq_{pc} \mathcal{K}_1$ and $\mathcal{A} \subseteq \mathcal{B}$ are structures from \mathcal{K}_0 , then we have $\Gamma(\mathcal{A}) \subseteq \Gamma(\mathcal{B})$.

For total structures, i.e., structures of the form $\mathcal{A} = (A, R_1, \dots, R_n, \overline{R}_1, \dots, \overline{R}_n)$, the notion of positive computable embedding coincides with the notion of computable embedding as defined in [23] and denoted by \leq_c .

Let us denote the structure $\mathcal{A}_X = (\mathbb{N}, S, X)$, where S is the successor relation and X is an arbitrary set. Then it is clear that $\{\mathcal{A}_K\} \leq_c \{\mathcal{A}_{\overline{K}}\}$, but $\{\mathcal{A}_K\} \nleq_{pc} \{\mathcal{A}_{\overline{K}}\}$, where K denotes the halting set. Moreover, $\{\mathcal{A}_\emptyset\} \leq_{pc} \{\mathcal{A}_K\}$, but $\{\mathcal{A}_\emptyset\} \nleq_c \{\mathcal{A}_K\}$.

DEFINITION 4.2 [23]. A Turing operator $\Phi = \varphi_e$ is a *Turing computable embedding* of \mathcal{K}_0 into \mathcal{K}_1 , denoted by $\Phi \colon \mathcal{K}_0 \leq_{tc} \mathcal{K}_1$, if Φ satisfies the following:

- (1) For any $A \in \mathcal{K}_0$, the function $\varphi_e^{D(A)}$ is the characteristic function of the atomic diagram of a structure from \mathcal{K}_1 . This structure is denoted by $\Phi(A)$.
- (2) For any $\mathcal{A}, \mathcal{B} \in \mathcal{K}_0$, we have $\mathcal{A} \cong \mathcal{B}$ if and only if $\Phi(\mathcal{A}) \cong \Phi(\mathcal{B})$.

Turing computable embeddings do in general not have the monotonicity properties of computable embeddings. This can be used to show the following.

PROPOSITION 4.3 (Greenberg and, independently, Kalimullin; see [20, 23]). If $\mathcal{K}_0 \leq_c \mathcal{K}_1$, then $\mathcal{K}_0 \leq_{tc} \mathcal{K}_1$. The converse is not true.

The Pullback Theorem in [4] connects Turing computable embeddings with definability by classical computable infinitary sentences. We obtain an analog of this result in our setting. The original pullback theorem was proved for structures whose universe can be arbitrary subsets of the natural numbers. Our version might seem a bit more restrictive at first sight, as we assume the universes of our structures to be ω and this in particular excludes finite structures. However, we could easily add unary relations for the universe of a structure and its coset to the vocabulary and then we could deal with this more general setting as well.

PROPOSITION 4.4. A positive computable embedding $\Gamma_e: \mathcal{K} \leq_{pc} \mathcal{K}'$ can be transformed into an effective Scott continuous function $\Gamma_a: Mod(\tau) \to Mod(\tau')$ with the property that $\Gamma_a(\mathcal{K}) = \Gamma_e(\mathcal{K})$.

PROOF. Recall that for a set A, $\Gamma_e(A) = \{x \mid \langle v, x \rangle \in W_e \& D_v \subseteq A\}$. We may suppose that for all natural numbers n, $\langle \ulcorner \emptyset \urcorner, \ulcorner n = n \urcorner \rangle \in W_e$. This ensures that all output sets can be interpreted as τ' -structures with domains ω . Since we can interpret any natural number as the code of a positive atomic sentence in τ' , we only need to filter out from W_e all sentences of the form $n \neq n$ and n = m for different natural numbers n and m.

Let us have the enumeration $\{W_{e,s}\}_{s<\omega}$ of the c.e. set W_e , where $W_e = \bigcup_s W_{e,s}$, $W_{e,0} = \emptyset$, and $|W_{e,s+1} \setminus W_{e,s}| \le 1$ for all s. We define $W_{a,s}$ inductively so that $W_{a,0} = \emptyset$ and $W_{a,s+1} = W_{a,s}$ if $\langle v, \lceil n \ne n \rceil \rangle$ or $\langle v, \lceil n = m \rceil \rangle$ belongs to $W_{e,s+1} \setminus W_{e,s}$, and otherwise, set $W_{a,s+1} = W_{a,s} \cup (W_{e,s+1} \setminus W_{e,s})$. Then clearly $\Gamma_a : \operatorname{Mod}(\tau) \to \operatorname{Mod}(\tau')$ is an effective Scott continuous mapping and by the construction of W_a , $\Gamma_a(\mathcal{K}) = \Gamma_e(\mathcal{K})$. It is clear that we can effectively obtain the index a from the index a.

Theorem 4.5 (Pullback Theorem). Let $K \subseteq Mod(\tau)$ and $K' \subseteq Mod(\tau')$ be closed under isomorphism. Let $\Gamma_e : K \leq_{pc} K'$, then for any $L^{pc}_{\omega_1\omega}$ τ' -sentence φ' we can effectively find an $L^{pc}_{\omega_1\omega}$ τ -sentence φ such that for all $A \in K$,

$$\mathcal{A} \models \varphi \text{ iff } \Gamma_e(\mathcal{A}) \models \varphi'.$$

Moreover, if φ' is Σ^{pc}_{α} (or Π^{pc}_{α}), then so is φ .

PROOF. By Proposition 4.4, we can view Γ_e as an effective Scott continuous function from $\operatorname{Mod}(\tau)$ to $\operatorname{Mod}(\tau')$ that is isomorphism invariant on \mathcal{K} , i.e., $\mathcal{A} \cong \mathcal{B}$ if and only if $\Gamma_e(\mathcal{A}) \cong \Gamma_e(\mathcal{B})$ for all $\mathcal{A}, \mathcal{B} \in \mathcal{K}$. Thus if $B \subseteq \operatorname{Mod}(\tau')$ is invariant Π^0_α , then $\Gamma_e^{-1}(B)$ is a Π^0_α subset of $\operatorname{Mod}(\tau)$ that is invariant on \mathcal{K} .

The \mathbb{N} - Π_{α}^{p} formula ξ describing $\Gamma_{e}^{-1}(B)$ can be effectively obtained from ξ' corresponding to B by replacing occurrences of atomic formulas in ξ' with the following formulas depending on their type:

$$heta_{\top} = \top \qquad heta_{\perp} = \bot \qquad heta_{D(\mathbf{n})} = \mathbb{V}_{(n,v) \in \Gamma_e} \bigwedge_{m \in D_v} D(\mathbf{m}).$$

An easy induction shows that $\xi \in \Pi^p_\alpha$ if and only if $\xi' \in \Pi^p_\alpha$ for $\alpha > 1$ and that $Mod(\xi) = \Gamma^{-1}_e(\xi')$. We obtained ξ effectively from ξ' . Thus, if $B = Mod(\xi')$ is Π^0_α , so is $\Gamma^{-1}_e(B) = Mod(\xi)$. A similar argument works for Σ^p_α formulas. To complete the proof of the theorem use Theorem 3.12 to obtain ξ' from φ' and then use Theorem 3.11 to obtain φ from ξ such that $Mod(\varphi)$ is equal to $\Gamma^{-1}_e(B)$ within K.

§5. An application. In this section, we give a simple application of the Pullback theorem which illuminates the difference between Turing and enumeration operators.

DEFINITION 5.1 [16]. For a structure \mathcal{A} , let $\tilde{\mathcal{A}}$ be a structure with a new congruence relation \sim such that:

- a) the \sim -class for each element in $\tilde{\mathcal{A}}$ is infinite;
- b) $\tilde{\mathcal{A}}/_{\sim} \cong \mathcal{A}$.

For a class K, let $\tilde{K} = {\tilde{A} \mid A \in K}$.

Intuitively, if K is in a relational vocabulary, then the isomorphism types in the class \tilde{K} are obtained from K by replacing each element a in the universe of $A \in K$ by infinitely many elements $(i_a)_{i \in \omega}$ and introducing a binary relation \sim to the language such that $i_x \sim i_y$ if and only if x = y. For example, if we are given an order type L, then \tilde{L} is a quasi-order with $x \sim y$ if and only if $x \leq y$ and $y \leq x$ where each \sim -class is infinite.

It is not difficult to see that we always have $\tilde{\mathcal{K}} \equiv_{tc} \mathcal{K}$, $\mathcal{K} \leq_c \tilde{\mathcal{K}}$, and $\tilde{\tilde{\mathcal{K}}} \leq_c \tilde{\mathcal{K}}$. More generally, for any two classes of structures \mathcal{K}_0 and \mathcal{K}_1 , we have the following implications:

$$\mathcal{K}_0 \leq_c \mathcal{K}_1 \implies \tilde{\mathcal{K}}_0 \leq_c \tilde{\mathcal{K}}_1 \implies \mathcal{K}_0 \leq_{tc} \mathcal{K}_1.$$

We will give examples of classes of linear orderings such that the converse of these implications does not hold. Let **n** denote the finite order type of size n for $n \in \omega$, and given any preorder \mathcal{A} , let \mathcal{A}^* be the structure obtained by reversing the order, i.e., if $x \leq^{\mathcal{A}} y$, then $y \leq^{\mathcal{A}^*} x$. To see that the second implication is strict consider the classes $\mathcal{K}_0 = \{1, 2\}$ and $\mathcal{K}_1 = \{\omega, \omega^*\}$. It is easy to see that $\mathcal{K}_0 \leq_{tc} \mathcal{K}_1$, but the monotonicity of enumeration operators gives us that $\tilde{\mathcal{K}}_0 \nleq_c \tilde{\mathcal{K}}_1$ because $\tilde{\mathbf{1}}$ is a substructure of $\tilde{\mathbf{2}}$, but $\tilde{\omega}$ is *not* a substructure of $\tilde{\omega}^*$.

Kalimullin [16] built a class K of finite undirected graphs such that $\tilde{K} \not\leq_c K$. This shows that the first implication is strict as we always have $\tilde{K} \leq_c \tilde{K}$. Since the example in the class of graphs is somewhat artificial, Kalimullin asked the following question.

QUESTION 5.2 (Kalimullin). Are there natural classes of structures K such that

$$\tilde{\mathcal{K}} \not\leq_c \mathcal{K}$$
?

THEOREM 5.3 (Ganchev–Kalimullin–Vatev [16]). Let $K = \{\omega_S, \omega_S^*\}$ be the class of strict linear orderings of types ω and ω^* , equipped with the successor relation. Then $\tilde{K} \not\leq_c K$.

Interestingly, it is not known whether $\{\tilde{\omega}, \tilde{\omega}^*\} \not\leq_c \{\omega, \omega^*\}$, where $\{\omega, \omega^*\}$ is the class of *strict* linear orderings of types ω and ω^* . Nevertheless, if we let $\{\omega, \omega^*\}$ be the class of linear orderings of order type ω and ω^* in the vocabulary $\leq, =, \neq$, then we can apply our new version of the Pullback Theorem and show that $\{\tilde{\omega}, \tilde{\omega}^*\} \not\leq_{pc} \{\omega, \omega^*\}$. For \mathcal{A} a linear ordering, the congruence relation $x \sim y$ in $\tilde{\mathcal{A}}$ is definable by the Σ_0^p formula $x \leq y \land y \leq x$, and, thus, we may omit \sim from the vocabulary.

For a class of formulas C (e.g., Σ_0^p and Π_1^p), a structure A, and a tuple \bar{a} in A, define C- $Th_A(\bar{a}) = \{\xi(\bar{x}) \in C \mid A \models \xi(\bar{a})\}$. If the tuple \bar{a} is empty, we will write C- Th_A .

The next proposition isolates the key property that the class $\{\tilde{\omega}, \tilde{\omega}^*\}$ possess which will allow us to show that $\{\tilde{\omega}, \tilde{\omega}^*\} \not\leq_{pc} \{\omega, \omega^*\}$.

PROPOSITION 5.4. Let \mathcal{A} and \mathcal{B} be linear orderings in the vocabulary \leq , =, \neq . For any tuple \bar{a} in $\tilde{\mathcal{A}}$ and any tuple \bar{b} in $\tilde{\mathcal{B}}$, if Σ_0^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) = \Sigma_0^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$, then Σ_1^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) = \Sigma_1^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$.

PROOF. It is enough to show that Σ_1^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) \subseteq \Sigma_1^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$. Consider a formula $\varphi(\bar{x}) = \mathbb{W}_{i \in W_e} \exists \bar{x}_i \xi_i(\bar{x}, \bar{x}_i)$, where $\xi_i(\bar{x}, \bar{x}_i)$ are Σ_0^{pc} . Suppose $\tilde{\mathcal{A}} \models \varphi(\bar{a})$. Fix $i \in W_e$ and a tuple \bar{a}' in $\tilde{\mathcal{A}}$ such that $\tilde{\mathcal{A}} \models \xi_i(\bar{a}, \bar{a}')$.

Since Σ_0^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) = \Sigma_0^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$, we know that \bar{a} and \bar{b} are ordered in the same way. Without loss of generality, suppose \bar{a} and \bar{b} have length n and $\tilde{\mathcal{A}} \models a_0 \leq a_1 \leq \cdots \leq a_{n-1}$ and similarly, $\tilde{\mathcal{B}} \models b_0 \leq b_1 \leq \cdots \leq b_{n-1}$. We consider two cases which show how we find the tuple \bar{b}' which makes $\xi_i(\bar{b},\bar{b}')$ true in $\tilde{\mathcal{B}}$. In both cases we use the fact that each \sim -class is infinite.

Suppose that for some a'_j from the tuple \bar{a}' , $\tilde{\mathcal{A}} \models a_i \leq a'_j \leq a_{i+1}$. The interesting case is when a'_j is in a separate \sim -class from a_i and a_{i+1} , but b_{i+1} belongs to the successor \sim -class of b_i in $\tilde{\mathcal{B}}$. Then we choose the corresponding element b'_j as an element \sim -equivalent to b_i or b_{i+1} . In this way, $\tilde{\mathcal{B}} \models b_i \leq b'_j \leq b_{i+1}$.

Similarly, suppose that for some a'_j from the tuple \bar{a}' , $\tilde{\mathcal{A}} \models a_{n-1} \leq a'_j$, but b_{n-1} belongs to the \leq -greatest \sim -class in $\tilde{\mathcal{B}}$. Then, again, we choose the corresponding b'_j as an element \sim -equivalent to b_{n-1} .

Notice that Proposition 5.4 does not hold if we consider *strict* linear orderings \mathcal{A} and \mathcal{B} and it does not hold for the class $\{\tilde{\omega}, \tilde{\omega}^*\}$ if the vocabulary under consideration is $<, =, \neq$.

LEMMA 5.5. Let A and B be linear orderings in the vocabulary \leq , =, \neq . Then

$$\Sigma_2^{pc}$$
- $Th_{\tilde{\mathcal{A}}} = \Sigma_2^{pc}$ - $Th_{\tilde{\mathcal{B}}}$.

PROOF. It is enough to show that Σ_2^{pc} - $Th_{\tilde{\mathcal{A}}} \subseteq \Sigma_2^{pc}$ - $Th_{\tilde{\mathcal{B}}}$. Consider a Σ_2^{pc} sentence φ such that

$$\varphi = \mathbb{W}_{i \in W_e} \exists \bar{x}_i (\xi_i(\bar{x}_i) \land neg(\psi_i(\bar{x}_i)),$$

where $\xi_i(\bar{x}_i)$ and $\psi_i(\bar{x}_i)$ are Σ_1^p formulas. Fix $i \in W_a$ and a tuple \bar{a} in $\tilde{\mathcal{A}}$ such that $\tilde{\mathcal{A}} \models \xi_i(\bar{a}) \land neg(\psi_i(\bar{a}))$.

Since every \sim -class contains infinitely many elements, it is easy to see that we can choose a tuple \bar{b} in $\tilde{\mathcal{B}}$ such that Σ_0^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) = \Sigma_0^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$. But then by Proposition 5.4, Σ_1^{pc} - $Th_{\tilde{\mathcal{A}}}(\bar{a}) = \Sigma_1^{pc}$ - $Th_{\tilde{\mathcal{B}}}(\bar{b})$. It follows that $\tilde{\mathcal{A}} \models \xi_i(\bar{b}) \land neg(\psi_i(\bar{b}))$ and hence $\tilde{\mathcal{B}} \models \varphi$.

Theorem 5.6. $\{\tilde{\omega}, \tilde{\omega}^{\star}\} \not\leq_{pc} \{\omega, \omega^{\star}\}.$

PROOF. Consider the Σ_2^{pc} sentences

$$\varphi_0 = \exists x \forall y (\neg x \neq y \lor \neg y \leq x)$$

and

$$\varphi_1 = \exists x \forall y (\neg x \neq y \lor \neg x \leq y).$$

It is clear that for any two copies \mathcal{A} and \mathcal{A}^* of ω and ω^* , respectively, $\mathcal{A} \models \varphi_0 \land \varphi_1$ and $\mathcal{A}^* \models \neg \varphi_0 \land \varphi_1$. Notice that we don't use the formulas $\exists x \forall y (x \leq y)$ and $\exists x \forall y (y \leq x)$ since they are Σ_2^{pc} and not Σ_2^{pc} .

 $\exists x \forall y (y \leq x) \text{ since they are } \Sigma_3^{pc} \text{ and not } \Sigma_2^{pc}.$ If we assume that $\{\tilde{\omega}, \tilde{\omega}^*\} \leq_{pc} \{\omega, \omega^*\}$, by the Pullback Theorem, there must be Σ_2^{pc} sentences $\tilde{\varphi}_0$ and $\tilde{\varphi}_1$ such that for any two copies $\tilde{\mathcal{A}}$ and $\tilde{\mathcal{A}}^*$ of $\tilde{\omega}$ and $\tilde{\omega}^*$, respectively, $\tilde{\mathcal{A}} \models \tilde{\varphi}_0 \land \neg \tilde{\varphi}_1$ and $\tilde{\mathcal{A}}^* \models \neg \tilde{\varphi}_0 \land \tilde{\varphi}_1$. But this contradicts Lemma 5.5.
