
Notes on Contributors

Kim Christiaens is Director of KADOC-KU Leuven, the Documentation and Research Centre for Religion, Culture and Society (1750–present) at Leuven University (Belgium). His research and publications focus on various aspects of Europe's transnational history during the post-war period, including the impact of decolonisation, the transformation of internationalisms and the rise of human rights and international solidarity movements during the Cold War, with an orientation towards the Third World (Latin America, anti-Apartheid and Vietnam) and Eastern Europe (peace movements and Solidarność). He has recently published articles in journals such as *European Review of History*, *Dutch Crossing*, *Archiv für Sozialgeschichte* and *Journal of Contemporary History*.

José M. Faraldo is Assistant Professor (former Profesor Investigador Ramón y Cajal) at the Complutense University of Madrid. After further studies in history and cultural studies in Moscow, Frankfurt/Oder and Poznań he worked from 1997 to 2002 at the European University Viadrina, in Frankfurt/Oder (Germany). From 2004 to 2008 he was research fellow and project coordinator at the Center of Research on Contemporary History, (ZZF), in Potsdam (Germany). Faraldo has researched extensively on communism, nationalism, European unity, visual and popular culture in former communist countries and comparative history of fascism and communism, with special attention to resistance. His last project was a history of the archives of communist secret police in Eastern Europe, focusing on the Soviet, East German, Polish and Rumanian cases and in the impact of these archives on private life. José obtained in 2011 the Spanish *Habilitation* for tenure of the ANECA (Spanish central state agency for Scholar Evaluation). In 2013 he received the 'Evaluación programa I3', special evaluation of the Spanish Ministry of Research for distinguished researchers. He has been member of the Steering Committee for Humanities of the European Science Foundation (Strasbourg).

Max Holleran is an urban and historical sociologist and Lecturer in sociology at the University of Melbourne. His dissertation is a study of coastal urbanisation for tourism in post-Franco Spain and post-socialist Bulgaria. He has also researched post-socialist urban planning, gentrification in US cities and architectural aesthetics.

His work has been published in anthropology, sociology, and history journals, including *The British Journal of Sociology*, *City & Society* and *Radical History Review*. He has also written for *Dissent*, *The New Republic*, *Boston Review*, *Slate*, *Public Books*, *Contexts*, *The Avery Review* and *OpenDemocracy*.

James Mark has worked in the History Department at Exeter since 2004. His research addresses the social and cultural history of state socialism in central-eastern Europe, as well as the politics of memory in the area during both socialism and post-socialism, and aims to connect the region to broader global histories and processes through transnational and comparative methods. His first book *The Unfinished Revolution: Making Sense of the Communist Past in Central-Eastern Europe* (Yale: 2010) was shortlisted for the 2011 Longman History Today Book Prize, and chosen as one of the 'best books of 2011' by *Foreign Affairs*. His second book is *Europe's 1968: Voices of Revolt* (OUP, 2013). He is currently working on a book (with Dr. Péter Apor) on the impact of the politics of decolonisation, peaceful co-existence, anti-imperialism and market socialism on official and nonconformist cultures of late socialist Hungary, and is editing a collection *Between Decolonisation and the Cold War: Transnational Activism and Its Limits in Europe 1950s–1990s* (with Dr. Maud Bracke).

Pavel Szobi (1983) holds an MA and PhD in History from the Charles University in Prague and is a research associate at the Institute of Technology and Business in České Budějovice. He specializes in history of Czechoslovakia after 1945 and history of the Eastern Bloc.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
