Manuel Pedro Ferreira was educated at Lisbon and at Princeton University, where he wrote his Ph.D. dissertation on Gregorian Chant at Cluny under Kenneth Levy's direction. He teaches in the Music Sciences Department of the Faculdade de Ciências Sociais e Humanas, Universidade Nova de Lisboa (FCSH-UNL), and has chaired the Music Sociology and Aesthetics Research Centre (CESEM) at FCSH-UNL since 2005. In 1995 he founded the early music ensemble, *Vozes Alfonsinas*, which he still directs.

Jason Stoessel is Adjunct Research Fellow in the School of Arts, University of New England, Australia. In 2013 he was Balzan Programme in Musicology research visitor in the Faculty of Music, University of Oxford, and in 2014–15 Associate Investigator with the Australian Research Council's Centre of Excellence for the History of Emotions. An Australian Research Council Discovery Grant (DP150102135) supports his research on canonic techniques and musical change in late medieval music. His publications on late medieval music and culture, music and humanism in early fifteenth-century Padua, and digital musicology have appeared in international fora in numerous journals and book chapters.

Nicola Tangari is a researcher at the University of Cassino and Associate Professor of Musicology at the Pontifical Institute of Sacred Music in Rome. His areas of research are computer applications to musicology (*La codifica delle note*, Rome 1996; *Documentazione musicale e informatica*, Galatina 2005), music bibliography and librarianship (*Standard e documenti musicali. I numeri, i modelli e i formati*, Milan, 2002), the sources of liturgical music (*Musica avvolgente*, Rieti 2014; *Musica e liturgia a Montecassino*, Rome 2012, as editor).
