

Greece and the Law of the Sea

This book reviews the main developments in the Greek Turkish dispute relating to the Greek islands in the Aegean Sea, and analyzes all other aspects of the Greek maritime interests in the light of the United Nations Convention on the Law of the Sea, which came into force in November 1994.

The contributors have followed closely the creation of the new international law of the sea and discuss in their papers how this affects a great maritime nation, such as Greece, in a variety of ways.

The work is published under the auspices of the recently established Aegean Institute of the Law of the Sea and Maritime Law, an independent scientific research center affiliated with the University of the Aegean, located in Rhodes.


