RONALD L. AKERS is an Assistant Professor of Sociology at the University of Washington. He is the author of numerous articles and has delivered papers at Conferences of the American Sociological Association, the Pacific Sociological Association and the Society for the Scientific Study of Social Problems. His primary interest is in deviant behavior, criminology, and delinquency.

CARL A. AUERBACH is Professor of Law at the University of Minnesota Law School. He is a member-at-large of the Division of Behavioral Sciences of the National Research Council and a member of the President's Commission on Marine Science, Engineering and Resources. His main concern on the latter is to explore ways and means of exploiting the oceans for the benefit of mankind. He is co-author of *The Legal Process—An Introduction to Decision-Making by Judicial, Legislative, Executive and Administrative Agencies* and of *The Federal Regulation of Transportation*.

SELDEN D. BACON is Professor of Sociology and Director of the Center of Alcohol Studies at Rutgers. He has been a member of numerous Committees on Alcoholism and is Program Chairman for the forthcoming International Congress on Alcohol and Alcoholism. He is the co-author of *Drinking in College*, and has published in a wide range of journals.

JOHANNES FEEST is presently employed as research sociologist with the Institut für Ausbildungs-forschung (Institute for Research in Education), Munich, working on problems of professional education. He is a lawyer by his German education and a sociologist by his American education, and is particularly interested in sociolegal research. He has published a study on the higher echelons of the West German judiciary and is at present preparing a study of socialization into the legal profession.

JACK P. GIBBS is Professor of Sociology at the University of Texas at Austin. He is author of numerous articles and his main interests are human ecology, deviant behavior, social control, and the sociology of law.

WALTER F. MURPHY is Chairman of the Department of Politics at Princeton University. He is the author of numerous publications including *Congress and the Court*, *Elements of Judicial Strategy*, and *Wiretapping on Trial*. He is an editorial board member of the *American Political Science Review*. In 1958 he won the American Political Science Association's Binkhead Award for a doctoral dissertation. He is an advisor to the U.S. Civil Rights Commission.

H. LAWRENCE ROSS is a Professor of Sociology and Law at the University of Denver. He teaches a seminar on negotiation and is spending most of his time preparing a manuscript on the negotiation of tort claims by insurance adjusters. His other interests are urban sociology and social deviance, particularly the study of drug use and sex deviance.

GLENDON SCHUBERT is a Professor of Political Science at the University of North Carolina. He has been a leader in the development of empirical research on judicial behavior. Among his best known works are *Judicial Behavior: A Reader in Theory and Research*, *Judicial Policy Making*, and *The Political Role of the Courts*. He has a forthcoming book entitled *Dispassionate Justice: A Synthesis of the Judicial Opinions of Robert Jackson*. He is currently engaged in cross-polity studies of judicial decision-making.

EDWIN M. SCHUR is Professor and Chairman of the Department of Sociology at Tufts University. A specialist in the sociology of law, deviance, and criminology, he has written *Narcotic Addiction in Britain and America*; *The Impact of Public Policy and Crimes Without Victims*; *Deviant Behavior and Public Policy—Abortion, Drug Addiction, Homosexuality*, and edited *The Family and the Sexual Revolution: Selected Readings*. He is an Associate Editor of the *American Sociological Review*.

JOSEPH TANENHAUS is a Professor of Political Science at the University of Iowa. He is a member of the editorial board of the *Midwest Journal of Political Science* and the *International Encyclopedia of the Social Sciences*. He has co-authored several books on American Political Science and is co-editor of a forthcoming one entitled *Frontiers of Judicial Research*. His main field of specialization is public law and the judicial process.

HOWARD J. WIARDA is an Assistant Professor of Government at the University of Massachusetts. He has published a number of articles on political development in Latin America and is author of two forthcoming monographs on the political system of the Dominican Republic.
