BRAZIL AND ITS RADICAL LEFT: AN ANNOTATED BIBLIOGRAPHY ON THE COMMUNIST MOVEMENT AND THE RISE OF MARXISM, 1922-1972 is the first book-length bibliography covering the Brazilian Communist party and the socialist, anarchist and Trotskyist currents that were present during the fifty years that followed the founding of the party. It provides access to the information contained in hundreds of newspapers and journals, books, memoirs and governmental and non-governmental documents.

This annotated work is arranged in three parts. Part one identifies books, pamphlets, memoirs, descriptive accounts and documents—many from the Communist party—reflecting the evolution of leftist thinking in Brazil. Part two cites articles written for periodicals; the emphasis is on English, Portuguese and Spanish language publications including the Communist newspapers FOLHA DO POVO and A HORA. Part three contains a comprehensive list of radical periodicals giving their locations in libraries and archives, followed by an index to the cited periodicals which is arranged according to language of publication. Explanatory remarks introduce each section of the book and a full subject index to the 3000 entries is included.

BRAZIL AND ITS RADICAL LEFT is an essential reference tool for students of Latin American history and politics, for scholars examining social movements in Brazil and for those researching radicals and the radical movement in general.

THE JAMAICAN NATIONAL BIBLIOGRAPHY, 1964-1974

This handy, one-volume work is an indispensable tool for researchers in the fields relating to Caribbeana. Not merely a catalogue of a single reference collection, it serves as a union list of the holdings of three major centers of higher learning in Jamaica and the British Caribbean: the Institute of Jamaica, the Jamaica Library Service and the University of the West Indies at Mona. The present edition merges the catalogue cards of the three libraries for the years 1971-1974 with the contents of an earlier edition published by the Institute of Jamaica, covering the years 1964-1970. The result is a new, ten-year cumulation, 1964-1974.

More than 3,300 entries, arranged according to subject and representing the books, pamphlets, articles, extracts, many types of government publications, and microforms in the collections, comprise the major portion of the **Bibliography**. The library location of each item is indicated. Maps and manuscripts are cited in separate sections and there are two lists of the Jamaican periodicals in the libraries' holdings, one arranged alphabetically by title and one by subject. A comprehensive author and title index is provided.

THE POLITICS OF NATIONALIZATION

Paul E. Sigmund

A TWENTIETH CENTURY FUND STUDY

The rapid increase in the number of nationalizations of foreign-owned concerns in Asia, Africa, and Latin America in recent years had led some observers to predict the impending demise of the multinational corporation in the Third World. Attempting to slow this trend, the U.S. government has used its diplomatic influence to defend American-based multinationals and the Congress has passed legislation aimed at deterring the expropriation of U.S.-owned companies. In this new book, Paul E. Sigmund challenges the notion of a rising tide of nationalization, arguing that, in Latin America at least, most of the exposed enclaves in the extractive industries that were the major targets of the economic nationalists have now been taken over, removing the major irritants affecting the relations of Third World governments with foreign investors. Instead of the previous conflict relationship, he perceives the beginnings of a new era of bargaining between Third World governments and foreign investors, in which there is a diminished role for the U.S. government and a mutual recognition by investors and host governments of the benefits to be secured by a bargaining relationship. Professor Sigmund's study makes a major theoretical contribution to the understanding of inter-American relations, providing insights which will be of interest to students of U.S. foreign policy, Latin-American studies, and economic development, as well as to business people involved in foreign investment.

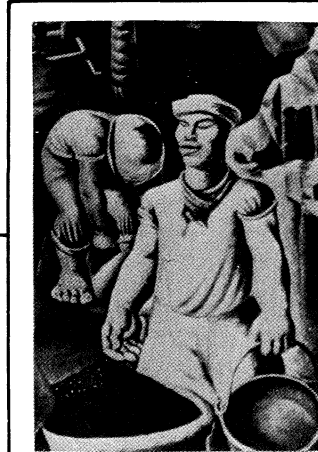

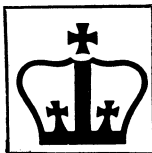
