Vincent J. Browne

Vincent J. Browne is a professor of political science and chairman of the political science department at Howard University. He received his Ph.D. from Harvard University. He has also served as Dean of the College of Liberal Arts at Howard University.

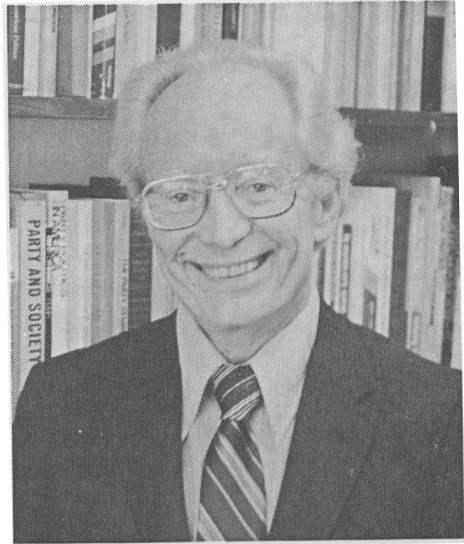
Browne's books, articles, and reports have covered such topics as: control of the public budget, civil defense, racial desegregation in public service, economic development in Liberia, natural disaster relief, and elimination of segregation by executive order. His writings have appeared in *The Journal of Negro Education*, *Public Management*, and a number of government publications.

James W. Prothro

This year James W. Prothro is being posthumously honored by the committee. He received his Ph.D. from Princeton University in 1952. At the time of his death in February of this year, he had just completed a term as chairman of the Department of Political Science at the University of North Carolina-Chapel Hill and was on leave preparing a grant proposal with a colleague. The intent was to restudy after 25 years some of the communities that had been analyzed in *Negroes and the New Southern Politics*, a book he published in 1966 with Donald Matthews, which analyzed southern politics and particularly black political participation.

Many doctoral students studied with James Prothro, and a considerable number of them are now leaders in the profession. He had a profound influence on these men and women, providing for them an excellent role model for the development of their professional careers.

This year's honorees will join the ranks of the other prominent political scientists recognized by the Committee on the Status of Blacks in the Profession: Twiley

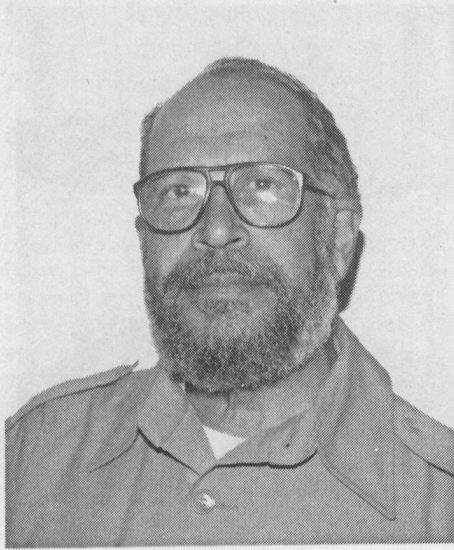

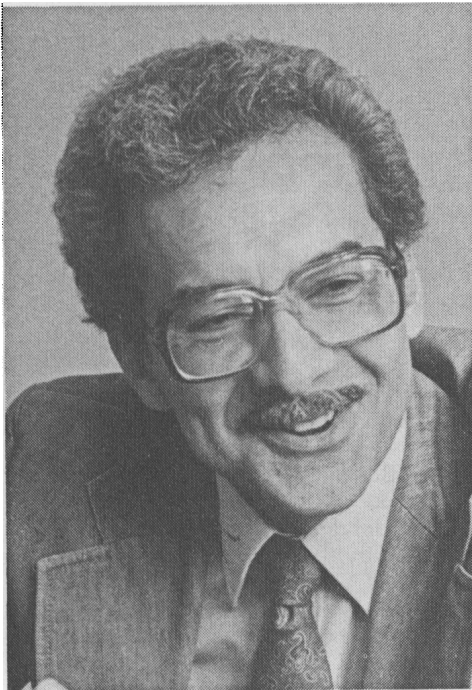

Frank Bonilla

Frank Bonilla is a professor of political science and director of the Center for Puerto Rican Studies at Hunter College of CUNY. He received his Ph.D. in sociology from Harvard University in 1959. Bonilla has taught at Stanford University and the Massachusetts Institute of Technology.

Bonilla's publications include: *A Strategy for Research on Social Policy* (co-editor with Jose A. Silva Michelena), *Labor Migration under Capitalism: The Puerto Rican Experience* (co-author as part of History Task Force, CUNY Center for Puerto Rican Studies), and *Foreign Elites in the Formation of the Venezuelan Economy*. His published articles have appeared in *Latin American Perspectives*, *La Revista*, *Migration Today* and *Daedalus*.

Herman D. Lujan, the other honoree, is currently vice-president for Minority Affairs and is a professor of political science at the University of Washington. He received his Ph.D. from the University of Idaho in 1964. His previously held positions include: director of the Office of Program Coordination at the University of Kansas, chairman of the Department of Political Science at the University of Kansas, and director of the Division of State Planning and Research for the State of Kansas.

Lujan's published articles have appeared in *Legislators and the Legislative Process*, *Comparative Politics*, the *American Journal of Political Science*, the *Rocky Mountain Social Science Journal*, and *Your Government*. His current research includes a book-length manuscript on traditional Hawaiian values in modern life (now under review) and a longitudinal study of minority students from 1976-83 in a university setting. □
