



# Association News

## Election Results

### The American Political Science Association Election of Officers and Council Members, 1969

The election was administered by the American Arbitration Association. The AAA, on October 3, 1969, mailed out 7771 ballots to regular members, 5290 to student members; a total of 13,061. The ballots were counted on November 10, 1969. The AAA Report of the results is set forth below. Those elected are marked with a star.

Pursuant to a request from the American Political Science Association, hereinafter referred to as APSA, the American Arbitration Association, hereinafter referred to as the Administrator, agreed to conduct a mail ballot for the election of officers.

This election was conducted pursuant to and in accordance with the Election Rules of the Administrator.

Ballots were mailed by the Administrator to all eligible members of APSA on October 3, 1969. To be valid, ballots had to be postmarked no later than November 3, 1969.

The counting of the ballots took place in the office of the Administrator at 140 West 51st Street, New York City on November 10, 1969, under the supervision of the undersigned in the presence of an observer and two members of the Election Committee. The secrecy of the ballot was maintained at all times.

Eight Thousand Four Hundred and Sixty-One (8,461) ballots were received by the Administrator One Hundred and Thirty-Seven (137) envelopes were void on the following basis:

- 58 No identification on envelope
- 55 No signature on return envelope
- 7 Numbered return envelope issued to another voter
- 2 Duplicates
- 15 Late postmark

A recount of votes for Profs. Kariel and Lipsitz did not change the outcome of the election.
