JAMES BROOKS, Assistant Professor of Political Science at New Mexico State University at Las Cruces, received his Ph.D from the University of Oklahoma in 1972. He has published "Choosing an Agency to Administer a Crime Compensation Program," *State Government Administration*, March/April, 1972. He is currently conducting research related to the attitudes of crime victims, making comparisons between the preferences of program administrators and academic analysts regarding program features and surveying ex-convict rehabilitation concepts and practices.

RICK J. CARLSON is currently a Visiting Fellow at the Center for the Study of Democratic Institutions at Santa Barbara, California. While a research attorney at the Institute for Interdisciplinary Studies in Minneapolis, he also taught a seminar entitled "The Law and the Delivery of Health Care" at the School of Dentistry of the University of Minnesota. Recent articles include: "Malpractice Suits: Is the End in Sight?" *Medical Economics*, June 7, 1971; "The Legal Context for the Development of Health Maintenance Organizations" (with Robert Holley), *Stanford Law Review*, April, 1972; and "Health in America," *The Center Magazine*, November/December, 1972. Carlson, also with Robert Holley and Patrick O'Donoghue, has prepared a draft no-fault malpractice bill for the Idaho State Legislature.

MALCOLM M. FEELEY, Russell Sage Fellow at Yale Law School, received his Ph.D. in Political Science from the University of Minnesota in 1969. His current research interests are problems of compliance in the administration of justice. His works include: "Coercion and Compliance: A New Look at an Old Problem," *Law & Society Review*, Spring, 1970; "Another Look at the Party Variable in Judicial Decision-Making," *Polity*, Autumn, 1971; and a paper presented to the 1972 annual meetings of the Public Choice Society entitled "A Solution to the 'Voting Dilemma' in Modern Democratic Theory." With Theodore L. Becker, he has co-edited *The Impact of Supreme Court Decisions*.

FRANK F. FURSTENBERG, JR. is Associate Professor of Sociology at the University of Pennsylvania. His 1967 Columbia University Ph.D. dissertation was entitled *Transmission of Social Attitudes in the Family*. He is co-editor of *On the Family, Education, and War: Willard W. Waller*, University of Chicago

Press, 1970, and the author of several articles, including: "Preventing Unwanted Pregnancies Among Adolescents," *Journal of Health and Social Behavior*, December, 1971; "Birth Control Experience Among Pregnant Adolescents: The Process of Unplanned Parenthood," *Social Problems*, Fall, 1971; and "Fear of Crime and Its Effects on Citizen Behavior," to be published in *Studies of Public Experience, Knowledge and Opinion of Crime and Justice*, edited by Albert D. Biderman.

RICHARD HAWKINS is an Assistant Professor of Sociology at Southern Methodist University where he is coordinator of a new undergraduate program in Criminal Justice. His areas of interest are sociology of law, societal reactions to deviance, with emphasis on labeling theory and victimization studies. He is co-editor of a forthcoming book in sociology of law, *Law and Control in Society*, from Prentice-Hall. He is also the co-author of a book due next year, *The Creation of Deviance*, from Merril Publishing.

JOSEPH W. LITTLE is a professor of Law at the University of Florida. Little, who received his J.D. from the University of Michigan, is a consultant for the University of Michigan Highway Safety Research Institute. He has worked on highway safety topics for several years and is currently doing an impact study of Florida's no-fault insurance law under sponsorship of the Council on Law-Related Studies, Cambridge, Massachusetts.

CHARLES H. LOGAN is Assistant Professor at the University of Connecticut. He received a Ph.D. in Sociology, with a minor in law from Indiana University in 1971. Articles published include: "Evaluation Research in Crime and Delinquency: A Re-Appraisal," *Journal of Criminal Law, Criminology and Police Science*, September, 1972; and "General Deterrent Effects of Imprisonment," *Social Forces*, September, 1972. Current research interests include deterrence and evaluation research.

EUGENE F. MILLER is Associate Professor of Political Science at the University of Georgia. His primary area of interest is political philosophy, with an emphasis on the epistemological foundations of political inquiry. His publications include "Positivism, Historicism, and Political Inquiry," *American Political Science Review*, September, 1972; "David Easton's Political Theory," *The Political Science Reviewer*, Fall, 1971; and "Hume's Contribution to Behavioral Science," *Journal of the History of the Behavioral Sciences*, April, 1971.

CHARLES R. TITTLE is Associate Professor of Sociology at Florida Atlantic University. He received a Ph.D. in 1965 from the University of Texas at Austin. He has published a book, *Society of Subordinates: Inmates Organization in a Narcotic Hospital*, several articles, and a chapter, "The Prisons," in *Social Control* edited by Peter K. Manning. He is currently most involved in a large NSF funded study of the effect of sanctions in deterring various kinds of deviance from social norms. Secondary interests include research methodology, particularly measurement problems, and the social organization of subordinate groups, particularly prisoners.

CHARLES F. WELLFORD is Associate Professor in the Department of Criminology at Florida State University. He received his Ph.D. in Sociology from the University of Pennsylvania. Formerly with the National Institute of Law Enforcement and Criminal Justice, he is currently working on a Police Foundation funded project involving the deterrent effect of police manpower. His research interests include the application of mathematical models to the issue of crime causation. He has authored several articles including the forthcoming "Age Composition and Patterns of Recorded Crime" in the journal *Criminology*.
