To colonized peoples, the nation has become the ideal of, and the means towards, an utterly new, entirely better condition. Amongst very many peoples, not merely colonized ones, circumstances will rather easily occur under which individuals are willing and often also expected to lay down their lives for the benefit of the nation.

The author of this study has attempted to understand and explain the fact that the nation can, and actually does, exert an appeal that will induce people to astounding efforts and at times to extreme sacrifices. To this purpose, he has approached his chosen subject from three different sides. First, he has reconsidered the nation, both as a concept and as an actual phenomenon, in an unusual and rewarding combination of sociological and culture-historical analysis.
