EDWARD N. BEISER is Assistant Professor of Political Science at Brown University. Among the articles he has published is "A Comparative Analysis of State and Federal Judicial Behavior: The Reapportionment Cases," which appeared in the *American Political Science Review* in 1968. Among his areas of major interest are judicial behavior, constitutional law, and civil liberties.
