In this study the author stresses the importance of the recognition of a plurality of languages and the role of reference in meaning. He explores the problems of truth and reference in Phenomenalism and Dualism, concluding that these two ontologies have their own rules of reference and conditions of truth; they can be understood only from the inside, but it is possible to adopt a mutual metaphilosophical stance from which to study and compare them. This stimulating review explores many other topics to provide a valuable contribution in the field of metaphysics.
