PUBLISHING AND SUBSCRIPTION INFORMATION

Environmental Conservation is published by Elsevier Sequoia S.A., Lausanne, for the Foundation for Environmental Conservation, with the collaboration of the International Union for Conservation of Nature and Natural Resources (IUCN), International Association for Ecology (INTECOL), International Conferences on Environmental Future (ICEF), World Environment and Resources Council (WERC), World Wildlife Fund (WWF), and others. It is covered in about twelve international contents and abstracting journals emanating from Great Britain, the United States, Italy, and West Germany.

Environmental Conservation is published quarterly, corresponding to the four seasons in the Northern Hemisphere. Size 28 × 20 cm, comprising 320 pages of text per annum (which it is hoped soon to extend). The annual subscription price for 1976 and 1977 continues at SFrs 120 (including postage) per volume.
