JOHN O. HALEY is Associate Dean and Professor at the University of Washington School of Law in Seattle. He is a graduate of Princeton University, Yale Law School, and the University of Washington's Asian Law Program. His principal area of interest in teaching and research relates to Japan, where he lived for over five years. From 1964 to 1966 he taught at the International Christian University under a Princeton-in-Asia Fellowship. He returned to Japan in 1971 for one year as a Fulbright-Hays Senior Research Scholar at Kyoto University and remained until October 1974 with the Tokyo law firm of Blakemore and Mitsuki. In October 1984 he was Visiting Professor at Kobe University in Japan. He is editor of Law in Japan: An Annual and has written numerous articles on Japanese law that explore the role of litigation and the judiciary in modern Japan. He is currently a Visiting Professor at the Harvard Law School.

RICHARD HAWKINS is Associate Professor of Sociology at Southern Methodist University in Dallas. He has published articles on the medicalization of deviance, court processing of mental illness petitions, and employee theft in restaurants; his paper on the reasons for the sociological neglect of the automobile as a research topic is scheduled for publication in 1986.

EDWIN M. LEMERT is Professor Emeritus of Sociology, University of California at Davis. He is the author of Social Pathology (1951), Human Deviance, Social Problems and Social Control (1972), Social Action and Legal Change (1970), and (with Forrest Dill) Offenders in the Community (1978).

ARTHUR ROSETT is Professor of Law at the University of California, Los Angeles. His current interests are in contract law and comparative law, particularly Asian legal systems. He is co-author with Elliot Dorff of *A Living Tree*, a comparative law examination of the Rabbinic legal tradition, scheduled for publication in 1987 by the Jewish Theological Seminary and the State University of New York Press.

DAVID M. TRUBEK is Voss-Bascom Professor of Law and Director of the Institute for Legal Studies at the University of Wisconsin-Madison. Formerly Director of the Civil Litigation Research Project, he has written on civil justice and dispute processing, legal services and public interest law, and critical legal studies.

HIROSHI WAGATSUMA was Professor of Cultural Anthropology of the Tokyo Institute of Technology at the time of his death in July 1985. Before returning to Japan in 1980, he lived in the United States for many years and taught at a number of American universities, most notably as Professor of Anthropology at the University of California, Los Angeles, and the University of Pittsburgh. His many publications emphasized his longstanding interest in the treatment of minority groups in Japan and Japanese social psychology.
