Probably the finest collection of books and other primary sources for the history of Western Europe compiled by one individual, Syracuse University's Ranke collection includes 430 manuscripts and miscellaneous private papers and letters. The manuscript collection is the first part of the collection to be completely catalogued. It contains copies of material from the 14th to 18th century preserved in Italian archives. At the core of the collection are more than 100 dispatches (*Relazioni*) from Venetian ambassadors written from 1500 to 1800. They constitute one of the largest collections in the U.S. of original manuscript material for the political and diplomatic history of early modern Italy.

Censorship and Interpretation

THE CONDITIONS OF WRITING AND READING IN EARLY MODERN ENGLAND

Annabel Patterson

Modern western critics, for the most part enjoying maximum intellectual freedom, seldom give adequate attention to the role that censorship played in shaping the works of earlier writers. In a far-ranging and provocative series of essays, Annabel Patterson explores the effects of censorship on both writing and reading in early modern England, drawing both the analogies and the actual connection with France in the same period. The result is an original account of the interpretative and communicative systems that we call culture, which will be of interest not only to students and scholars of Renaissance and seventeenth-century literature, but also to anyone alert to the relationships between politics and art at any time and place.

In early modern Europe, freedom of expression was not taken for granted; rather, it was a major subject of political and intellectual concern. There was, Patterson points out, an implicit social contract between authors and authorities, well understood by both, as to what could be said publicly and what form (genre) it could take. These required codes of communication also had complex psychological effects upon writers, as fear shaded into caution, caution into prudence, and prudence into more self-serving emotions and motives. It is this subtle intersection of state censorship and self-censorship that provides the underlying theme of Patterson's essays, as she explores works by Marot, Sidney, Jonson, Shakespeare, Donne, Marvell, Massinger, Milton, Madeleine de Scudéry, and others, concluding with Jean Jacques Rousseau.
