Socolow examines bureaucrats in early modern society through a study of Buenos Aires under the Bourbon reforms of the late colonial period. This is the first study to consider the entire body of a colonial bureaucracy in a capital city, and not only the highest officials. In addition to theoretical questions on the nature of a bureaucracy, Socolow studies the individuals who held positions in the colonial civil service, their recruitment, aspirations, job tenure, professional advancement, and economic position, as well as marriage and kinship relationships the bureaucrats formed in the local society.
