This book examines the overlap between early modern English attitudes to disease and to society and explores the cultural meaning of the image of the body at the interfaces of medicine, morality and politics in Tudor and early Stuart England. In particular, it demonstrates how the body politic's metaphorical "cankers" and "plagues" were increasingly attributed to allegedly pathological "foreign bodies" such as Jews, Catholics, and witches. One can glimpse the origins of not only modern xenophobic attitudes to foreigners as carriers of disease, but also "germ" theory in general. The pathological and the political thus have a long-standing, problematic, and mostly neglected relationship, the pre-history of which this book seeks to uncover.

**HEBRAICA VERITAS? CHRISTIAN HEBRAISTS, JEWS, AND THE
STUDY OF JUDAISM IN EARLY MODERN EUROPE**

From the fifteenth to the eighteenth century, Christian scholars, sometimes in collaboration with contemporary Jews, played an important role in laying the foundations for the modern study of Judaism. In 1999-2000, the Center for Judaic Studies will study the assumptions, methods, and accomplishments of these remarkable individuals, paying special attention to the political, religious, and intellectual contexts in which they worked and to the often unstated presuppositions that guided them. We hope to reconstruct a vital chapter in the intellectual and cultural history of Western civilization, to shed new light on the complex relations between Jews and Christians, and to identify the origins of lasting tendencies and tensions that still characterize the modern study of Judaism. We will explore such questions as: How did the Christian study of Jewish literature affect perceptions of "Otherness" as well as Christian self-understanding; how did Christian Hebraism relate to the emergence of the modern study of cultural anthropology and comparative religion; and what was its impact on Jews and their self-perceptions? While the seminar will focus primarily on the early modern era, students of this subject in earlier periods (especially the patristic and medieval) are encouraged to apply.

The Center invites applications from scholars engaged in all fields of Judaic studies and from scholars in other fields interested in approaching either of the topics from a comparative and interdisciplinary perspective. Only applications whose research topics fall within the chosen theme will be considered. Outstanding graduate students in the final stages of writing their dissertations may also apply. Stipend amounts are based on a Fellow's academic standing and financial need with a maximum of \$30,000 for the academic year. A contribution may also be made towards travel expenses. Awards will be announced on January 30, 1999.

The Phyllis Goodhart Gordan Book Prize

The Renaissance Society of America awards an annual book prize of \$1,000 in memory of the late Phyllis Goodhart Gordan, a strong supporter of the RSA from its early days. The purpose of the prize is to recognize significant accomplishment in Renaissance Studies by members of the RSA and to encourage Renaissance scholarship, the goals of the RSA since its foundation in 1954.

The Gordan Prize will be awarded to the author of the best book in Renaissance Studies published between July 1 and June 30 of the succeeding year. The winner is announced at the Annual Meeting of the Society.

To be eligible, a book must be written by a current member of the RSA; it must be written in English; and it must be in one of the disciplines recognized by the RSA. Please see the inside cover of the *Directory of Members of the RSA* or an issue of *RQ* for the list of disciplines. The prize will be awarded for a book dealing with a Renaissance topic within the chronological period, 1300-1700. The following are offered as examples of Renaissance topics: a vernacular or Neo-Latin literary author, topic, or text; humanism in any of its forms; printing; a Renaissance city-state and/or its institutions; the art or an artist of the period. These topics are not meant to exclude other possibilities. Bibliographical works and scholarly aids are eligible for the Gordan Prize, but editions of texts and translations into English will not be considered.

Books will be judged on the following criteria: a) Contribution to Renaissance Studies; b) Originality in insight and research; c) Clarity and eloquence; d) Thoroughness and accuracy in documentation.

One copy of each work, together with a brief curriculum vitae, must be received by *each* of the prize committee members. Each entry should be labeled "Gordan Prize Entry." *Entries must be post-marked by or on July 15 to be eligible.* Late entries will not be considered. Contact the RSA office for names and addresses of committee members.
