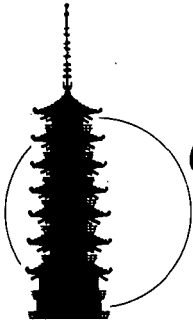

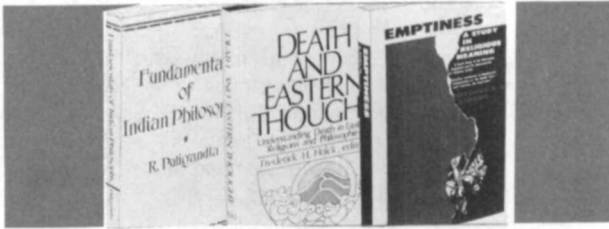

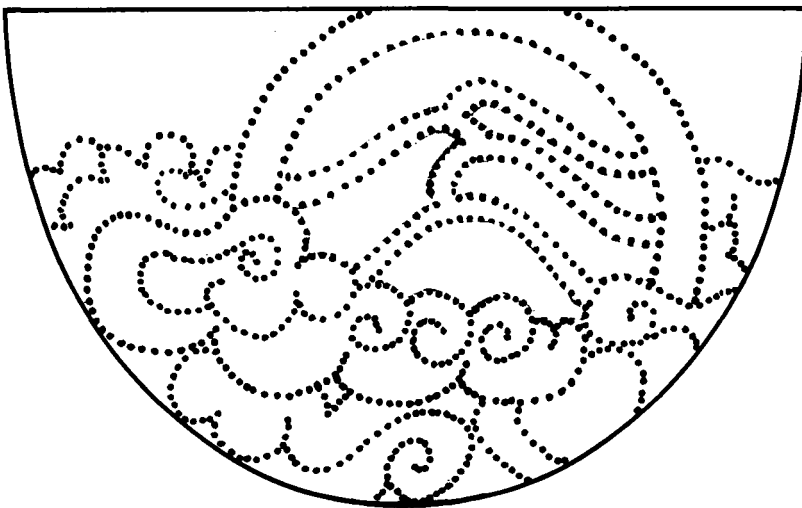

Agrarian CRISIS in India

The Case of Bihar

By F. Tomasson Jannuzi

Although much has been written on agrarian reforms in India, there are few in-depth studies of specific states, and none concerning the relevance of agrarian reforms to the economic development and political stability of Bihar—a state containing one-tenth of the people in India. F. Tomasson Jannuzi's field research in Bihar, beginning with village-level surveys and interviews in 1956 and extending through repeated visits through August 1970, has enabled him to provide a unique perspective on events and issues associated with the continuing struggle to transform Bihar's agrarian structure.

Agrarian Crisis in India is at once a history of postindependence agrarian reforms in an important state of India, a detailed critique of the statutory loopholes that have frustrated successive land-reform measures, and a penetrating analysis of the economic, political, and social implications of the failure of agrarian reforms to be implemented in contemporary Bihar.
