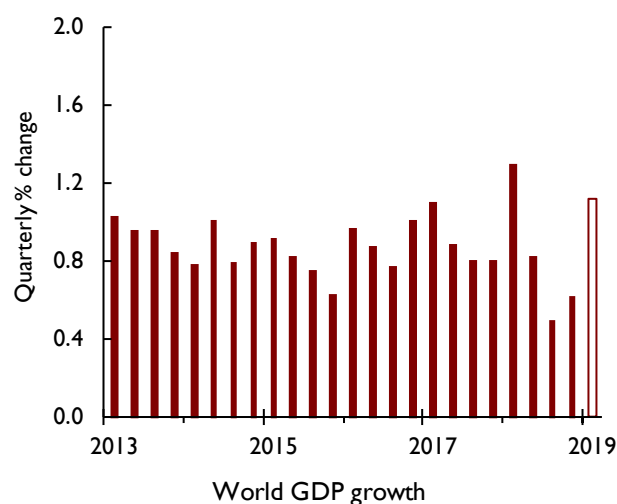

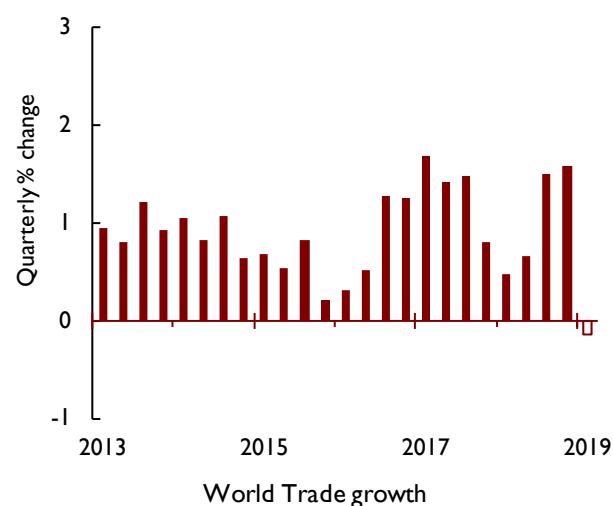

Figure B2. NIESR estimates that world trade fell by 0.1 per cent in 2019Q1

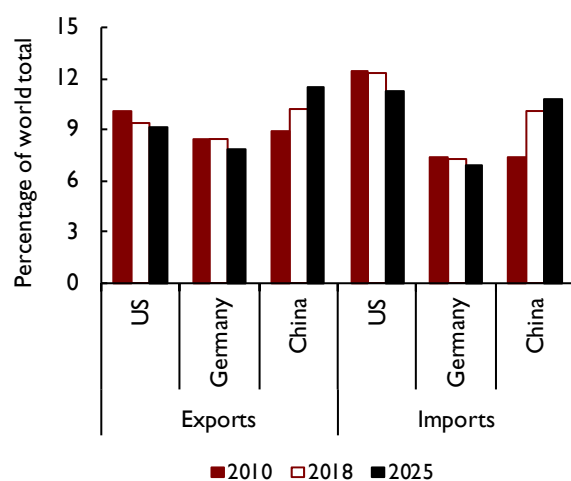

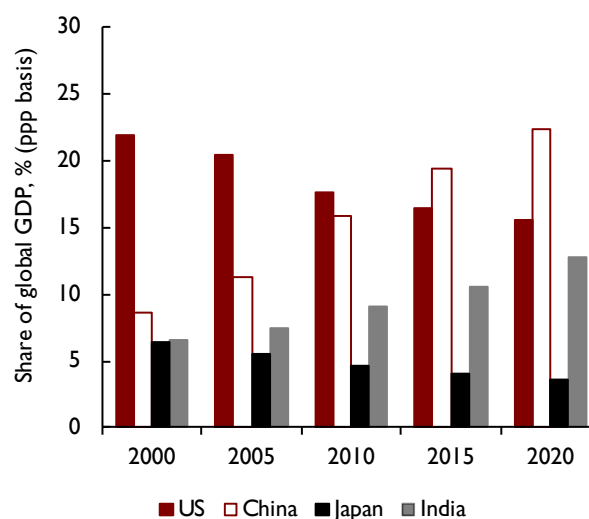
