MASAKI ABE is a Research Fellow in the Department of Law at Kyoto University. He has published articles on administrative discretion as well as on policymaking and implementation. His research interests also include legal reasoning and the judicial review of administrative action.

KITTY CALAVITA is Assistant Professor in the Program in Social Ecology at the University of California, Irvine. She is author of *U.S. Immigration Law and the Control of Labor, 1820–1924*, and articles on contemporary U.S. immigration policy, occupational safety and health laws in the United States and Italy, and white-collar crime.
