Urban Studies Fellowships

The Department of Housing and Urban Development has announced the award of graduate fellowships in urban studies to 107 students, five of them political science students. These fellowships are made available to qualified students in a wide range of urban-related fields of graduate service. Grants are made up to \$3000 for a year of study preparing for careers in the urban public service. Grants are made up to \$3000 for a year of study, plus \$500 per dependent.

Colorado Traineeships

Three University of Colorado graduate students in public administration are studying this year under annual City and County of Denver Management Traineeships. All are studying toward master of public administration degrees.

The year's trainees are **Milo L. Colton** of Denver, **George H. Delaney** of Sturgeon, Pa.; and **Russell Lee Wilson, Jr.** of Beaumont, Tex. They receive \$562 per month during the summer for full-time service and \$281 per month during the academic year for half-time service as management trainees in Denver.

Ford Faculty Fellowships

Award of forty-six faculty research fellowships in economics, political science, and sociology for the 1969-70 academic year have been announced by the Ford Foundation. Totaling approximately \$700,000, the awards went to faculty members of graduate departments at thirty-five universities across the nation. Political scientists received 20 awards.

The purpose of the fellowships is to strengthen the social sciences through support of independent research by young faculty members on subjects of their own choosing. Each fellowship provides full

salary plus a modest research allowance for an academic year free of teaching and administrative duties.

Nominations for the program were submitted to the Foundation by seventy-six institutions. Recipients were selected with the assistance of advisory committees of economics, political science, and sociology professors. Foundation grants covering individual awards are made to the universities with which the fellows are associated.

Ford Grants

An increased level of support for academic exchange and foreign area study programs focusing on both Western and Eastern Europe, including the Soviet Union, has been announced by the Ford Foundation.

Grants totaling \$1 million to the American Council of Learned Societies, Harvard University, and the Social Science Research Council are designed to improve U.S. knowledge and understanding of postwar Europe and to take advantage of the increased opportunities for the exchange of scholars with Eastern Europe.

A number of other grants for foreign area and related studies were also announced by the Foundation: \$154,880 to the Fletcher School of Law and Diplomacy for a new graduate program in "public diplomacy" \$400,000 to the University of Michigan for comparative political studies in the Latin countries of Europe and Latin America; and \$150,000 to Yale University for Caribbean studies, with emphasis on Cuba and Haiti.
