CONTRIBUTORS TO THIS ISSUE

PATRICIA AUSPOS received a PhD from Columbia University in 1978, writing her dissertation on "Pressure Groups and Liberal Politics, 1870-1880." She taught British history and politics at the University of the South for two years. She is now employed as an assistant editor of a Bureau of National Affairs newsletter in Washington D.C. Currently she is working on a study of the changes in pressure group campaigns and tactics in response to the growth of cabinet government and the hardening of the two-party system in late nineteenth-century England.

J.V. BECKETT is Lecturer in History at the University of Nottingham. He is the author of *Local Taxation: National Legislation and the Problems of Enforcement* (1980), *Coal and Tobacco: The Lowthers and the Economic Development of West Cumberland 1660-1760* (1981), and a number of articles on eighteenth-century English history. At present he is doing research on English landowners and their estates for the period 1700-1850.

RICHARD A. GLEISSNER is Associate Professor of History at George Mason University. His previous publications have dealt with seventeenth-century colonial America. His current research focuses on the development of the theory of natural law and the place of natural law in eighteenth-century American political and legal philosophy.

ROBERT S. GOTTFRIED is Associate Professor of History at Rutgers University. His books include *Epidemic Disease in Fifteenth-Century England* (1978), and *Triumph in Transition: Bury St. Edmunds, 1290-1539* (forthcoming). His articles have appeared in a number of journals, including *The Journal of British Studies*, *The American Historical Review*, *The Journal of Modern History*, and *The Journal of Economic History*; he is also a contributor to the *Dictionary of the Middle Ages*. He now is working on books on the Black Death and on late medieval medicine.

T.W. HEYCK is Associate Professor of History and Associate Dean of the College of Arts and Sciences at Northwestern University. His publications include *The Dimensions of British Radicalism: The Case of Ireland, 1874-1895*. His book on intellectual life in Victorian England will be published in 1981. He is currently researching and writing on intellectual life in twentieth-century England.

D.R. HIRSCHBERG is Assistant Professor of History at the University of Pennsylvania. He has finished a book, tentatively titled *Patronage, Profes-*

sionalization and Social Mobility: The Anglican Episcopate, 1660-1760, and has begun a study of Anglican church courts from the Restoration to the early nineteenth century.

BRIAN P. LEVACK is Associate Professor of History at the University of Texas at Austin. His publications include *The Civil Lawyers in England, 1603-1641: A Political Study* (1973). He is completing a book on the problem of Anglo-Scottish union, 1603-1707, and is working on a study of European witchcraft prosecutions.

J.W. MARTIN lives in Washington, D.C., and has spent most of his working career as a federal civil servant. He is a graduate of Haverford College and Oxford University, and he received his PhD from Columbia University. He has taught at Barnard College, College of the City of New York, and Black Mountain College, North Carolina. He is especially interested in the religious nature and social role of early English sectaries, and is currently investigating the pamphlet controversies and underground congregations of Mary Tudor's reign.

MICHAEL MCGIFFERT, editor of *The William and Mary Quarterly*, published by the Institute of Early American History and Culture, is Professor of History at the College of William and Mary. His current research concerns the religious, political, and social significance of conceptions of covenant in the modern age.

GREGORY D. PHILLIPS is in his first year at Yale Law School. After he received a PhD from Harvard University in 1976, he taught at Stanford University and Lafayette College. He has published an earlier article in *The Journal of British Studies*, and a book, *The Diehards: Aristocratic Society and Politics in Edwardian England*. He is the author of a forthcoming article on the Liberal Unionist peers. He is continuing research on British landed society in the twentieth century.
