1) To enable Asian political scientists to become members of The American Political Science Association for a three-year period at greatly reduced rates. Membership includes subscription to *The American Political Science Review*.

(Membership in the Association for three years and subscription to the *Review* will be only \$1.00. Applicants should write directly to The American Political Science Association, 1726 Massachusetts Avenue, N.W., Washington 6, D. C. Payment may be made in UNESCO coupons or in any way convenient and acceptable under the exchange regulations of the country concerned. The privilege is extended to graduate students as well as to established political scientists.)

2) To enable libraries, university departments, and research institutes in Asia, who have heretofore been unable to do so, to subscribe to *The American Political Science Review* at greatly reduced rates.

(The cost of a three-year institutional subscription will be \$2.00, payable as above.)

3) To supplement travel expenses of Asian political scientists who are in the United States and who wish to attend meetings of The American Political Science Association. The next meeting will be held September 6-9, 1961, in the Sheraton-Jefferson Hotel, St. Louis, Mo.

(Applicants must be at least at the graduate student level and may come from any Asian country from Afghanistan eastward. Applications should be sent to The American Political Science Association, 1726 Massachusetts Avenue, N.W., Washington 6, D. C. In his request the applicant should give his regular academic position, the nature of his study or visit in the United States, and the sum necessary for travel to and from the meeting.)

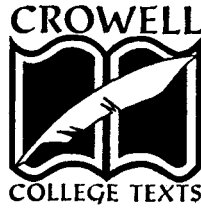

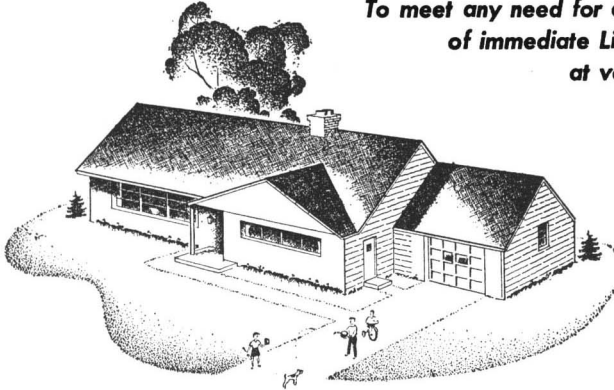

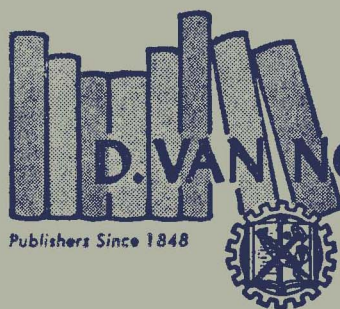
