John Christman received his Ph.D. from the University of Illinois at Chicago in 1985. He is an Assistant Professor in Philosophy at Virginia Polytechnic Institute, and was a Visiting Assistant Professor at the University of California at San Diego in 1987–88. He is the editor of a forthcoming volume, *The Inner Citadel: Essays on Individual Autonomy*. He has published articles in ethics and political philosophy in such journals as *Philosophy and Public Affairs*, *Ethics*, and *The Southern Journal of Philosophy*.

Richard A. Epstein is James Parker Hall Professor of Law at the University of Chicago Law School and has published widely in the fields of legal philosophy and economic law. He is the editor of the *Journal of Legal Studies*. His book *Takings: Private Property and the Power of Eminent Domain* was published by Harvard University Press in 1985.

Andrew Levine is Professor of Philosophy at the University of Wisconsin–Madison. He is the author of *The Politics of Autonomy* (University of Massachusetts Press, 1976), *Liberal Democracy: A Critique of Its Theory* (Columbia University Press, 1981), *Arguing for Socialism* (Routledge and Kegan Paul, 1984; 2nd edition Verso, 1988), and *The End of the State* (Verso, 1987).

Andrew Kernohan farms beef cattle in Parrsboro, Nova Scotia. He received a Ph.D. from the University of Toronto in 1984, and is now an Adjunct Assistant Professor of Philosophy at Dalhousie University. During the slower months of the farming year he has been able to enjoy the hospitality of the University of Toronto Department of Philosophy, thanks to a grant from the Social Science and Humanities Research Council of Canada. He has published papers in nuclear physics, political theory, and philosophy of psychology.

John Gray was born in 1948 and educated at Exeter College, Oxford, where he read Philosophy, Politics, and Economics, and received his doctoral degree. In 1973 he was appointed to a Lectureship in Political Theory at the University of Essex, and in 1976 he was elected a Fellow of Jesus College, Oxford. His books include *Mill on Liberty: A Defense*, *Hayek on Liberty*, *Conceptions of Liberty in Political Philosophy* (edited with

Z.A. Pelszynski), *Liberalism*, and *Liberalisms: Essays in Political Philosophy*. He is currently at work on a three-volume critique of Marxism.

Stephen Macedo is an Assistant Professor in the Department of Government at Harvard University, where he studies and teaches political theory and American constitutionalism. His publications include a monograph, *The New Right v. The Constitution*, and a book, *Liberal Virtues: A Liberal Theory of Citizenship, Virtue, and Community*, the latter of which will soon be published by Oxford University Press.

Gary A. Dymski received his Ph.D. in Economics from the University of Massachusetts at Amherst in 1987, and is currently an Assistant Professor of Economics at the University of Southern California. In 1985–86 he was the Leo Model Research Fellow in Economic Studies at the Brookings Institution. His recent papers include “A Keynesian Theory of Bank Behavior” (forthcoming in the *Journal of Post Keynesian Economics*), “Banking and Financial Fragility,” “Illiquidity, Uncertainty, and Bank Innovation,” “Coercive Signals, Bank Lending, and the Latin American Debt Crisis” (with Manuel Pastor), and “Some Analytics of Narrow Banking” (with Robert E. Litan).

John E. Elliott received his Ph.D. in Economics from Harvard in 1956, and is currently Professor of Economics and Director of Political Economy and Public Policy at the University of Southern California. His major interests are the history of economic and political theory, comparative political economy, and Marxian political economy. His articles on these subjects have appeared in such journals as *Economic Inquiry*, *Quarterly Journal of Economics*, *Journal of Economic Organization and Behavior*, *Review of Social Economy*, and *International Review of Ethics and Economics*. He is the author of *Comparative Economic Systems*, 2nd edition (Wadsworth, 1985). He currently serves as Vice President of the History of Economics Society and President-Elect of the Association for Social Economics.

Israel M. Kirzner was born in London, England, in 1930. He subsequently lived in Cape Town, South Africa, attending the University of Cape Town. Moving to the U.S. in 1948, he received his B.A. from Brooklyn College in 1954, his M.B.A. from New York University in 1955, and his Ph.D. (under Professor Mises) from the same institution in 1957. Since 1957, he has taught at New York University, where he is Professor of Economics. Professor Kirzner is the author of six books, including *Competition and Entrepreneurship* (University of Chicago Press, 1973). At New York University, Professor Kirzner heads the doctoral program in Austrian Economics.

Antony Flew is Emeritus Professor of Philosophy at the University of Reading and a Distinguished Research Fellow of the Social Philosophy and Policy Center. He is the author of *Hume's Philosophy of Belief, Evolutionary Ethics, The Politics of Procrustes, Thinking about Social Thinking, Darwinian Evolution, David Hume: Philosopher of Moral Science, The Logic of Mortality* (with Godfrey Vesey), *Agency and Necessity, Power to the Parents*, and other books. He is also the editor of the Penguin Classic, Malthus's *Essay on the Principle of Population*. Professor Flew is a founding member of the Council of the Freedom Association, the Education Group of the Centre for Policy Studies, and the Academic Advisory Board of the Adam Smith Institute.

Peter Rutland is currently an Assistant Professor of Government at Wesleyan University, and has taught previously at the University of Texas at Austin and the Universities of York and London in England. In 1984–85 he was a research fellow at Harvard University's Russian Research Center. He has spent over two years living in Eastern Europe and the USSR, including study as a visiting scholar at three Sovieteconomics institutes. His publications include *The Myth of the Plan: Lessons of Soviet Planning Experience* (1985), and articles on topics ranging from Soviet industrial management to nationality policy. He has just completed a book manuscript on party supervision of the economy in the USSR.
