This list includes all of the published English-language materials on the legal profession which are known to me. Several worthy items of whose existence I am assured have been included in spite of the absence of complete bibliographic information. Some general works which contain substantial treatment of lawyers have been included, although I have no doubt omitted as many more with an equal claim to inclusion. Several items are merely representative of more or less populous species of materials.

The journal sections of the many local law reporters, which occasionally contain material on the practicing profession and the judiciary, are relatively unexploited here. Further material on legal education may be found in the scholarly journals and souvenir-type magazines published (usually annually) by many law colleges. Beyond these, of course, there lies a wealth of materials in the press, in court registries and record rooms, in lawyers' offices, college files and government papers. It is hoped that the present list, incomplete as it is, will provide a useful starting point for further research.
