

NOTES ON CONTRIBUTORS

Jakub Beneš teaches modern European history at the University of Birmingham. He earned his degrees at Middlebury College (BA) and the University of California, Davis (MA, PhD). He is author of the award winning monograph *Workers and Nationalism: Czech and German Social Democracy in Habsburg Austria, 1890–1918* (Oxford: 2017) and has published research articles on topics in modern East Central European history in *Past & Present*, *Slavic Review*, *Střed/Centre* and *Forum Historiae*. His current research focuses on peasant revolt and peasant movements in twentieth-century Europe.

Filip Erdeljac is Visiting Assistant Professor in the Center for European and Mediterranean Studies at New York University. His research, which focuses on non-elite engagements with nationalism and politics in mid-twentieth century Central and Eastern Europe, has received support from the United States Holocaust Memorial Museum and the Vienna Wiesenthal Institute for Holocaust Studies. His first book manuscript, *Ordinary Nationalist and the First Destruction of Yugoslavia: Indifference and Extremism in World War II Croatia, 1918–1948*, is currently under review. He is presently working on a second, transnational project that applies the analysis of ordinary people's understandings of nationalism in the Balkans to a broader geographic space in Central and Eastern Europe.

Alan Granadino is coordinator of the research network North and South in Europe at the Centre for Nordic Studies of the University of Helsinki. Broadly, his research interests are the political history of post-war Europe, especially the history of European social democracy and the Iberian transitions to democracy. He is particularly interested in the transnational perspective and in the cultural and conceptual transfers between Northern and Southern Europe. He has a PhD in History and Civilization from the European University Institute.

Jan Eivind Myhre was formerly Professor at the University of Tromsø and the Norwegian University of Science and Technology. He is currently Emeritus Professor of Modern History at the University of Oslo. His English-language books include: *Making a Modern University: The University of Oslo 1811–2018* (Scandinavian Academic Press: 2018), *Boundaries of History* (Scandinavian Academic Press: 2015), *Intellectuals in the Public Sphere in England and Norway after World War II* (Oslo Academic Press: 2008), *Nordic Historiography in the 20th Century* (Oslo Academic Press: 2000) and *Making a Historical Culture: Historiography in Norway* (Scandinavian Academic Press: 1995). He is also the author or editor of more than twenty-five books in Norwegian.

Linda Risso is Senior Research Fellow at the Institute of Historical Research in London. Since October 2018 she is also Historical Consultant at the Supreme Headquarters Allied Powers Europe in Mons, Belgium. Risso has published extensively on the history of NATO and on European security during and after the Cold War.

Miguel Ángel Ruiz Carnicer is Professor of Contemporary History at the University of Zaragoza, Spain. He is a specialist in the history of student movements and youth associations. His works include *Los estudiantes de Zaragoza en la posguerra* (Ciencias Sociales: 1986) and *El Sindicato Español Universitario, 1939–1975* (Hachette: 1996) and, in collaboration with Jordi Gracia, *La España de Franco. Cultura y vida cotidiana* (Tapa blanda: 2001).

Václav Šmidrkal is a researcher at the Masaryk Institute and Archives of the Czech Academy of Sciences and Assistant Professor of Contemporary Central European History at the Charles University, Prague, Czechia. His research focuses on the cultural and social history of violence and the armed forces in twentieth-century Central Europe. Besides journal articles (in, for example, *East European Politics and Societies*, *European Review of History*, *Český časopis historický*) and book chapters on these topics, he has recently co-edited a binational book on modern Austrian-Czech history entitled *Nachbarn. Ein österreichisch-tschechisches Geschichtsbuch* (Bibliothek der Provinz: 2019).

Lauren Stokes is Assistant Professor of History at Northwestern University where she teaches German and European history, migration history and the history of gender and sexuality. She is currently working on her first book, which examines the idea and the practice of ‘family migration’ in West Germany. Her work has been supported by organisations including the Alexander von Humboldt Foundation, the Council on European Studies and the Central European History Society.

Julia Wambach received her PhD from University of California, Berkeley in 2017. In her dissertation, ‘Learning from Defeat. The French Occupation of Germany after Two World Wars’, she shows how the long history of mutual occupations between France and Germany throughout the twentieth century influenced the way the last occupation between the two countries, the French occupation of Germany after 1945, played out. She is a researcher at the Max Planck Institute for Human Development in Berlin.

Sarah L. Wood is Visiting Assistant Professor of French and Francophone Studies at the University of Connecticut. Before arriving in the United States she was Lecturer in Imperial and Postcolonial History at the University of York and Visiting Research Fellow at the Universitat Autònoma de Barcelona. Prior to this she taught History and Sociology at the University of Manchester, from where she earned her PhD in History in 2015. Wood’s book *Locating Guyane*, co-edited with Catriona MacLeod, was published by Liverpool University Press in 2018. It explores the historical and conceptual locations of the French overseas department of Guyane as a relational space characterised by dynamics of interaction and conflict between the local, the national and the global. She is currently working on a monograph, tentatively entitled *Françamazonie: The Making of French South America*.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of Eastern and Western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
