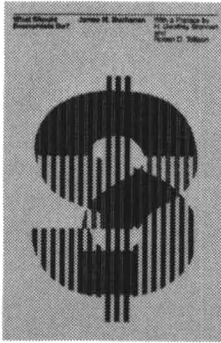

Suggestions for Contributors

Other things being equal, articles of 20 to 30 pages in length (including footnotes) have the best chance of prompt publication in the JOURNAL. Three copies of all manuscripts must be submitted, including the original. They should be typed double-spaced on paper of standard size and weight. Pages should be clipped together rather than stapled.

Do not put your name on the manuscript itself, as it will be sent to referees for anonymous review. Include your name, address, and the article's title in a covering letter or on a separate title page. Articles submitted by non-members of the Economic History Association should be accompanied by a submission fee of \$15.00.

All notes should be grouped at the end of the article, typed double-spaced and numbered consecutively for the entire article. Footnotes should not be attached to titles or headings. Acknowledgements of assistance and the like should be included in an unnumbered footnote which will be printed at the foot of the first page of text. No bibliographies are published with JOURNAL articles.

At the first reference to a source, fully cite its author (including first name) and title, as in the examples below. *Ibid.* (unitalicized) may be used, but *not* *op. cit.* and *loc. cit.* When other notes intervene between the first and subsequent citations, use the author's surname and an abbreviated form of the title. For Slavic and non-European citations a transliteration, capitalized as ordinary prose and placed in brackets in roman type, should follow the citation of the title in the original.

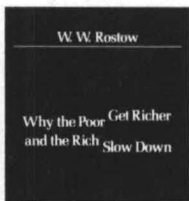

Tables and figures (pen and ink graphs or drawings) should be numbered with arabic numerals and placed on separate sheets at the end of the manuscript. Indicate clearly within the text where tables and artwork are to appear. For footnotes to tables use lower-case letters, not numerals. Such notes should be placed immediately following the table. The source of a table should be given as its final footnote, introduced by "Source:".

When a manuscript is initially submitted for consideration, reasonably clear and precise artwork drawn by the author is acceptable. For publication the artwork must usually be redrawn by a professional draftsman. Use heavy cardboard to protect artwork from damage in the mail. Titles, explanatory legends, and notes to artwork should be typed on a separate sheet of paper.

Quotations of less than 50 words are run on in the text; longer quotations are set as block quotations (double-spaced and indented from either margin). Securing permission to use quotations exceeding the legal length is the author's responsibility. Consult the *Chicago Manual of Style* for conventions governing the use of ellipsis in quotations.

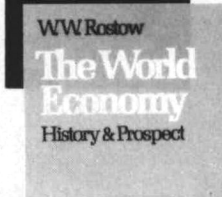
The editors follow Webster's *New International Dictionary* (unabridged; 3rd ed.) for hyphenation and for preferred spellings. Webster's seventh *New Collegiate Dictionary* (1970) may be used as a convenient reference. The *Chicago Manual of Style* (12th ed.) is the JOURNAL's final arbiter on all technicalities and questions of documentation.

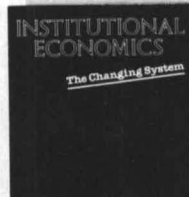

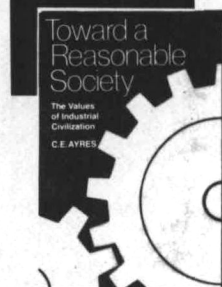


