### APSA Organized Sections Distribute Awards at Annual Meeting

Twenty-two of the 32 APSA Organized Sections used the 1994 Annual Meeting as an opportunity to recognize distinctive scholarship

and career service within their fields of political science.

### *Federalism and Intergovernmental Relations*

The **Distinguished Scholar Award** in recognition of distinguished scholarly contributions to the study of federalism and intergovernmental relations was awarded to Samuel H. Beer, Harvard University. The **Best Paper Award**, conferred upon the best paper in the field of federalism and intergovernmental relations presented at the previous year's annual APSA meeting was presented to Rey Koslowski, University of Pennsylvania.

### *Law and Courts*

The **C. Herman Pritchett Award** for the best book in the field of Law and Courts authored by a political scientist in 1993 was awarded to Howard Gillman, University of Southern California, for his book *The Constitution Besieged: The Rise and Demise of Lochner Era Police Powers Jurisprudence* (Durham: Duke University Press, 1993). **Honorable Mention was given to:** Kevin T. McGuire, University of Minnesota, for *The Supreme Court Bar: Legal Elites in the Washington Community* (Charlottesville: University Press of Virginia, 1993).

The **American Judicature Society Award** for the best faculty paper in the field of Law & Courts presented at the previous year's APSA Annual Meeting was presented to Christine Harrington, New York University and Daniel Ward, Rice University, for "*Rethinking Litigation: The Role of Courts in Producing Litigation.*"

The **CQ Press Award** for best paper in the field of Law & Courts by a political science graduate student was won by Nancy Crowe, University of Chicago, for "*Gender and Asset Settlements in Divorce Proceedings.*"

### *Legislative Studies*

The **CQ Press Award** for an outstanding paper in legislative politics

presented at the preceding APSA Annual Meeting was presented to Elizabeth Theiss-Morse and John Hibbing, University of Nebraska-Lincoln, for *"Public Enemy: People's Perception of Congress."*

The **Richard F. Fenno Prize** awarded annually for the best book in legislative studies published during the previous year was given to Gary W. Cox and Matthew D. McCubbins, University of California, San Diego, for *Legislative Leviathan: Party Government in the House* (University of California Press).

### Public Policy

The **Aaron Wildavsky Enduring Contribution Award** given to any book or article published between 10 and 20 years ago that continues to influence the study of public policy was awarded to John W. Kingdon, University of Michigan, for *Agendas, Alternatives, and Public Policy*.

### Political Organizations & Parties

The **Samuel Eldersveld Career Achievement Lifetime Award** of distinguished scholarly and professional service to the field was presented to James Sundquist, The Brookings Institution.

An **Emerging Scholars Award** for significant research by a scholar receiving his or her doctorate within the past five years was awarded to Scott H. Ainsworth, University of Georgia.

The **Jack Walker Award** for an article of unusual importance and significance to the field was given to Theodore Lowi, Cornell University, for *"Arenas of Power."*

The **Leon Epstein Award** for a book that has made a distinguished contribution to the field was awarded to Mancur Olson, University of Maryland, for *The Logic of Collective Action*.

### Public Administration

The **Herbert Kaufman Award** for the best paper in public administration presented at the previous APSA Annual Meeting was awarded

to Delmer D. Dunn, University of Georgia, and John Uhr, Australian National University, for *"Accountability and Responsibility in Modern Democratic Governments."*

### Conflict Processes

The **Lifetime Achievement Award** for distinguished and lasting contributions to the study of conflict was conferred upon Dina A. Zinnes, University of Illinois.

### Representation and Electoral Systems

The **George H. Hallet Award** for the author of a book published at least ten years ago that has had a lasting contribution to the literature on representation and electoral systems was presented to W. J. M. Mackenzie, for *Free Election*.

The **Leon Weaver Award** for the best paper presented at a panel sponsored by the Representation and Electoral Systems Division was given to Burt L. Monroe, Indiana University, for *"Fully Proportional Representation."*

### Presidency Research

The **Richard E. Neustadt Award** for the best book published during the year that contributed to research and scholarship in the field of the American presidency was given to Stephen Skowronek, Yale University, for *The Politics Presidents Make: Leadership from John Adams to George Bush* (Harvard University Press, 1993)

### Religion and Politics

The **Best Paper Award** for the best paper on religion and politics presented at the 1993 APSA Annual Meeting was presented to David C. Lege, University of Notre Dame, for *"The Decomposition of the Religious Vote"* and to Stephen V. Monsma, Pepperdine University, for *"Justice Potter Stewart on Church and State."*

### Urban Politics

The **Best Book Award** for the best book in Urban Politics published during the calendar year was awarded to Jeffrey M. Berry, Kent E. Portney & Ken Thomson, Tufts University, for *The Rebirth of Urban Democracy* (Brookings Institution, 1993).

The **Career Achievement Award** for the distinguished contributions to the study of urban politics throughout a career was presented to Clarence N. Stone, University of Maryland.

### Science, Technology, and Environmental Politics

The **Best Book Award** on science, technology, and environmental politics published during 1993 or 1994 was given to Scott D. Sagan, Stanford University, for *The Limits of Safety: Organizations, Accidents, and Nuclear Weapons* (Princeton University Press, 1993).

### Women and Politics

The **Best Dissertation Award** was awarded to Joanna Goven, University of California, Berkeley, for *"The Gendered Foundations of Hungarian Socialism: State, Society and the Anti-Politics of Anti-Feminism, 1948-1990."*

The **Best Paper Award** in the field of Women and Politics Research was given to Eileen McDonagh, Northeastern University, for *"Abortion Rights Alchemy and the U.S. Supreme Court."*

### Foundations of Political Theory

The **First Book Award** for the best book by a political theorist in the early stages of his or her career was presented to Bonnie Honig, Harvard University, for *Political Theory and the Displacement of Politics* (Cornell University Press, 1993).

### Computers and Multimedia

The **Best Computer Instructional Software Award** for 1993 was awarded to Marc A. Triebwasser,

Central Connecticut State University for "The American Government Interactive Videodisc," which is designed to supplement presentation in introductory American Government and Social Studies courses and in upper division political science courses in the legislative process, political parties, and interest groups.

The Award for **Best Computer Research Software** was awarded to Gary King, Harvard University for COUNT: A Program for Estimating Event Count and Duration Regression Models, which provides plotting capabilities and implements a variety of statistical models for analyzing dependent variables that are either event counts or durations.

### Comparative Politics

The **Gregory Luebbert Award** for the best work published in comparative politics during 1991, 1992 and 1993 was presented to Robert D. Putman, Harvard University, for "Making Democracy Work: Civic Traditions in Modern Italy" (Princeton University Press, 1993).

### State Politics and Policy

The **Best Paper Award** for the best paper on state politics and policy presented at the 1993 APSA Annual Meeting was given to Kim Quaille Hill, Jan E. Leighley and Angela Hinton-Anderson, Texas A & M University, for "Lower-Class Mobilization and Redistributive Policy: A Longitudinal Analysis."

### Political Communication

The **Ithiel de Sola Pool Award** for the best paper in political communication presented at the previous APSA Annual Meeting was presented to Richard Johnston, University of British Columbia; Elisabeth Gidengil, McGill University, and Neil Nevitte, Calgary University, for "The Dynamics of Referendum Preferences: Canada 1992."

The **Murray Edelman Distinguished Career Award** created to honor Professor Murray Edelman and given to a scholar whose life-

time scholarship has advanced the study of political communication in exceptional ways was awarded to Kurt and Gladys Lang, University of Washington.

### Politics & History

The **J. David Greenstone Book Prize** for the best book in history and politics in the past two calendar years was presented to Stephen Skowronek, Yale University, for *The Politics Presidents Make* (Cambridge: Harvard University Press, 1993).

The **Best Article Award** was awarded to two articles of equally outstanding merit this year. Winners were Charles Stewart III, Massachusetts Institute of Technology and Barry Weingast, Hoover Institute, "Stacking the Senate, Changing the Nation: Republican Rotten Boroughs, Statehood Politics, and American Political Development," and to Richard M. Valelly, Swarthmore College, "Party, Coercion, and Inclusion: The Two Reconstructions of the South's Electoral Politics."

### Political Economy

The **Best Book or Article Award** published in 1991, 1992 or 1993 in the political economy field was awarded to Sven Steinmo, University of Colorado for *Taxation and Democracy* (New Haven: Yale University Press, 1993).

### New Political Science

The **Christian Bay Award** for the best paper delivered at a New Political Science panel at the 1993 APSA Annual Meeting was presented to C. R. D. Hilisi, Indiana University-Bloomington, for "From Liberalism to Citizenship in Black South African Political Thought."

The **Michael Harrington Book Award**, awarded yearly to the author of a book which best exemplifies the goals of the section was presented to Stephen Bronner, Rutgers University, for *Moments of Decisions* (New York and London, Routledge, 1992).

### Political Psychology

The **Best Political Psychology Book** of 1992 Award was given to John Zaller, University of California, Los Angeles, for *The Nature and Origins of Mass Opinion* (New York: Cambridge University Press, 1992) and Yuen Foong Khong, Nuffield College, *Analogies at War: Korea, Munich, Dien Bien Phu and the Vietnam Decisions of 1965* (Princeton: Princeton University Press, 1992).

### Enlargement of Foreign Policy Section

At its 1994 business meeting the Section on Public Opinion and Foreign Policy decided to enlarge its focus by renaming itself the **Section on Domestic Sources of Foreign Policy**. The primary reasons for this name change were to build the membership of the POFPS Section and to help organize the larger community of foreign policy analysts in the APSA. As the membership of the Section grows, the Section hopes to play a greater role in the Association both in terms of planning the annual convention and in rewarding outstanding contributions to the field of foreign policy.

The Section will emphasize approaches that either deal exclusively with domestic sources of foreign policy or inclusively with both domestic and international sources. Thus, the Section on Domestic Sources of Foreign Policy is particularly interested in the relative potency of domestic and international sources of foreign policy.

The Section is also concerned with the whole range of foreign policy issues, e.g., international political economy, defense policy, security policy, and immigration and refugee policies. The domestic sources of military, economic, political, social and other policies abroad are all relevant. Indeed, one of the questions that arises in the study of domestic sources is: how much difference do issue areas make?
