### Political Scientist Runs For President of U.S.

In the spring of 1984, a political scientist will join other Democratic candidates in New Hampshire and in other New England primaries. The candidate is William P. Kreml, an associate professor of political science at the University of South Carolina.

Kreml's campaign against Senator Ernest Hollings in the 1980 senatorial primary in South Carolina broached the question of constitutional review. The national publicity his campaign garnered helped lead to the formation of the Commission on Constitutional Study, a national citizen's group that includes Robert McNamara, Barbara Tuchman, Lloyd Cutler, C. Douglas Dillon, Henry Reuss and others.

Kreml's purpose, and the purpose of the Commission on Constitutional Study, is to have the 1987 bicentennial of the Constitution be what James MacGregor Burns calls a "cerebration" of the document. Increasingly, many American scholars, as well as informed citizens, are disturbed by the excessive fragmentation of the American government and the deadlock of policy which seems to result from such fragmentation.

Though Kreml does not endorse the adoption of a pure parliamentary form of government, he suggests lengthening the terms of House members to four years and the abrogation of Section 6, Article I, thereby permitting leading congressional members to serve in the executive branch, which would provide a workable alternative to our current separation of powers system.

Independently of the Commission, which has established a Washington office with tax-deductible funding, Kreml will enter the six New England Democratic primaries in 1984 and will hold forums to discuss the constitutional issue at colleges and universities in the region. Political scientist Robert Lane at Yale, economist Lester Thurow at M.I.T., Amaitai Etzioni, and former Senator James Abourezk are among those who have already accepted invitations to appear at forums. Kreml invites the interest of others who would be willing to speak to the Constitutional issue in the spring of 1984.

Kreml also plans a hospitality suite at the Chicago meeting in September and invites all interested political scientists to either meet with him there or contact him

beforehand at the Department of Government and International Studies, University of South Carolina, Columbia, SC 29208. □

### Teachers Invited to Taft Seminars

The Robert A. Taft Institute of Government announces its 1983 seminars open to elementary and secondary school teachers, librarians, and administrators. There is exploration through the two-week seminars to find relevant ways to teach elementary school children and high school students the meaning of American liberties and how these freedoms are maintained through operation of the two-party political process.

Educators will meet with experienced Republican and Democratic political experts to discuss the two-party system and ways for individuals to carry out their political responsibility. Chosen participants receive tuition, texts, housing, some meals, and other allowances. All seminars award graduate credit. Also announced is a new Taft Seminar II in Washington, D.C. for former Taft participants. Competition for selection will be based upon submitting good ideas for teaching politics and government.

### Urban Resources Inaugurated

The Division of Metropolitan Services of the University of Cincinnati announces the creation of a new journal, *Urban Resources*. The journal serves two purposes: to bridge the gap between urban practitioners and academics, and to provide a common forum for the disparate urban disciplines. A working document published in loose-leaf format, *Urban Resources* focuses on current urban-related topics through articles from all urban disciplines. Forthcoming topics include: the dynamics of urban power, creating a new urban infrastructure, defining the neighborhood, the urban individual, urban myths, adapting to the city.

*Urban Resources* welcomes manuscripts from all urbanists. Articles should fuse practical experience or empirical research with theory (for example, problem-solving or process-analysis). They should be 10-15 pages long, double-spaced, and be written in non-technical language. A two-year subscription to *Urban Resources* is \$22 for individuals, \$36 for institutions and includes a free inaugural issue, six regular issues, and a custom binder. A three-issue trial subscription is \$12 for individuals, \$18 for institutions. ### International Journal Planned

*Social Choice and Welfare*, an international journal on welfare economics,

social choice and voting theory will be published three times a year by Springer-Verlag, Heidelberg, Berlin and New York, beginning in 1984. It will contain original articles, survey papers and book reviews on the ethical and positive aspects of welfare economics and social choice interpreted in a broad sense. ### CIS Publishes Index to International Statistics

After more than three years of research and development, Congressional Information Service, Inc., (CIS) has published the first monthly issue of the Index to International Statistics (IIS).

The index and a corresponding microfiche collection of source publications provide current access to economic, demographic, industrial, and social statistics published by major international intergovernmental organizations (IGOs).

Among the organizations covered are the United Nations, the European Community, the Organization of American States, the Organization for Economic Cooperation and Development, and some 30

others. During its first year IIS will cover 1300-1500 titles, including periodicals, annuals, biennials, serials, monographs, and special studies.

IIS provides access to IGO statistical publications by subject, name, and geographic area; category of data breakdown (e.g., by country, by industry, etc.); title; issuing source; and report number. IIS abstracts describe the subject matter of the publication, the data sources and breakdowns, and the time period covered. IIS indexes and abstracts are cumulated quarterly in paperbound form and annually in a two-volume cloth-bound edition.

CIS also publishes the American Statistics Index to statistical publications of the U.S. government, and the Statistical Reference Index to statistical data produced by U.S. business organizations, associations, commercial publishers, research centers, universities, and state governments.

### 1982 Public and Elite Surveys on Foreign Policy Available

The newest in a series of surveys on foreign policy conducted by the Gallup Poll for the Chicago Council on Foreign Relations is now available. Two surveys were conducted in November 1982—one a random national sample of the public and the other a cross-section of elites from the Congress, the White House, the business community, news media, foreign policy academics and others.

There are over 250 variables in the elite sample and over 350 in the public sample. Many questions were asked of both elites and the public.

This is the third in a series of surveys on foreign policy sponsored by the Chicago Council on Foreign Relations. The previous surveys conducted in 1974 and

1978 follow the same format as the 1982 survey. Therefore, comparisons of elites and the public are possible between 1974 and 1982. Funding for the two 1986 surveys has already been guaranteed.

All surveys have been deposited at the Interuniversity Consortium for Political Science Research in Ann Arbor, Michigan and at the Roper Center at the University of Connecticut, Storrs, Connecticut 06268.

### **Nominations Requested for Policy Studies Awards**

At the spring 1982 meeting of the Council of the Policy Studies Organization (PSO), a decision was reached to establish a PSO Awards Committee. The Committee is chaired by Aaron Wildavsky in his role as PSO Vice-President and President-Elect. The Committee will consist of three members. The other two members appointed by Bob Lineberry in his role as PSO President are Dennis Palumbo and Walter Beach. *The Harold Lasswell Award.* An award for being an outstanding scholar in contributing to our understanding of the substance or process of public policy.

*The Hubert Humphrey Award.* An award for being an outstanding public policy practitioner.

*The Donald Campbell Award.* An award for being an outstanding methodological innovator in public policy studies.

The committee invites nominations for any one of these three awards from members of the Policy Studies Organization or other people interested in policy studies. The winners of the awards will be announced in a brief ceremony at the annual PSO-APSA meeting on September 2 at the Palmer House in Chicago, as well as announced in the November issue of the *Policy Studies Review*. □

### **Political Scientists Will Tour Soviet Union**

A tour to the Soviet Union is now available, co-sponsored by the journal *New Political Science* and the Labor Research Association. Political scientists, their spouses and friends have been invited by the All-Union Central Council of Trade Unions to meet Soviet political scientists, journalists, workers and just plain folks, and discuss important aspects of life in the USSR. The trip is scheduled for August 5 to August 20, 1983.

The cost is \$1,715; it covers *all* expenses including travel from New York City and within the USSR, hotel accommodations, meals, etc., and it may be tax deductible.

Visits will be made to Moscow, Leningrad and Baku. Travelers will explore how the Soviet University is run and

observe factories and other workplaces. They will visit the USA-Canada Institute and the Institute on the International Labor Movement, meet with employees of *Pravda, Krokodil* (a Soviet satire and humor magazine), the state television network, members of the Writers Union, trade union officials and peace movement activists. Participants will visit cultural and historical sites and have time to meet ordinary citizens and sample some of the social and recreational life. (Bring bathing suits.)

Essay Contest  
Established**

The Arms Control Association (ACA) announces the establishment of the Gerard C. Smith essay contest. Named in honor of the U.S. negotiator for the first Strategic Arms Limitation Talks (SALT I) with the Soviet Union, its purpose is to encourage innovative thinking and creative approaches to arms limitation and reduction.

A \$500 prize will be awarded annually for the best essay submitted to ACA by a post-graduate student or professional under the age of thirty. A \$350 prize will be awarded for the best essay written by a college or university student, and \$250 will be awarded for the best essay by a high school student. There will be two honorable mentions in each category who will receive a \$100 prize.

Submissions should be no longer than 3,500-4,000 words. Essays should be submitted in original, neatly typed, double-spaced form, plus one copy. Footnotes and bibliography may be included and will not count against restrictions in length.

Contestants may address arms control strategies in general, or deal with a specific problem that world leaders now face or that will soon appear on their arms limitation agenda.

The contest is open to all persons between 12 and 30 years of age, except the staff and their families of ACA and Carnegie Endowment for International Peace.
