**Paolo Acanfora** teaches History and the Institution of the European Union at the IULM University in Milan. His publications include *Miti e ideologia nella politica estera DC*, (Bologna: Il Mulino 2013) and *Un nuovo umanesimo cristiano. Aldo Moro e Studium*, (Roma: Studium 2013). He has also published various articles and essays in both Italian and English, focusing mainly on Catholic political culture. His research interests also extend to cooperative culture in England and the International Cooperative Alliance.

**Óscar J. Martín García** is a COFUND Marie Curie Junior Fellow at the Aarhus Institute of Advanced Studies (Aarhus University). He has previously been a postdoctoral research fellow at the Spanish National Council for Scientific Research (Madrid, 2009–2012) and the London School of Economics and Political Science (2007–2009). His research has focused on social movements and democratisation studies, as well as international history more generally. On these topics he has authored three books and has published several articles in international peer reviewed journals such as *Cold War History*, *Democratization*, *Social Movement Studies* and *Contemporary British History*.

**Ed Naylor** is a Leverhulme Early Career Research Fellow within the Centre for European and International Studies Research at the University of Portsmouth. He completed his PhD thesis, ‘The politics of a presence: Algerians in Marseille from independence to “immigration sauvage” (1962–1974)’ in the School of History at Queen Mary, University of London in 2011. His current research project explores how decolonisation impacted upon the French welfare state and reshaped understandings of marginality and integration.

**David Petrucci** is a PhD candidate at Yale University, where he is completing a dissertation on efforts by police officials, jurists and political leaders to develop international frameworks for fighting crime between the wars. This project draws on research conducted in the United States, France, Switzerland, Germany, Austria, Poland and Hungary. He was a Fulbright Fellow in Freiburg, Germany, a Junior

Visiting Fellow at the Institute for Human Sciences in Vienna and a Fox Fellow at the Freie Universität in Berlin.

**Francisco J. Rodríguez Jiménez** works at the University of Salamanca. He was previously a postdoctoral researcher at the Weatherhead Centre for International Affairs, Harvard University (2012–2013) and a Fulbright Visiting Scholar at George Washington University (2010–2012). His areas of interest are international relations in twentieth century Spain, the United States and China, as well as US public diplomacy in Europe and the analysis of Anti-Americanism. Among other publications, he has published the books *¿Antídoto Contra el Antiamericanismo?* (Valencia: 2010), *Estrategias de Diplomacia Cultural en un Mundo Interpolar* (Madrid: 2015, co-edited with Elisa Gavari) and *¿Mujeres sabias? Mujeres universitarias en España y América Latina* (Limoges: 2015, co-edited with Josefina Cuesta and M<sup>a</sup> Luz de Prado). He is currently finishing the monograph *Selling Democracy? U.S. Public Diplomacy and Democratization in Spain* (New York: Palgrave Macmillan, September 2015, co-edited with Nicholas Cull and Lorenzo Delgado).

**Gil Rubin** is a doctoral candidate in history at Columbia University. He is completing his dissertation 'The Future of the Jews: Planning for the Postwar Jewish World, 1939–1946'. Publications include 'The End of Minority Rights: Jacob Robinson and the "Jewish Question" in World War II', *Simon Dubnow Institute Yearbook*, 11 (2012), 55–72.

**Leslie M. Waters** is Assistant Professor of Modern European History at Randolph-Macon College in Ashland, Virginia. She is the author of 'Learning and Unlearning Nationality: Hungarian National Education in Reannexed Felvidék, 1938–1944', *Hungarian Historical Review* 2, 3 (2013), and she is currently at work on a book manuscript entitled *Identity Politics and Territorial Change in the Slovak-Hungarian Borderlands, 1938–1948*, an adaptation and expansion of her 2012 dissertation at UCLA. Her research interests include borders and borderlands, migration, nationalism and transnational history.

**Ville Yliaska** has a PhD in history from University of Helsinki. His main field of expertise is the history of New Public Management in Finland.

## NOTES FOR CONTRIBUTORS

*Contemporary European History* covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

### Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at [ceh@sheffield.ac.uk](mailto:ceh@sheffield.ac.uk)

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
