Submitted manuscripts should be typewritten with wide margins and with double spacing between the lines, or prepared with a word processor, such as L^AT_EX or Microsoft Word. Two copies of the manuscript should be sent to the editor, and the author should also keep a complete copy and the electronic file from which the submitted copy was prepared, if a word processor was used. After the paper is accepted in its final form, an electronic copy will be appreciated and will advance the final publication date of the paper, especially if it is in L^AT_EX or A^MS-L^AT_EX. The JOURNAL and the BULLETIN OF SYMBOLIC LOGIC are typeset in a version of A^MS-L^AT_EX, using a stylefile which is posted on the ASL Website, <http://www.aslonline.org>, along with instructions for its use. Fifty offprints of each article are supplied at no charge, and additional offprints may be purchased if desired.

Volumes 1 through 60 of the JOURNAL are available online in the JSTOR database.

Reviews of articles and books in logic which in the past were published in the JOURNAL have been moved to the BULLETIN OF SYMBOLIC LOGIC, beginning with the March 2000 issues.
