His recent research examines how corporate inertia hinders companies from adapting to environmental changes, and his findings have been published in *Industrial and Corporate Change*, *European Management Journal*, *Academy of Management Best Paper Proceedings*, *Harvard Business Review*, *Financial Times*, and a series of case studies.

The second, called the “special award,” consists of a cash award of \$500 and a scroll, and is presented to the author of the best article written by a graduate student or recent Ph.D. who has not yet published a book in the field of business history. If a tie occurs in either category, or if the article is authored by more than one person, the cash prize is divided between the winners.
