Prize to Honor Elaine and David Spitz

The Conference for the Study of Political Thought notes with profound regret the death of Elaine Spitz, one of its original and most valuable members, a member of its Executive Committee, and its former Vice-Chair. She died after a long and extraordinarily courageous battle against a death she knew was inevitable. No one who met her will forget how

brave and entirely devoid of self-pity Elaine Spitz was during these years when she worked to the last to complete her scholarly projects.

No doubt she would have preferred to be remembered as a promising political theorist, teacher, and as the wife of David Spitz, another irreplaceable colleague and friend of the Conference. The author of a recent and well-received book, *Majority Rule*, Elaine was also the author of numerous contributions on democratic theory and liberalism. At the time of her death she was at work on her first historical study: of John Locke's friend, Damaris Cudworth Masham.

Her teaching career included appointments at the City University of New York, Colgate, Cornell, Vassar, the New School for Social Research, Montclair State College, and C.W. Post. She had been appointed to a tenured position at North Texas State University, but was unable to take up her position there.

After graduating with honors from Hunter College, Elaine Spitz received a Falk Fellowship and an M.A. with honors from Yale, and her doctorate from the City University of New York. She held research fellowships from the Russell Sage Foundation and the National Endowment for the Humanities. During the last year of her life, nothing gave her more pleasure than her connections with Trinity and King's Colleges at Cambridge University. She served as a member of the Editorial Board of *Polity* and as a member of the committee on equality of the American Civil Liberties Union.

She is survived by her daughters, Karen and Jessica Mates; her sister, Gloria Zicht of New York City; and her mother, Sylvia Gilbert.

The Conference for the Study of Political Thought proposes to establish a prize in the memory of Elaine and David Spitz. It will be awarded annually to the author of the best published work on democratic theory. A committee of the Conference will award the prize at its yearly international meeting. Guide to Federal Funding for Social Scientists Available

Political scientists and other social science researchers now have a comprehensive guide to federal funding tailored specifically to their needs. The *Guide to Federal Funding for Social Scientists* was prepared by the Consortium of Social Science Associations (of which APSA is a founding member) with support from the Russell Sage Foundation. The *Guide* will be available in mid-June.

In this time of increasing demand on scarce federal research dollars, it has become even more important for social and behavioral scientists to be aware of the wide range of federal agencies that support extramural research and training. The *Guide* is designed to help experienced scholars discover alternative funding sources for their research as well as to introduce new scholars to the federal funding arena.

The *Guide* contains nearly 200 entries with information on over 300 federal programs that provide support for the social and behavioral sciences and related areas of the humanities, either through research grants and contracts, fellowships, or dissertation support. Entries are based on in-depth interviews with federal program staff discussing their current and future research priorities, and what specific role they see for the social sciences in their programs or agencies. Also included are contact persons, budget information, application and review processes, deadlines, funding mechanisms, and examples of funded projects.

Other chapters in the *Guide* include "Academics and Contract Research," "Structure and Organization of the Social Sciences in the Federal Funding Arena," "The Federal Statistical Agencies," written by experts in these fields, and inside views on funding procedures at the National Science Foundation, the National Institutes of Health, and the Alcohol,

Drug Abuse, and Mental Health Administration, written by officials at those agencies.

The *Guide* is being published by the Russell Sage Foundation and distributed through Basic Books. The cost is \$19.95 for individuals; \$24.95 for library or institutional copies. Commonwealth Inaugurated

Following a considerable period of planning, and authorization at its last annual conference, the Pennsylvania Political Science Association announces the inauguration of a new publication, *Commonwealth: A Journal of Political Science*. *Commonwealth* is to be a general journal, publishing articles from among the many subfields and perspectives in the discipline as well as those of an interdisciplinary nature. Open to a variety of approaches and methodologies, it seeks studies that are based on theoretical perspectives (empirical and/or normative) as well as those that advance knowledge by using historical approaches. Initially it will be an annual, published in the fall. The first issue is substantially complete, and the editor is seeking submissions for Volume II. *Commonwealth* would particularly encourage scholars studying Pennsylvania state and regional politics and public policy to submit articles for consideration by our referees.

Some guidelines for manuscripts are as follows: the preferred length is 15-25 typewritten pages (including notes and references). Tables and figures should be on separate, consecutively numbered pages following the text and preceding content notes, with a note in the text

indicating their placement. The number of copies to be submitted is four. To facilitate blind refereeing, author's name and affiliation should be on a separate cover page. Citation style: *APSR* (in-text) for references. Content notes should be placed at the end of the manuscript, preceding the list of references. All material should be double-spaced.

Donald G. Tannenbaum, Gettysburg College, has assumed the post of editor of *Commonwealth*. Annette Steigelfest, Widener University, is managing editor.

Nominations Sought for Dissertation Award

The National Council for the Social Studies (NCSS) is sponsoring an Exemplary Dissertation Award competition in order to recognize excellence in research conducted by doctoral candidates in areas related to social studies education. The author of the selected dissertation will receive a certificate of merit, \$150, and recognition at the NCSS National Conference.

The award will be conferred on the basis of dissertation research in the pursuit of the doctoral degree. Research is broadly defined to include experimental, conceptual, historical, philosophical, and other modes appropriate to the problem investigated. For a dissertation to be selected for the award, it must make a significant contribution to the field of

social education. The dissertation must also be outstanding in the areas of problem statement, analysis of related literature, methods and procedures, analysis of data, and discussion of results.

To be eligible for the 1986 award, the dissertation must have been completed between June 16, 1984, and June 15, 1986. Nominations should include four copies of "Chapter One" of the dissertation submitted to the Exemplary Dissertation Award Committee chair by June 15, 1986. Please include a cover page that provides the following information: author's name, address and telephone number; name of degree-granting institution and graduation date; and name of major advisor. After initial review, the Award Committee may request a copy of the entire dissertation for final evaluation.

Summer Institute Offered in Survey Research

The Survey Research Center of the Institute for Social Research (ISR), The University of Michigan, will hold its 29th annual summer institute in Survey Research Techniques at ISR during the summer of 1986. Two four-week sessions, beginning June 30 and ending August 22, will be offered. The program emphasis is on the sample survey as a basic measuring instrument for the social sciences. Teaching faculty in the summer institute are drawn primarily from the research faculty of the departments of sociology and psychology of the university. Participants in the program gain familiarity with the application of survey research methods, including research design, sampling, measurement, questionnaire design, field methods, data management, and the statistical analysis of data. In addition to the nine graduate-level courses, the 1986 summer institute will offer two five-day short courses on the use and interpretation of survey data.

Faculty Workshop Planned on Game Theory and International Conflict

The Alfred P. Sloan Foundation will sponsor a Faculty Workshop on Game Theory, National Security, and International Conflict at Wellesley College on August 3-15, 1986, under the direction of Steven J. Brams of New York University. Only faculty from the 36 colleges in Sloan's New Liberal Arts Program are eligible to participate. The purpose of the workshop is to illustrate how game theory and related tools can be applied to the analysis of the deterrence and defense strategies of nations, arms races and different means for controlling them, and the verification of international treaties. Particular attention will be paid to nuclear conflict and possible ways of averting it, especially between the superpowers, but other issues of national and international security amenable to rational strategic analysis will also be discussed. □

Each program lasts for one 14-week semester.

The internship placements of Hansard Scholars are as assistants to Members of the House of Commons and the House of Lords or to key personnel in local government, the political parties, public policy research institutes, the public affairs sections of business firms and trade unions, and public interest and advocacy groups.

Three related academic courses are taught at Birkbeck College, University of London. Hansard Scholars must have completed two or more years of college study.
