About the *Annotated Code* . . .

The **Textual and Historical Notes** present the legislative history of the American Bar Association's Code of Professional Responsibility. The Notes deal with the development of the Code beginning with the tentative unpublished draft and proceeding to the preliminary and final drafts and subsequent amendments through August 1978. Textual information is supplemented by interview data from the Reporter of the drafting committee, John F. Sutton, Jr., and some members of the ABA Committee on Ethics and Professional Responsibility.

The **Comments** are based on court opinions reported in the National Reporter System (1) which interpret the Code and (2) which do not interpret the Code but which nevertheless are highly relevant. The Code was adopted in 1970. Generally, opinions from 1970 through 1978 are included in the Comments.

All **Opinions** of the ABA Committee on Ethics and Professional Responsibility that refer to the Code and its Disciplinary Rules and Ethical Considerations, as well as relevant pre-Code opinions, are analyzed and referred to in the Comments.

References to secondary materials, primarily law review articles and notes, are included wherever appropriate.
