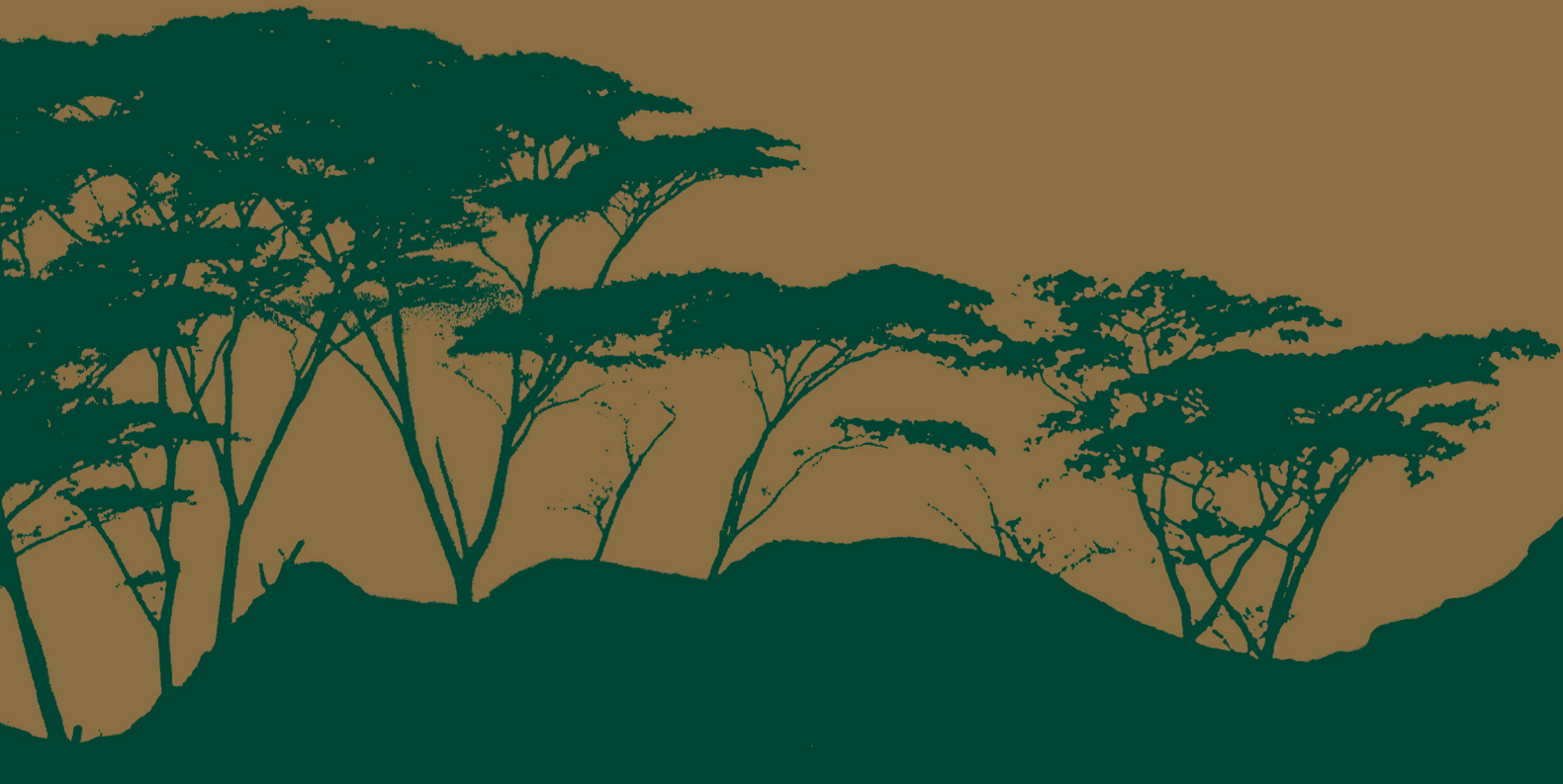

Scope of the journal

Papers may deal with terrestrial, freshwater and strand/coastal tropical ecology, and both those devoted to the results or original research as well as those which form significant reviews will be considered. Papers normally should not exceed 6000 words of text. *Short Communications* are acceptable: they should not exceed four printed pages in total length.
