JORGE DURAND, an investigator at the Center for Research on Social Movements at the University of Guadalajara, just completed a Ph.D. at the University of Toulouse in France. He has written widely on migration and social change in Mexico, including the edited volume *La migración mexicana a los Estados Unidos en los años veinte: una antología*, published in Mexico by the Consejo Nacional de Cultura.

They also loaned their collection of retablo paintings to the Diego Rivera Museum in Mexico City for an exhibition.

BRADFORD BARHAM is an assistant professor in the Department of Economics at the University of Wisconsin–Madison. He is currently working on adoption and accumulation patterns associated with nontraditional exports in Guatemala.
