CONTRIBUTORS

Rafael Chamboleyron is an Associate Professor at the Universidade Federal do Pará, in the Brazilian Amazon. His research focuses on the colonial history of the Portuguese Amazon region in the seventeenth and eighteenth centuries. He is at present investigating the dynamics of that region's colonial economy as related to agriculture and the gathering of products in the hinterland, and how this economy relied on the use of an Indian labor force. His overview of the history of the colonial Amazon region, titled "Territory, Economy, and Labor in the Colonial North" (2019), appears in the *Oxford Research Encyclopedia of Latin American History*.

Christopher Woolley is Assistant Professor of History at the University of North Carolina at Pembroke. His research interests include environmental history, Mesoamerican ethnohistory, and the legal and social history of New Spain and the Spanish empire. He completed his PhD at the University of Florida in 2016 with research funding from a Fulbright-García Robles fellowship and an International Dissertation Research Fellowship from the Social Science Research Council. His publications include (with Susan Milbrath) a study of the likely pre-Hispanic Codex Borgia (2011) and a special-edition article for *The Americas* (2017) on the journal's contribution to the study of missions and missionaries in colonial Mexico.

Magdalena Candiotti is Associate Researcher of the National Council for Scientific and Technological Research (CONICET) at the Instituto de Historia Argentina y Americana "Dr Emilio Ravignani" and Associate Professor in the Faculty of Humanities and Sciences, Universidad Nacional del Litoral, Argentina. Candiotti has a PhD in History, from the Facultad de Filosofía y Letras, Universidad de Buenos Aires. Her doctoral research was on the political history of justice in nineteenth-century Río de la Plata, and she published *Un maldito derecho: leyes, jueces y derecho en la Buenos Aires republicana, 1810–1830* in 2018. In 2014, she was awarded a scholarship by the Slicher van Bath De Jong Foundation, CEDLA (Holland) to conduct comparative research on slavery in Santa Fe and Buenos Aires. Since 2018, she has been responsible for the research project Slavery, Emancipation and Citizenship in the Río de la Plata: Comparative Study of Africans and Afro-descendants in Buenos Aires, the Litoral, Cuyo and Córdoba (1776–1860), funded by the National Agency

to Promote Science and Technology. She has published articles in national and foreign journals and many book chapters on topics related to the political and judicial history of slavery, Free Womb laws, and forms of manumission. Her current research is focused on the social history of slavery, abolition, and the African Diaspora in the Río de la Plata.

Gema Kloppe-Santamaría is Assistant Professor of Latin American History at Loyola University, Chicago. She holds a PhD in Sociology and Historical Studies from the New School for Social Research. She has been a Visiting Fellow at the Kellogg Institute for International Studies at Notre Dame University (2017–18), a Matías Romero Visiting Scholar at the University of Texas at Austin (Fall 2016), and a Visiting Fellow at the Center for US-Mexican Studies at the University of California, San Diego (2014–15). Before joining Loyola, she was Assistant Professor and Director of Undergraduate Studies at the International Studies Department at the Instituto Tecnológico Autónomo de México (2015–17). In 2016, she received the Women in the Humanities Fellowship awarded by the Mexican Academy of Sciences. Kloppe-Santamaría is the lead editor of the volumes *Violence and Crime in Latin America: Representations and Politics* (University of Oklahoma Press, 2017) and *Seguridad humana y violencia crónica en México: nuevas lecturas y propuestas desde abajo* (Editorial Porrúa, 2019).

Estefanía Yunes Vincke's research focuses on the cultural contact between indigenous peoples of Mesoamerica, in particular the Nahuas, and the Franciscan friars during the first decades of the viceroyalty period in New Spain. Yunes Vincke was awarded her PhD by the University College London in 2015, with a dissertation on the pivotal role of Friar Pedro de Gante in the process of the transculturation of the Valley of Mexico in which she analyzed three influential Christian pedagogic texts composed by the friar. Yunes Vincke has an interdisciplinary background, with an undergraduate degree in Archaeology from the Escuela Nacional de Antropología e Historia in Mexico, and two master's degrees, one in Archaeology of the Near East and another in Book and Digital Media, focusing on the history of the book. Her research interests include the history of Mexico, Christian pedagogic treatises, the mendicant orders in New Spain, indigenous identity, and codices, transculturation, agency, and language preservation during the viceroyalty period in Mexico. She was a Spanish teaching fellow at the University of Leicester for three years and is preparing a book proposal derived from her dissertation subject.
