Madeline Harrison Caviness is Mary Richardson Professor Emeritus, Tufts University, a fellow of the American Academy of Arts and Sciences, and a former president of ICPHS. She began her career as a historian of medieval art and has recently published on gender and sexuality in medieval and modern works.
