

## GRANTS FOR ASIAN POLITICAL SCIENTISTS

The American Political Science Association has received from The Asia Foundation a grant of \$2,500 for encouraging closer relations between Asian and American political scientists. The funds will be used in three ways:

1) To enable Asian political scientists to become members of The American Political Science Association for a three-year period at greatly reduced rates. Membership includes subscription to *The American Political Science Review*.

(Membership in the Association for three years and subscription to the *Review* will be only \$1.00. Applicants should write directly to The American Political Science Association, 1726 Massachusetts Avenue, N.W., Washington 6, D. C. Payment may be made in UNESCO coupons or in any way convenient and acceptable under the exchange regulations of the country concerned. The privilege is extended to graduate students as well as to established political scientists.)

2) To enable libraries, university departments, and research institutes in Asia, which have heretofore been unable to do so, to subscribe to *The American Political Science Review* at greatly reduced rates.

(The cost of a three-year institutional subscription will be \$2.00, payable as above.)

3) To supplement travel expenses of Asian political scientists who are in the United States and who wish to attend meetings of The American Political Science Association. The next meeting will be held September 8-10, 1960, in the Statler Hilton Hotel, New York City.

(Applicants must be at least at the graduate student level and may come from any Asian country from Afghanistan eastward. Applications should be sent to The American Political Science Association, 1726 Massachusetts Avenue, N.W., Washington 6, D. C. In his request the applicant should give his regular academic position, the nature of his study or visit in the United States, and the sum necessary for travel to and from the meeting.)

# OUTSTANDING MCGRAW-HILL BOOKS

## EUROPEAN AND COMPARATIVE GOVERNMENT, *New Third Edition*

The post-Stalin era is thoroughly discussed, taking account of the Khrushchev regime and the decisions of the Twenty-first Party Congress.

## STATE AND LOCAL GOVERNMENTS: A Study in the Political Process

By CHARLES R. ADRIAN, Michigan State University. *McGraw-Hill Series in Political Science*. 536 pages, \$7.50.

A stimulating and distinguished textbook which describes state and local governments as a continuous process, rather than by institutions. 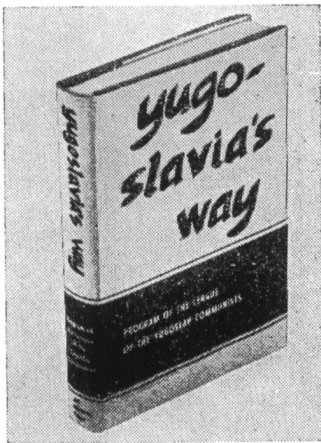

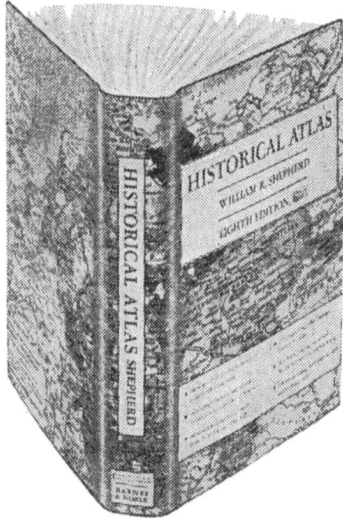
