

CURRENT RESEARCH INVENTORY

THE FOLLOWING SECTION CONTAINS A DESCRIPTIVE LISTING OF POSTDOCTORAL Latin American research in progress at institutions in the far western region of the United States, in Canada, and in the southern tier of Latin America. Included in this listing are projects still in progress but described in detail in earlier issues of LARR. These continuing projects are cross-referenced to the particular issue in which the description originally appeared.

The usual "Supplementary Listing"—a list of research projects received from geographical areas other than those specifically designated for coverage—has not been included in this issue's Research Inventory section. However, these supplementary projects will be published in the next issue of LARR, Volume III, number four, in lieu of the usual geographically designated projects. Publication of these accumulated supplementary projects will also mark the end of "Supplementary Listing" in the Research Inventory section. Beginning with Volume IV, number one, the Research Inventory will adhere strictly to the following geographical breakdown; number one will cover research projects in progress at institutions on the Eastern coastal region of the U.S. and those projects being carried out by U.S. government agencies and international organizations; number two will cover projects from institutions in the mid-western part of the U.S. and those from the northern tier of Latin America; number three will cover projects being carried out in the far-western region of the U.S., in Canada, and in the southern tier of Latin America (Argentina, Bolivia, Brazil, Chile, Ecuador, Paraguay, Peru and Uruguay).

We are happy to announce that in the next issue of LARR, Volume III, number four, the Research Inventory section will initiate coverage of research focused specifically on Spain and Portugal. Coverage of these topics will thereafter be regularly listed in this section and will follow the same area allocation as research carried out on Latin American topics.

ural increase taking place within the rural and urban areas of Costa Rica. Estimates of age-sex specific net migration between rural and urban areas are presented. A suitable method is developed to exploit available information from censuses and vital statistics and to correct for gross errors. Begun, 1968. EDC, 1968.

A Stable Population Model with a Constant Stream of Rural-Urban Migration.

A model is formulated for the study of population dynamics in a closed universe with two sectors—the rural and urban areas. The stable distributions of rural and urban populations are obtained when the age specific schedules of mortality, fertility, and migration remain constant over time. The results are illustrated with data from Costa Rica. Begun, 1968. EDC, 1968.

Reliability of Survey Data for Estimation of Fertility: San José, Costa Rica.

The sampling and non-sampling errors in the data from San José Fertility Survey are examined. The Brass Method is utilized to arrive at estimates of age-specific fertility which are relatively free of recall and reference period biases. Three areas are selected as case studies: mainly Santiago, Chile; Bogotá, Colombia; and São Paulo, Brazil. Each of these is considered in the context of overall urbanization forces, going further into critical issues involved in development in each of the metropolitan areas, methods of dealing with these problems presently applied, and suggestion of approaches that might be used. Investigation has a twofold purpose: 1) to study a traditional peasant-based regional exchange system in Oaxaca, Mexico, and the changes attributable to the impact of the modern industrializing economy of Mexico

since about 1940; and, 2) to evaluate the relevance of the data to economic theory and theories of development and sociocultural change. Investigation includes surveys of all market places and intensive studies of the different types. These studies examine the kinds of goods exchanged, routes and procedures by which goods are transferred, problems of capital, credit, price formation and profits, economic decision making and responses to changing opportunities and market situation, together with the sociocultural environments in which these occur. /NSF. Venezuelan Indian Project.

Project being carried out in conjunction with UCLA's Regional Latin American Center in Caracas. Project will be conducted in three stages: 1) Baseline studies will be made of contemporary indigenous societies of Venezuela, critically reviewing all existing ethnographic information from the Conquest to the present, and bringing this source material together in regional handbooks, the first of which has been published as *Indios de la Region Orinoco-Ventuari*. Each regional handbook will contain a resumé of research and the ethnographic information Dr. Wilbert has gathered during six years of intensive research in Venezuela. 2) Four diagnostic studies will be made of typical tribes of Venezuela, who will be chosen on the basis of the achieved developmental stages of their indigenous cul-

tures. These studies will result in several monographs. A Handbook of Venezuelan Indians will critically summarize the available material and present it in a practical form for scholars interested in the study of culture morphology. (Source: *Latin American Activities and Resources*, 1967.)

It examines the domestic and external policies of the Castro government in the development of the Cuban Revolution; the role played by the old Cuban Communists in the early stages of the Revolution; the Soviet view of Cuban developments and Moscow's direct and indirect influence on the Revolution; and the dynamic relationships between Havana and Moscow. A comparative analysis of the contents of the Cuban and Soviet press, together with information obtained in Havana, August 1967, is being used in this study. Begun, 1966. EDC, 1969. A related article, "Castro's Revolution, Communist Appeals and the Soviet Response," appears in the October, 1968 issue of *World Politics*.

883. Lois Elwyn Smith (University Extension Specialist)

The Christian Social Party of Venezuela. A study of COPEI, Venezuela's second ranking party and its role in Venezuelan politics. Will include ideology and program; bases of support; leadership; intraparty decision making and organization; financing; recruitment techniques and campaign strategy; relationships to other Venezuelan parties and to other Christian Democratic parties. Clase social de los líderes políticos.

Objetivos: Detectar el origen social de los líderes políticos que han operado en los últimos 50 años de la vida republicana. *Metodología:* Análisis del contenido de documentos y de testimonios de personas calificadas. *Estado de la investigación:* Diseño de los instrumentos de recolección de datos.

1082. Edmundo Fuenzalida (FLACSO). José Mejía Valera y Jesús Véliz Lizárraga (O)

Subdesarrollo y saber superior.

Bajo la dirección científica del profesor Fuenzalida y con del auspicio de la Facultad Latinoamericana de Ciencias Sociales (Flacso) se ha emprendido una investigación comparativa en Chile, Brasil y Perú sobre algunos problemas sociales relativos a saber superior, cuyo análisis estará a cargo del referido profesor. La recolección de datos en el Perú y su análisis se efectuará por los directores asociados del proyecto; profesores José Mejía Valera y Jesús Véliz Lizárraga, con el auspicio del Instituto de Investigaciones Sociológicas de la Universidad de San Marcos. El estudio se refiere a la estructura social del saber superior en la hipótesis que existe un grado diferencial en la institucionalización y en la internalización de dicha estructura, la cual sigue una pauta definida de interrelación con las subestructuras política y económica de la sociedad global. *Metodología:* Los datos se han recogido mediante una encuesta hecha en 1967 a una

muestra de profesores y alumnos universitarios que representan tres tipos de saber: tecnológico, científico y humanístico. *Estado de la investigación:* Procesamiento mecánico de los datos por el sistema IBM.

1083. Hernán Godoy y José Mejía Valera Los Intelectuales.

La investigación tiene por objeto mostrar: 1) Los factores determinantes de la orientación vocacional de los intelectuales; 2) la determinación de los grupos intelectuales, divididos en generaciones y sus diferentes perspectivas de la problemática nacional, especialmente referida al Desarrollo; 3) las motivaciones; 4) la existencia de grupos de acción intelectual constituidos sobre la base de atracciones y repulsiones; 5) la situación objetiva de clase a que pertenezcan los intelectuales peruanos; 6) definición del papel social del intelectual en el Perú. Se inició en 1965. En preparación.

1084. Aníbal Ismodes Cairo

Sexualidad y socialización.

Estudio de las relaciones visibles y de profundidad que se dan en el ejercicio de la prostitución en Lima. Correlación entre las siguientes variables; niveles de ingreso, continuidad en el ejercicio de la prostitución, características económicas antes de iniciarse el dicho ejercicio, planes para el futuro, placer e indiferencia sexuales durante la ocupación, opiniones y actitudes frente a los hombres, a las oportunidades para dedicarse a otros menesteres y al ahorro. Vinculación de la prostituta con el sistema de protección masculino, propio del ambiente. Los datos se recogieron en 1966 mediante una encuesta efectuada a 400 prostitutas y entrevistas grabadas a tratantes de blancas. Codificación y procesamiento mecánico de los datos mediante el sistema IBM.

Consumidores de la Prostitución.

Objetivos: Determinación de las formas de socialización de la conducta sexual en Lima, y estudio de las motivaciones para el consumo de la prostitución. Los datos se recogerán mediante la aplicación de un cuestionario a una muestra de consumidores de la prostitución. *Estado de la investigación:* Formulación de las hipótesis de trabajo, diseño de la muestra y de los instrumentos de recolección de datos.

1086. José Mejía Valera

Los Barrios marginales de Lima.

CURRENT RESEARCH INVENTORY

Las investigación pretende: 1) Mostrar la composición de las "barriadas" de Lima, desde el punto de vista del origen geográfico de sus habitantes. 2) Encontrar las modalidades de la desorganización social existente. 3) Establecer el grado de integración comunitaria en el barrio, el de la participación de los vecinos en las Asociaciones de Pobladores y el papel desempeñado por ésta. 4) Detectar el tipo de aspiraciones y su correlación con factores tales como el ingreso, la posición objetiva de clase, la autoidentificación clasista, la ocupación antes y después de haber migrado a Lima, 5) determinación de las condiciones de la vivienda, la densidad de su población, el habitamiento humano resultante, etc. Los datos se recolectaron en 1966 mediante una encuesta a una muestra de 1,162 habitantes de tres barrios marginales típicos de la ciudad de Lima, estratificados según su antigüedad y tamaño. Liderazgo Sindical.

Objetivos: mostrar la estructura social del sindicato en la industria manufacturera de Lima. Estudiar las características del liderazgo sindical en relación con la estructura social de sindicato. Establecer la actitud diferencial de los líderes sindicales de acuerdo con sus diferentes status sobre la base de la hipótesis de que dichas actitudes se modifican a medida que se asciende o desciende en los escalones de la organización. Detectar la estructura del poder sindical y las tendencias de su utilización. Establecer la correlación que existe entre el tipo de liderazgo (carismático y administrativo) y el grado de afianzamiento a la organización sindical a la que pertenezca. Describir las tendencias ideológicas de los líderes sindicales. *Metodología:* Los datos se recolectarán mediante entrevistas a base de un cuestionario aplicado a una muestra de líderes que se extraerá de otra de centros de trabajo estratificados.

1088. Jesús Véliz Lizárraga

Determinantes sociales del desarrollo regional.

Los objetivos—estudiar los determinantes sociales del desarrollo regional para cuyo efecto se intentará: 1. Detectar los grupos sociales

con status revelantes. 2. Establecer el grado del potencial humano para el desarrollo, a través de la relevancia del status regional. Describir las características de dicho potencial para el desarrollo en el supuesto que dicha relevancia pueda comprender: a) la migración como proceso para lograr el equilibrio de su configuración y b) el asentamiento en la comunidad y su conversión en potencial para el desarrollo. La recolección de los datos se efectuó en 1966 mediante un cuestionario aplicado a una muestra de 200 personas del área urbana y 200 del área rural, en las provincias de Huancayo, Jauja, Tarma, Yauli, Concepción, Satipo y Junín.


Opiniones y actitudes frente a la educación.

En la hipótesis de que en los países subdesarrollados existe una asincronía institucional, manifestada en el desajuste entre los sectores económico y educacional, que produce una tendencia a la formación de un sector terciario que no alcanzaría a ser absorbido por la estructura social, la investigación tiene por objeto someter a comprobación los siguientes supuestos: 1. La asincronía institucional educación-economía, 2. La importancia asignada a la educación como elemento para comprender los problemas provenientes del medio social externo, con distintos grados de apertura, 3. La imagen del sistema educacional como subsistema de estratificación dentro de la estratificación global. *Metodología:* para someter a comprobación la hipótesis de la asincronía institucional educación-economía se procederá a un análisis contextual comparativo entre países colocados en distintas posiciones dentro del continuo que va del polo "asincronía institucional completa" hasta el de "ajuste institucional perfecto," utilizando los datos de los censos y estadísticas sobre la materia. Los datos para la comprobación del resto de las hipótesis se recolectarán mediante la aplicación de un cuestionario a estudiantes secundarios, universitarios y padres de familia.
