The author contends that these qualifications are unnecessary, and that a careful application of the original theory obviates any need for modification. POLISH LOGIC 1920-1939

edited by STORRS McCALL. The years between the two wars saw a rich flowering of the work in formal logic in Poland. Yet the writings of Polish logicians of that time have largely remained inaccessible to English-speaking readers. This collection of translations includes papers by Lukasiewicz, Lesniewski, Ajdukiewicz, Chwistek, Jaskowski, Sobocinski, Wajsberg, Slupecki, and Jordan, all but two of which appear in English for the first time. An Introduction by Tadeusz Kotarbinski, former President of the Polish Academy of Sciences, completes the volume. \$15.00

THE CONCEPT OF CRITICISM

by F. E. SPARSHOTT. This philosophical essay seeks to develop a secure and neutral underpinning for conflicting theses about critical procedures and values. From little more than a bare notion of criticism as talk about how well things are done, a continuous argument yields solid inferences about such topics as the basis of critical evaluations, the justification of interpretations, and the status of criticism as a fine art. \$5.00

LEIBNIZ: LOGICAL PAPERS

A Selection, edited and translated by G. H. R. PARKINSON. This volume presents some of Leibniz's most important logical works, many of them translated into English for the first time. A long Introduction provides explanatory comment and gives an estimate of Leibniz as a logician. The book is to some extent complementary to the translator's *Logic and Reality in Leibniz's Metaphysics*, but does not presuppose an acquaintance with that work; it is designed, not only for those whose chief concern is with Leibniz, but also for those whose interests are primarily in the history of logic, in which Leibniz, the first symbolic logician, is a major figure. \$5.95
