
Notes on Contributors

Alexandre Bernier is currently completing the first year of his PhD at the Institute for East and Southeast European Studies (IOS) of the University of Copenhagen, working under the supervision of associate professor Morten Rasmussen. Bernier's primary research area is the history of European integration, with a particular focus on France and the formation of the European legal system between 1950 and 1981.

Anne Boerger-De Smedt is assistant professor at the University of Alberta. She is currently conducting research on the early history of the European law and on the history of the treaty negotiations, with a focus on the genesis of supranational institutions. On that specific subject, she has published 'Le Luxembourg et les institutions de la Communauté Européenne de Défense', in *Festschrift für Gilbert Tausch* (Les Éditions Saint-Paul, 2011); 'La Cour de Justice dans les négociations du Traité de Paris instituant la CECA', *Journal of European Integration History*, 18, 2 (2008), 7–33, and 'Derrière la valse des chiffres: Retour sur les origines de la composition de l'exécutif européen', *Journal of European Integration History*, 13, 1 (2007), 25–48.

Ulf Brunnbauer is managing director of the Institute for East and Southeast European Studies in Regensburg and Chair of East and Southeast European History at the University of Regensburg. His latest books include the edited volumes (with Claudia Kraft and Martin Schulze Wessel) *Sociology and Ethnography in East-Central and South-East Europe: Scientific Self-Description in State Socialist Countries* (Oldenbourg, 2011), and *Transnational Societies, Transterritorial Politics: Migrations in the (Post-)Yugoslav Region, 19th–21st Century* (Oldenbourg, 2009). He is currently working with Hannes Grandits on a book on ambiguous and recent nation building processes in south-eastern Europe. Another ongoing project concerns a history of labour emigration from the Balkans since the nineteenth century.

Bill Davies is assistant professor in Justice, Law and Society at American University in Washington DC. He is a historian of Europe's public legal order since the Second World War, with a particular focus on the national-European relationship. He has written *Resisting the ECJ: Germany's Confrontation with European Law 1949–1979* (New York: Cambridge University Press, 2012) and has published on the German reception

of the *Van Gend en Loos* and *Costa* decisions in the *Journal of European Integration History*, 14, 2 (2009).

Jean-Michel Guieu is lecturer in Contemporary History at the University of Paris 1 Panthéon-Sorbonne. His main research interests concern the study of pacifism and pro-European activism during the interwar period, the history of the League of Nations, and the historical roots of European law. He has published notably *Le rameau et le glaive: Les militants français pour la Société des Nations* (Presses de Sciences-Po, 2008).

Karin van Leeuwen is researcher at the Huygens Institute of Netherlands History and lecturer at the Radboud University Nijmegen. She is currently working on an edition of the documents of Dutch constitutional committees 1883–1983. In addition she is completing a PhD thesis on constitutional politics in the post-war Netherlands, 1945–1983. Publications include *De functie van staatscommissies voor grondwetsherziening: Regels en gebruiken in de commissies-Beel (1946) en -Van Schaik (1950–1954)* (Ministerie van Binnenlandse Zaken en Koninkrijksrelaties, 2008); and, with Carla Hoetink, ‘Dilemmas of Democracy: National and Supranational Concerns for a Democratic Europe in Early Postwar Netherlands’, in Joris Gijsenbergh et al., eds, *Creative Crises of Democracy* (Peter Lang, 2012).

Peter Lindseth is the author, most recently, of *Power and Legitimacy: Reconciling Europe and the Nation-State* (Oxford University Press, 2010), which examines European integration from the legal-historical perspective of the evolution of administrative governance on the national level over the course of the twentieth century. Among his other published works are ‘Democratic Legitimacy and the Administrative Character of Supranationalism: The Example of the European Community’, *Columbia Law Review*, 99 (1999), 628–738; ‘The Paradox of Parliamentary Supremacy: Delegation, Democracy, and Dictatorship in Germany and France, 1920s–1950s’, *Yale Law Journal*, 113 (2004), 1341–415; and ‘“Always Embedded” Administration?: The Historical Evolution of Administrative Justice as an Aspect of Modern Governance’, in Christian Joerges, Bo Stråth and Peter Wagner, eds, *The Economy as a Polity: The Political Constitution of Contemporary Capitalism* (University College of London Press, 2005). Professor Lindseth holds a BA and JD from Cornell University and a PhD from Columbia University, where he studied contemporary European history under the supervision of Robert Paxton.

Morten Rasmussen is associate professor at University of Copenhagen. He is currently working on a general history of European law from 1950 to 1970. He has published several articles on the history of European law, most recently, ‘Constructing and Deconstructing European “Constitutional” European Law: Some Reflections on How to Study the History of European Law’, in Henning Koch, Karsten Hagel-Sørensen, Ulrich Haltern and Joseph Weiler, eds, *Europe: The New Legal Realism* (DJØF Publishing, 2010), 639–60. His many publications on the history of European integration include Wolfram Kaiser, Brigitte Leucht and Morten Rasmussen, eds,

The History of the European Union: Origins of a Trans- and Supranational Polity 1950–72 (Routledge, 2009); and Ann-Christina Lauring Knudsen and Morten Rasmussen, eds, *The Road to a United Europe: Interpretations of the Process of European Integration* (Peter Lang, 2009).

Annemarie Sammartino is Associate Professor of History at Oberlin College. She is the author of *The Impossible Border: Germany and the East, 1914–1922* (Cornell University Press, 2010). She is currently working on a project on housing and urban crisis in East Berlin and New York City. She is also writing a book on migration and mobility in East Germany.

Laurent Warlouzet is a lecturer at the University of Artois (Arras, France) and at Sciences Po (Paris). A historian of European integration, he has a particular interest in institutional and economic issues. To date he has published four books including: his PhD: *Le Choix de la CEE par la France: Les débats économiques de Pierre Mendès-France à Charles de Gaulle (1955–1969)*; a working paper on the history of competition policy: *The Rise of European Competition Policy, 1950–1991: A Cross-Disciplinary Survey of a Contested Policy Sphere*; and several articles, including ‘De Gaulle as a Father of Europe: The Unpredictability of the FTA’s Failure and the EEC’s Success (1956–1958)’, *Contemporary European History*, 20, 4 (2011), 419–34.

Tobias Witschke is an official of the European Commission at the Directorate General for Regional Policy. In recent years he has been working for an EU Executive Agency and national and local authorities in EU programme management on budgetary law and procedures. He completed his PhD in 2003 at the European University Institute, Florence, under the supervision of Alan S. Milward, on the historical roots of European competition policy (ECSC) and the ‘reconcentration’ of the West German steel industry from 1950 to 1963. A revised edition of the dissertation has been published by Akademieverlag in Germany, *Gefahr für den Wettbewerb? Die Rekonzentration der Ruhrstahlindustrie und die Wettbewerbspolitik der EGKS* (Akademieverlag, 2009).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

- Contributors of accepted papers should send a final version via email. This should include
1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
 2. a 100-word summary of the article in English, French or German
 3. a short title for use as a running page-head
 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
 5. a short biographical note with a description of work in progress and previously published work (130 words max.)
