## THE CONTRIBUTORS

LOUIS MORTON has been appointed Professor of History at the University of Wisconsin. Until recently he was with the Office of the Chief of Military History, Department of the Army, where he directed the preparation of the 12-volume Pacific series in the official Army history of World War II, and wrote two of the volumes: *The Fall of the Philippines* (1953) and the forthcoming *Strategy and Command*.

ALEXANDER GERSCHENKRON, Professor of Economics at Harvard University, is the author of a number of studies in the field of European economic history and the economy of the USSR.

RANJIT SINGH BHAMBRI, Assistant Lecturer in Economics at the University College of North Staffordshire in Keele, Staffordshire, is engaged in research on international trade and balanced economic growth.

LEON D. EPSTEIN, Professor of Political Science at the University of Wisconsin, was in Britain in 1958-1959 studying the politics of foreign policy issues. He is the author of *Britain—Uneasy Ally* (1954) and *Politics in Wisconsin* (1958).

WENDELL BELL is Associate Professor of Sociology and Anthropology in the Department of Anthropology and Sociology and the Center of Latin American Studies at the University of California, Los Angeles. In 1955, he and Eshref Shevsky published *Social Area Analysis*; he is now preparing a monograph entitled *Jamaican Elites* and a review of the literature on public leadership in the United States.

MARTIN BLUMENSON, Historian in the Army's Office of the Chief of Military History, is the author of *Breakout and Pursuit*, a forthcoming volume in the European theater sub-series of *The U.S. Army in World War II*, and two essays of his appeared in *Command Decisions* (1959).

J. HERBERT FURTH is Associate Adviser, Division of International Finance, Board of Governors of the Federal Reserve System, and Adjunct Professor of Economics at the American University in Washington, D.C.

KENNETH E. BOULDING, Professor of Economics at the University of Michigan, is on leave as Professor and Head of the Department of Economics at the University College of the West Indies in Kingston, Jamaica. His most recent work is *The Principles of Economic Policy* (1958) and he is now preparing a book on "The Pure Theory of Conflict."

SIDNEY VERBA, Research Associate of the Center of International Studies, Princeton University, is working on a comparative study of attitudes toward government and citizenship in Italy, Germany, Mexico, and England.

JACQUES FREYMOND is Professor of the History of International Relations and Director of the Graduate Institute of International Studies in Geneva. Among his books are *Lénine et l'impérialisme* (1951), *De Roosevelt à Eisenhower, la politique étrangère américaine* (1953), and *Le conflit sarrois* (1959).

ERNST B. HAAS, Associate Professor of Political Science at the University of California, Berkeley, is engaged in studies on the integrative impact of international organizations. His recent publications include *Dynamics of International Relations* (with Allen S. Whiting, 1956), *The Uniting of Europe* (1958), and the forthcoming *Consensus Formation in the Council of Europe*.

GEORGE I. BLANKSTEN, Professor of Political Science at Northwestern University, is doing research on the relationship between levels of economic development in the underdeveloped areas and political patterns there. He is the author of *Ecuador: Constitutions and Caudillos* (1951) and *Péron's Argentina* (1953) and a contributor to *The Politics of the Developing Areas*, edited by Gabriel A. Almond and James S. Coleman, to be published this spring.
