The 1995 People's Republic of China's "Eugenics Law" was euphemistically renamed the "Maternal and Infant Health Law" but the policy remained the same. Prospective newlyweds diagnosed with hereditary, veneral, reproductive, or mental diseases are considered "unsuitable for reproduction" and encouraged to undergo sterilization, abortion or remain celibate. Exploring the contexts and history of eugenics in both Communist China and Taiwan, Dikötter provides a revealing look at how cultural currents have combined with medical discourse to promote this alarming program.


