

CENTRAL AMERICA AND THE CARIBBEAN

The U.S. State Department's "confidential" diplomatic post files from Central America and the Caribbean for the period from 1930 onward have never been published in any format until now. As the definitive source of American diplomatic reporting from the region, the records in these files are the very best primary sources for the study of the long-term development of U.S. policy toward Central America and the Caribbean and, even more significantly, for the study of the complex mix of social, economic, and political factors that has shaped the current conditions of the region. Therefore, the fact that over 200,000 pages of these records are being published for the first time is important news for professors and students with interests either in the history of U.S. foreign relations or in the history of Central America and the Caribbean. The diplomatic post files from Cuba, Honduras, El Salvador, and Nicaragua form the first installments in what will be an ongoing project to publish the records of key State Department posts throughout Latin America.

In most timely fashion University Publications of America now is offering to Latin American scholars the first published accounts of the Confidential U.S. Diplomatic Post Records for Cuba, Honduras, El Salvador, and Nicaragua. No research library can function properly without them, and Central Americanists in particular are going to wish that they could afford them for their own libraries. The files, numbering tens of thousands of pages, are available for the years 1930-1945 and are of the same high quality as UPA's earlier microfilm. Each nation's records contain a useful index and a helpful guide.

Research Guide to Central America and the Caribbean

Kenneth J. Grieb, editor

This work, initiated by the Caribé-Centro America Committee of the Conference on Latin American History, is the first comprehensive guide to archival resources concerning Central America and the Caribbean. Drawing on the collective expertise of the most prominent professionals in the field—including over seventy scholars from twenty different countries—it identifies the location, contents, and potential utility of all extant archival material regarding Central American and Caribbean countries, regions, and subjects.

The *Guide* contains two major types of articles. The archival descriptions are designed to provide basic information about available primary sources. They indicate the major archival depositories or research centers, the scope of their holdings, any unique aspects or restrictions, their hours of operation, and prevailing conditions. They should enable the researcher easily to identify the holdings of specific interest.

A second feature of the *Guide* is its topical essays. These articles indicate future directions for research, subjects yet to be studied, gaps in existing research, and particularly timely issues in the field. The inclusion of these essays allows the researcher to do more than locate relevant materials—it also helps facilitate the framing of research questions worth asking and the recognition of potentially fruitful topics for exploration.
