## THE CONTRIBUTORS

ALEXANDER DALLIN was Associate Director of the Research Program on the USSR and Director of Research of the War Documentation Project at Columbia University. Now a research fellow at the Russian Research Center, Harvard, he will teach at the Russian Institute at Columbia in 1956-1957 as a Visiting Assistant Professor.

RALPH S. MAVROGORDATO, a former Research Associate of the War Documentation Project at Columbia, is on the staff of the Office of Chief of Military History, Department of the Army, Washington, D.C.

FREDERICK C. BARGHOORN, Associate Professor of Political Science at Yale and Visiting Professor of International Relations at Columbia, is the author of *The Soviet Image of the United States* (1950) and *Soviet Russian Nationalism*, to appear in May 1956.

DAVID GRANICK is Associate Professor of Economics at Fisk University, Nashville. The author of *Management of the Industrial Firm in the USSR: A Study in Planning* (1954), he is preparing a book on economic development and technology, using Soviet metalworking as a case study.

R. A. C. PARKER, Lecturer in Modern History at the University of Manchester, is engaged in research in recent international history and English agrarian history in the eighteenth century.

KENNETH W. THOMPSON, Assistant Director of the Social Sciences division of the Rockefeller Foundation, edited, with Hans J. Morgenthau, *Principles and Problems of International Politics* (1950). He is also co-author, with Karl de Schweinitz, Jr., of *Man and Modern Society* (1953).

MYRON WEINER, Instructor in the Department of Politics and a staff member of the Center of International Studies at Princeton University, is writing a book entitled, *Parties and Politics in India: A Study of the Development of a Multi-party System*.

GORDON WRIGHT is Professor of History at the University of Oregon. Author of *The Reshaping of French Democracy* (1948) and co-author of *European Political Systems*, edited by Taylor Cole (1953), he is working on a book with the tentative title, *Peasant Politics in France*.

HOWARD S. ELLIS is Flood Professor of Economics at the University of California. Among his recent publications are *The Economics of Freedom: The Progress and Future of Aid to Europe* (1950) and, with N. S. Buchanan, *Approaches to Economic Development* (1955).

ROBERT E. WARD, Associate Professor of Political Science and a member of the staff of the Center for Japanese Studies at the University of Michigan, is a specialist in the political affairs of Eastern Asia.

HOWARD F. CLINE, Director of the Hispanic Foundation in the Library of Congress, is the author of *The United States and Mexico* (1953). He is currently engaged in a long-term study of developmental problems of particular Indian areas in Mexico.

ADOLF STURMTHAL is Philip Murray Professor of International Labor Studies at Roosevelt University, Chicago. His published works include *The Tragedy of European Labor, 1918-1939* (2nd ed., 1951) and *Unity and Diversity of European Labor: An Introduction to Contemporary Labor Movements* (1953).
