## Contributors

*Edward Beatty* is associate professor of history at the University of Notre Dame and fellow of the Kellogg Institute for International Studies. He has published studies of industrial policy in nineteenth-century Mexico, most recently *Institutions and Investment: The Political Basis of Industrialization in Mexico before 1911* (2001). His current project, partially funded by the National Science Foundation, examines patterns of technological change in Mexico between 1850 and 1920.

*Mansel G. Blackford* is professor of history at the Ohio State University, where he has taught courses in business history and the history of the American West since 1972. Many of his numerous works have dealt with the intersection of business and environmental history. His most recent book, the third edition of *The Rise of Modern Business: Great Britain, the United States, Germany, Japan, and China*, was published in 2008. He is currently preparing a book-length study tentatively titled, like his article in this issue, *Fishers, Fishing, and Overfishing: American Experiences in Global Perspective, 1976–2006*.

*Andrew Godley* is professor of business history at Henley Business School, University of Reading. He has published widely in the area of entrepreneurship, retailing and marketing history, including *Jewish Immigrant Entrepreneurship in London and New York, 1880–1914* (2001), a study of cultural assimilation among Jewish immigrants in the garment trade.

*Shane Hamilton* is assistant professor of history at the University of Georgia. In 2009, he received the Theodore Saloutos Memorial Award for Best Book in Agricultural History for *Trucking Country: The Road to America's Wal-Mart Economy*, published in 2008 by Princeton University Press. He is currently researching the political economy of U.S. supermarkets.

*Knut Sogner* is professor of economic history at the Norwegian School of Management BI and current head of the school's Business History Unit. He has written several books on Norwegian industrial history and family ownership. His articles have appeared in *Business History Review*, *Scandinavian Economic History*, *Scandinavian Journal of History*, and *History & Technology*.



*Uwe Spiekermann* is deputy director of the German Historical Institute, Washington, D.C., and Privatdozent at Göttingen University. His publications include *Basis der Konsumgesellschaft: Geschichte des modernen Kleinhandels in Deutschland, 1850–1914* (1999), and *Künstliche Kost: Die Genese der modernen Ernährung in der Wissens- und Konsumgesellschaft Deutschlands, 1880–2000* (forthcoming in 2010).

*Bridget Williams* is visiting research fellow at Henley Business School, University of Reading. She was the archivist at J. Sainsbury PLC for many years and was instrumental in establishing the Sainsbury Archive. She is author of *The Best Butter in the World: A History of Sainsbury's* (1994, reprinted in 2008).
