## ***Paradise Lost* and the Rhetoric of Literary Forms**

*Barbara Kiefer Lewalski*

This comprehensive study interprets *Paradise Lost* as a rhetoric of literary forms, by attending to the broad spectrum of literary genres, modes, and exemplary works Milton incorporates within that poem. It engages major issues in contemporary Milton criticism in terms supplied by Renaissance poetics and rhetorical theory. Barbara Lewalski argues that Milton uses the Renaissance genre system, and the cultural significances and moral values associated with the several kinds, as a vehicle of his artistic perception, as a means of accommodating his subject to his audience, and as a rhetorical strategy for educating that audience. \$32.50

## **The Georgic Revolution**

*Anthony Low*

Although Virgil was immensely influential on English poetry in the Renaissance and seventeenth century, inspiring dozens of epics and thousands of pastorals, the middle term of the Virgilian *rota*, georgic, has been neglected by those who have examined the literature of the period. In the first book on this important topic, Anthony Low discusses the courtly or aristocratic ideal as the great enemy of the georgic spirit, and shows that georgic powerfully invaded English poetry in the years from 1590 to 1700. During that time a revolution took place with religious, ideological, and technological as well as literary ramifications. Professor Low describes a significant current of social history, as revealed in poetry, and at the same time elucidates that poetry by placing it more precisely in a living context. \$32.50
